It was my good intention to stop off at Augusta on my way to northern Maine this summer, and give you the story verbally, but my plans were changed, and I happened to go through your city on a Sunday, and therefore lost out.

I was born in Houlton, Maine, and not being a woman can tell you the date. It was July 12, 1895. I attended Houlton Grammar School and graduated from Houlton High School in June 1913.


My next scholastic training was the the Mass. College of Pharmacy, which I attended in 1915, 1916, and 1917.

In June 1917 I joined the U.S. Army with the 77th Division, training at Fort Ethan Allen, Vt., and attached to the base hospital at Camp Upton, Long Island.

My other scholastic training consists of two years at Boston University and one year at the Mass. Institute of Technology.

After the war, I came to work for the B. F. Sturtevant Company, and have been employed by them since August 1920 in the capacity of Assistant Advertising Manager, Sales Engineer, Advertising Manager, and now in Charge of Merchandising. Each one of these positions lasted about three years, excepting the last one which has only been of about a year's duration.

I certainly appreciate your interest in my behalf, and thank you very kindly for getting in touch with me.


