I Cyrus Arnold of Bangor do solemnly swear, that I will truly and faithfully make a full and perfect enumeration and description of the persons resident within the first Ward of the City of Bangor, on the first day of March eighteen hundred and thirty-seven, and return the same to the Treasurer of Maine, agreeably to the directions of an Act, entitled "an Act providing for the disposition and repayment of the public money, apportioned to the State of Maine, on deposit, by the Government of the United States," according to the best of my ability, and that I will make said enumeration and description by actual inquiry at every dwelling-house in said Ward, or personal inquiry of the head of every family and not otherwise.
