

WARRANT

STATE OF MAINE.

To CHAS. A. CHASE, a constable in the town of Carmel in said County.

GREETING:

In the name of the State of Maine you are hereby required to notify and warn the inhabitants of the said town of Carmel, qualified by law to vote in said town affairs to assemble at the Town House in said town on Monday, the sixth day of March A. D., 1916, at 10 o'clock in the forenoon to act on the following articles, to wit:

- Article 1. To choose a moderator to preside at said meeting.
- Article 2. To choose a town clerk.
- Article 3. To see if the town will vote to accept the town report as printed.
- Article 4. To elect three or more selectmen, assessors and overseers of the poor.
- Article 5. To elect a town treasurer.
- Article 6. To elect one member of school committee.
- Article 7. To elect one or more town constables.
- Article 8. To elect a collector of taxes and fix his compensation for the same.
- Article 9. To elect one or more fire wardens, fix his compensation and raise money for same.
- Article 10. To elect all other town officers as required by law to be chosen at the annual town meeting.
- Article 11. To see what sum of money the town will raise for support of schools, and the poor, and the repairs of roads and bridges; for contingent expenses, for school books, for repairs on schoolhouses, for tuition expenses and for cutting bushes on highway.

Article 12. To see if the town will vote "yes" or "no" on the question of appropriation and raise money necessary to entitle the town to State aid as provided in Section 20 of Chapter 130 of the Public Laws of 1913.

Article 13. To see if the town will appropriate and raise the sum of \$533. for the section of State Aid road as outlined in the report of the State Highway Commission, in addition to the amount regularly raised for the care of ways, highways and bridges. The above amount being the maximum which the town is allowed to raise under the provision of Section 19 of Chapter 130 of the Public Laws of 1913.

Article 14. To see whether the town will vote to raise money and what sum, for the maintenance of State and State Aid highway during the ensuing year, within the limits of the town, under the provision of Sections 9 and 18 of Chapter 130 of the Public Laws of 1913.

Article 15. To see what sum of money the town will raise for repairs on cemetery fences in town.

Article 16. To see if the town will raise thirty dollars and donate the same to the C. K. Johnson Post for Memorial Services.

Article 17. To see if the town will vote to increase the salary of the Chairman of the Board of Selectmen, Assessors and Overseers of the Poor, and if so, what amount.

Article 18. To see if the town will vote to build a sidewalk on the south side of the Hampden Road, so called, from Town House to the dwelling house of E. F. Robinson, and raise money for the same.

Article 19. To see if the town will vote to authorize its Superintending School Committee to join with such other town or towns as it may deem expedient for the purpose of employing a Superintendent of Schools in accordance with the provisions of Section 40 to 45 inclusive of Chapter 15 of the Revised Statutes.

Article 20. To see what sum the town will vote to raise and appropriate for the salary of the Superintendent of Schools for the ensuing year.

Article 21. To see if town will vote to pay the Superintending School Committee for their services and what sum.

Article 22. To see if town will vote to elect a woman to serve on Superintending School Committee.

The Selectmen give notice that they will be in session for the purpose of revising and correcting the list of voters at the Town House in said town at nine-thirty o'clock in the forenoon of said meeting.
