# Warrant for Town Meeting.

To Chandler Garland, a constable of the town of Paris, in the County of Oxford,—Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of Paris, qualified by law to vote in town affairs, to meet at the town house in said town on Monday, the fifth day of March next, at ten o'clock in the forenoon, to act on the following articles, viz.:

ARTICLE 1. To choose a moderator to preside at said meeting.

ART. 2. To see if the town will accept the report of the selectmen and superintending school committee.

ART. 3. Report of the Crocker fund.

ART. 4. To choose all necessary town officers for the ensuing year.

ART. 5. To see if the town will grant and raise such sums of money as may be necessary for the maintenance and support of schools and the poor, and the repairs of roads and bridges, and to defray all other necessary town charges for the ensuing year.

ART. 6. To see if the town will vote to have their

highway and money tax put in one assessment.

ART. 7. To see what sum of money the town will raise toward paying the town debt and interest.

ART. 8. To see what sum of money the town will raise for repairs on school houses, for the ensuing year.

ART. 9. To see what sum of money the town will raise for the purchase of school books for the ensuing year.

ART. 10. To see if the town will vote to raise the sum of sixty dollars, to be expended by William K. Kimball

Post, G. A. R., in suitably observing Decoration Day.

ART. II. To see what some of money the town will raise to pay snow bills.

ART. 12. To see what the town will vote to pay per hour for labor on the highway.

ART. 13. To see if the town will vote to let the collecting of taxes to the lowest bidder.

ART. 14. To see if the town will allow a discount of ten per cent on all taxes paid on or before the first day of September.

ART. 15. To see if the town will vote to charge interest on all taxes unpaid after the first day of January, 1895.

# School Report.

## DISTRICT NO. 1.

FRANK R. WITHAM, Agent.

Whole number of scholars in district, 25. Summer term was taught by Helen A. Johnson. Whole number attending school, 5. Average attendance, 3. Length of school, 9 weeks. Wages of teacher, excluding board, \$3.00. Price of board per week, \$1.00.

Miss Johnson is a fine scholar and a thorough and successful teacher, and her work deserves the highest praise.

The fall term was begun by Miss Johnson, but because of ill-health, she canceled her engagement at the close of the first week. The work was soon resumed with Susie L. Rounds in charge. Whole number of scholars in attendance, 9. Average number, 6. Length of school, 9 weeks. Wages of teacher, excluding board, \$4.00. Price of board per week, \$2.50.

This was Miss Rounds' first school. She is a thorough scholar and a conscientious worker. Her methods of instruction are good. She gave universal satisfaction and the district was fortunate in securing her services.

The winter term, taught by the same teacher, is still in session.

#### DISTRICT NO. 2.

DR. ISAAC ROUNDS, Agent.

Whole number of scholars in district, 333. High School.—Summer term was taught by Henry Fletcher as principal and Winifred E. Roundy as assistant. Whole number of scholars in attendance during summer term, 52. Average number, 44. Length of school, 11 weeks, Wages of teachers, including board, \$80.00 per month and \$9.00 per week.

This school was everything that could be desired. The

teachers were earnest and faithful in their endeavors to make the school a success. Good discipline prevailed and the scholars made rapid progress and did thorough work.

The fall and winter terms have been under the instruction of the same teachers. Whole number of pupils in attendance during the fall term, 60. Average attendance, 55. Length of school, 11 weeks. Wages of teachers, including board, \$80.00 per month and \$9.00 per week.

Winter term is still in session with 62 pupils registered. Although the agents' reports for the last two years show a considerable decrease in the number of scholars in the district, yet there has been a steady increase in the number of pupils attending this school.

Grammar School.—Summer term taught by Hattie A. Hooper. Whole number of scholars in attendance, 28. Average number, 23. Wages of teacher, including board, \$9.00 per week.

Miss Hooper is well qualified as a teacher and her work in this school was of a high order. The term was satisfactory.

The fall and winter terms have been under the instruction of the same teacher. Whole number of pupils in attendance during fall term, 32. Average number, 28. Wages of teacher, including board, \$9.00.

No school in the district ought to be fostered with greater care by the patrons and citizens than this. New desks have been provided for the pupils. The room which the school now occupies is much too small to accommodate it.

Winter term is still in session.

Intermediate School.—Summer term taught by Lena A. Porter. Whole number of scholars in attendance, 47. Average number, 45. Wages of teacher, including board, \$10.00 per week.

Too much praise cannot be given this teacher for her work in this school. Mrs. Porter is a thorough disciplinarian, and her work is of the highest order.

Mrs Porter has continued to teach the same school during the fall and winter terms. Her work has been during these terms still more efficient and satisfactory, if possible, than ever before.

Whole number of scholars in attendance during the fall term, 44; average number, 40. Wages of teacher, including board, \$10.00 per week. The winter term is still in session.

Primary school. — Summer term taught by Emma Shurtleff. Whole number of scholars in attendance, 43. Wages of teacher, \$8.00 per week.

Miss Shurtleff is a thorough and successful teacher of much experience, and is especially well adapted to instruct and govern in this department of the school.

Fall and winter terms taught by the same teacher. Whole number of scholars in attendance during fall term, 41; average number, 36. Length of school, 11 weeks. Wages of teacher, \$8.00 per week. Winter term is still in session.

Pleasant Street School. — Summer term taught by Eva M. Richardson. Whole number of scholars in attendance, 26; average number, 21. Length of school, 11 weeks. Wages of teacher, including board, \$7.00 per week.

Miss Richardson is a teacher of rare ability, and the school was satisfactory in every way.

This teacher was persuaded to remain in charge of the school during the fall and winter terms. Whole number of scholars in attendance during fall term, 30; average number, 27. Wages of teacher, including board, \$7.50 per week. Length of school, 11 weeks. Number of visits by citizens, 31. Winter term is still in session.

This school, we think, receives the most attention from parents of any school in the district. The committee are pleased to note this interest on the part of patrons and friends and ascribe to it much of the interest which the pupils have in their lessons and their school.

Porter Street School. — Taught by Hattie M. Leach. Whole number of pupils in attendance during summer term, 33; average number, 30. Length of school, 11 weeks. Wages of teacher, including board, \$8.00. Whole number of pupils in attendance during fall term, 36; average number, 32. Length of school, 11 weeks. Wages of teacher, including board, \$8.00 per week.

Miss Leach is a teacher of long experience and her work in this school was satisfactory.

#### DISTRICT NO. 3.

# O. G. Curtis, Agent.

Number of scholars in the district, 29. Summer term taught by Dora E. Curtis. Whole number of scholars in attendance, 21; average number, 19. Length of school, 8 weeks. Wages of teacher, excluding board, \$3.50 per week. Price of board per week, \$1.50.

This school was visited but once. The school then appeared well and we have no doubt it was a success, as Miss Curtis seemed to have won the confidence of her scholars and was evidently working for their advancement and in the interests of the school.

The fall term also was taught by Miss Curtis, now Mrs. Tyler. Whole number of scholars in attendance, 26; average number, 19. Length of term, 8 weeks. Wages of teacher, excluding board, \$4.00 per week. Price of board, \$1.50 per week.

This term was a success and gave good satisfaction. This teacher is too well known in our schools to need further comment here.

The winter term taught by Mr. F. A. DeLano is still in session. Number of scholars registered, 24. Wages of teacher, \$24.00 per month.

#### DISTRICT NO 4.

# A. J. PENLEY, Agent.

Number of scholars in district, 18. Summer term taught by Lula E. Perry. Whole number of scholars in attendance, 12; average number, 10. Length of school, 6 weeks. Wages of teacher, excluding board, \$2.50. Price of board per week, \$1.40.

This school was visited but once; at that time the school appeared to be in a demoralized condition, there being no discipline in the school. Miss Perry seemed to try to make the school a success but she lacked method and firmness—hence the school was a failure.

The fall term was taught by Lena M. Tuell. Whole number of scholars in attendance, 12; average number, 10. Length of term, 10 weeks. Wages of teacher, excluding board, \$4.00 per week. Price of board, \$1.40 per week.

Miss Tuell had taught this school before with satisfactory results. Good order prevailed and the scholars were interested in their work.

Winter term is still in session under the instruction of Lena P. Hicks. This teacher's scholarship is unuasually good. Her experience is limited, but she possesses many of the qualities of a successful teacher.

#### DISTRICT NO. 5.

# C. S. HASKELL, Agent.

Whole number of scholars in district, 16. Summer term taught by Mrs. Mabelle Pike. Number of pupils in attendance 8. Average number 7. Wages of teacher, excluding board, \$3.00. Price of board per week ——. Length of term 8 weeks.

Mrs. Pike is a teacher of experience and comments are unnecessary. Good progress was made.

Fall term taught by Ida M. Abbott. Number of scholars attending school 10. Average attendance 8. Wages of teacher, excluding board, \$3.75. Price of board per week, \$2.49. Length of term, 10 1-2 weeks.

Miss Abbott sustained her former reputation here. Interest and advancement both good.

## DISTRICT NO. 6.

# C. H. LANE, Agent.

Whole number of scholars in district 61.

Summer term taught by Lula A. Buck. Number of scholars attending school 28. Average number 23 1-3. Length of term 9 weeks. Wages of teacher, excluding board, \$5.50. Price of board per week \$2.50.

Fall term taught by same teacher. Number of scholars in attendance 29. Average number 22. Length of term 9 weeks. Wages of teacher, excluding board, \$7.00. Board \$2.50.

Miss Buck's qualifications as a teacher are excellent. During the fall term several scholars were taken out to work in the corn shop, which of course was a detriment to the best interests of a school. Had the teacher the hearty cooperation of the parents the school might have been more profitable. Parents make a great mistake to take their scholars out of school for petty, sometimes real but more

often imaginary reasons. We think this district is particularly addicted to this evil, and hope in the future to see a more regular attendance. We do not hesitate to place Miss Buck in the front rank of good teachers, and to say that in our opinion her schools here were successful, so far as she could make them.

Winter term still in session.

## DISTRICT NO. 7.

CALEB DUDLEY, Agent.

Whole number of scholars in district, 10. Summer term taught by Ida M. Maxim. Whole number of scholars in attendance, 4. Average number, 3. Length of school, 9 weeks. Wages of teacher, excluding board, \$2.50 per week. Price of board per week, \$1.75.

This school was not visited by the committee, but we do not hesitate to say that the term was a success, as Mrs. Maxim is a teacher of much ability, and one who always works in the interest of her pupils.

Winter term was in charge of the same teacher. Whole number of scholars in attendance, 5. Average number, 4. Wages of teacher, including board, \$5.00 per week. Length of school, 12 weeks and 3 days.

Three of the scholars were the teacher's own children and all were taught with a mother's love and care.

# DISTRICT NO. 8.

S. M. KING, Agent.

Summer term taught by Mrs. H. M. Tucker. Length of term, 8 weeks. Number of scholars in attendance, 12. Average attendance 10. Wages of teacher, including board, \$5.00 per week. Mrs. Tucker's methods of instruction were good, and she worked hard to make the school a success. In spite of hindrances for which the teacher was in no way responsible, the school made good progress.

Winter term taught by Mrs. Dora E. Tyler. Length of term 9 weeks. Number of scholars in attendance 11. Average attendance 9. Wages of teacher, excluding board, \$5.00 per week. Price of board per week \$1.50. The same forces which hindered the school in the summer term, worked against its success during this term. Very good work however, was accomplished.

## DISTRICT NO. 9.

S. E. NEWELL, Agent.

Summer term of primary school school taught by Miss Lucy A. Andrews. Length of term, 10 weeks. Number of scholars in attendance, 41; average attendance, 35. Wages of teacher, excluding board, \$6.00 per week. Price of board per week, \$2.00.

Fall term of primary school was taught by the same teacher. Length of term, 10 weeks. Number of scholars in attendance, 38; average attendance, 33. Wages of teacher, excluding board, \$7.00 per week. Price of board, \$2.00 per week.

The winter term of the primary school, taught by same teacher, is still in session.

Miss Andrews is so well known as a successful teacher, that words of praise are not needed. It is hoped that the school may for some time be under her charge.

The pupils of the upper grade in this district have attended the academy during the year.

#### DISTRICT NO. 10.

RANSOM RIPLEY, Agent.

Summer term taught by Miss Lena M. Tuell. Length of term, 10 weeks. Number of scholars in attendance, 7; average attendance, 5. Wages of teacher, excluding board, \$4.00 per week; price of board per week, \$1.50.

Miss Tuell sustained her reputation as an excellent teacher.

Fall term taught by Miss Hattie D. Royal. Length of term 10 weeks. Number of scholars in attendance, 16; average attendance, 13. Wages of teacher, excluding board, \$5.00 per week. Price of board per week, \$1.45.

The winter term is still in session, taught by the same teacher.

Miss Royal is one of our best teachers. She has introduced some new methods which have been of help to the school.

#### DISTRICT NO. 11.

WM. STEARNS, Agent.

Whole number of scholars in district, 9. Summer term taught by Bessie C. Colby. Whole number attending

school, 3; average number, 3. Length of term, 5 weeks. Wages of teacher, excluding board, \$2.50. Price of board per week, \$1.50.

This was Miss Colby's first experience in teaching. In so small a school her talents as a teacher were not very well tested. With a wider field and a diligent application to the duties of a teacher, we think she may make a good teacher. The school was begun by her sister but having a more pecuniary offer she left and the term was finished by the above named.

Winter term taught by Helena O. Park. Whole number attending, 4; average number, 3. Length of term, 15 weeks. Wages of teacher, excluding board, \$4.00. Price of board per week, \$1.50.

With so few scholars it seems hardly profitable to have a school, but Miss Park showed herself a capable teacher and the scholars made good progress.

# DISTRICT NO. 12.

## G. OLEN CHASE, Agent.

Summer term taught by Ida M. Abbott. Number of pupils in attendance, 25; average attendance 21. Wages of teacher, excluding board, \$4.00. Price of board per week \$2.00. Length of term 9 weeks.

Miss Abbott is a teacher of considerable experience and her reputation was sustained here. The scholars were interested and made good advancement.

Fall term taught by Rose E. Starbird. Whole number of scholars attending, 30; average number 22. Length of term 10 weeks. Wages of teacher, excluding board, \$4.25. Price of board per week, \$2.00.

Miss Starbird commenced the school with a much larger number than was anticipated. Considerable fault was found from the fourth week, and finally a formal notice was given for the Superintending School Committee to visit the school. Accordingly at the end of the eighth week the school board met at the school house and listened to the complaints against the school and arguments in favor of continuing, or sustaining the teacher. Without giving the many statements made on both sides, the board came to this decision: That the teacher was in fault in many respects but hardly sufficient to stop the
