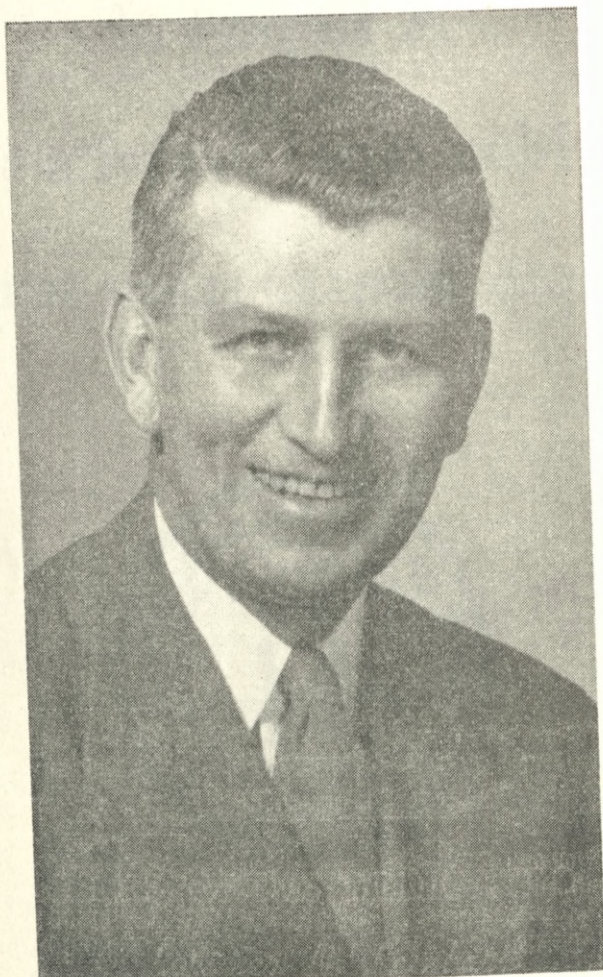

## IN MEMORIAM

CLINTON C. MEWER, Collector of Taxes for the years 1934-1935 and 1936, son of William J. and Hattie M. Mewer, and engaged in the insurance business under the name, Montrose E. Hill Co., Inc. passed away suddenly at his home on October 24, 1955 at the age of 60 years, leaving a wife, Violet and four children.

He was a past Commander of C. Fayette Staples Post American Legion, Past President of the York County Fish and Game Asso., a member of the Kiwanis Club, and always active in Civic and Fraternal affairs. He was held in high esteem by a wide circle of friends.

JOHN McKINNON, who served the Town as Health Officer for many years passed away after a long illness on May 22, 1955 at the age of 75, leaving a wife, Emily. He was engaged in the hotel business for several years after his retirement from the cloth manufacturing industry and was always interested in any movement for civic betterment.

Mr. McKinnon will be missed for his civic pride and energetic efforts toward the betterment of the Town.

BERTRAND M. WHITMAN, Collector of Taxes for eleven years, from 1902 to 1912 inclusive, passed away on September first, 1955 at the age of 79, leaving a wife and daughter Katherine.

He was born at South Paris, Maine, the son of Jared and Mary Whitman. His father was an Advent Minister and the family came here to reside when he was very young, and here he spent the greater part of his life. He was a member of the Advent Church and took a deep interest in its welfare.

HOWARD N. ROBINSON, aged 75 and unmarried, Chief of Police and Constable for the years 1915, 1916 and 1917, son of Nicholas Robinson, passed away suddenly at Memphis, Tennessee, while on a tour. He was retired after many years of service as a conductor with the Boston & Maine Railroad. He was a member of Orchard Lodge F. & A. M., and took a deep interest in the welfare of the Lodge, his untiring efforts being largely responsible for the recently dedicated Temple. He attended and aided the Methodist Church.

He will be missed not only by his local friends but by the many people he met during his services with the Railroad.

WILLIAM B. ROBINSON, who held the offices of Selectman, Assessor and Overseer of the Poor and who was the last engineer to operate the fire engine "The E. C. Staples", before the installation of motor equipment, died June 8, 1955 at the age of 77, leaving a wife and two daughters.

Mr. Robinson was engaged in the plumbing business here during the greater part of his lifetime. He was a member of Atlantic Lodge, I.O.O.F., and Orchard Lodge, F. & A. M.

# Manager's Report

## TO THE HONORABLE BOARD OF SELECTMEN AND THE CITIZENS OF OLD ORCHARD BEACH

May I take this opportunity to express my sincere appreciation to the citizens of Old Orchard Beach for the courtesy shown me, and compliment them for the fine manner the taxes for 1955 have been paid.

If we can claim any degree of success during this past year, the credit is not due me alone, but to your Selectmen, and to each and every department head. They have co-operated with me to the fullest extent.

My personnel staff in the Town Office have worked diligently during the year as we have slowly but constantly modernized your accounting system for the purpose of eliminating duplications and establishing accuracy. My personal compliments to them.

The 1955 taxes are approximately 88½% paid and, due to this new record and the practice of economy, the Town's finances are somewhat improved.

The net operating surplus for 1955 has been used to pay Town debt, namely \$8650.00 which was appropriated by borrowing at the Special Town Meeting held August 19th 1955. Those notes have been completely paid for and no further appropriation is necessary. The balances carried forward should be reflected in the future by lower appropriations to some extent.

To the best of my knowledge, all bills held over from 1954 have been paid. The only unpaid account for 1955 is \$1200.00, to Millett, Fish & Dresser, which is in the process of adjustment, and is believed to be excessive.

A complete analysis of balances is shown on page No. 11 & 12

My recommendations are few and brief.

My first and foremost recommendation is that provisions be made to amortize the \$75,000.00 outstanding temporary loan, by either issuing bonds or serial notes with definite maturity dates.

The Town's credit can easily be placed in jeopardy if proper attention is not given to these notes.

For reasons of economy, all obsolete equipment should be sold or traded on one new truck. Three trucks in addition to the Packer body truck and the Walters should be sufficient. Regular trucks can be hired for seasonal work, when needed.



Whatever street construction you provide for by appropriations should be of permanent construction with two inch mix in place surface from curb to curb, to reduce future street maintenance costs.

There is a great deal of work to be done with respect to the assessment and provisions should be made to accomplish this needed improvement.

Provisions should be made for continued re-decoration in the Town Hall. The first impression is usually a lasting one, therefore it should be a good one.

It is my sincere wish that you will give serious consideration to creating a Licensing Board by an act of the Legislature together with proper ordinances to establish a schedule of licensing fees.

Old Orchard Beach is a fine town and a prosperous one. The growth seems constant. New construction and improvements for 1955 will approximate the half million mark. Each and every improvement should be made with a thought of improving and beautifying the community.

Our greatest need, however, is a sincere belief in the future.

## CIVIL DEFENSE AND PUBLIC SAFETY

The Civil Defense organization has been handicapped during the last half of 1955 since H. Dayton Benway, our community director, changed his residence so that he might assume the responsibilities of Town Manager in Bridgton. Too few of our citizens realize the time and effort he expended in behalf of our town, solely because of his conviction that the ever-present threat of disaster demands an organization be ready, and competent, to counter any emergency that can bring hardship to our families or to those in other towns and cities. This motive led him in his endless and everlasting search for more of our citizens who were both willing and qualified to fill a niche in the team of about five hundred Old Orchard Beach people that should be in our Civil Defense and Public Safety organization.

Good fortune favored our town in the year 1955. Not one emergency arose that required the calling of Civil Defense, but there were two serious threats which prompted State and County Civil Defense authorities to warn us to be ready to call out our forces if the path of either storm turned in this direction. Our good fortune spared us the full force of these storms, but in spite of the damage so escaped there were some who complained because a number of summer visitors left.

Early in the past year a new Motorola radio transmitter-receiver was installed at Civil Defense headquarters, so we now have instantaneous contact with the fire and police radios. The Town received reimbursement for one-half of the cost of this instrument from the State allocation of available federal civil defense funds.

The regular monthly test of the civil defense system disclosed, last spring, an electrical fault which has been repaired. In December, Old Orchard Beach civil defense workers were photographed for individual identification cards as our part of a country-wide program. The less than 150 workers, who voluntarily gave about fifteen minutes time for this purpose, identify the core of our local organization and, at the same time, this positively shows that many groups and individuals failed to respond adequately.

If this town were completely blockaded by a snowstorm, or other disaster, that closed all roads and suspended the telephone system, an emergency channel for official messages would become a dire necessity. Such a condition soon will be surmountable with reasonable ease as Civil Defense has arranged to buy three short-wave radio transmitter-receivers adaptable to tuning to any of the three wave lengths reserved for emergency use by federal, state, and county agencies. The radios will be obtained by the Town at one-half cost through the state and federal assistance program, and then civil defense headquarters promptly can bring any local emergency to the attention of the proper authority. Subsequent direct contact with such authority, from spots even closer to the

center of trouble, will be possible as the other two sets will be sufficiently portable to be promptly put into operation at key points near the disaster. The necessary funds have been carried forward from the 1955 appropriation.

The support of numerous citizens and town officers has been graciously offered, and has been appreciated as evidence the public believes Civil Defense provides a worthwhile insurance protecting the Public Safety of our town.

### REPORT OF THE CIVIL SERVICE COMMISSION

The calls received by the Fire Department during the year 1955 were unusually low in number, even though 19 calls larger than in the year before. The record low number of calls in 1954, when combined with the previous two years, results in an average of about 125 fire department calls each year. The record for 1955 follows.

The majority of the calls received were handled by the firemen on full-time duty without the help of the call firemen. Forty-four alarms brought the call fire-men to the scene, but the remaining sixty-one were still alarms which did not require their assistance. This record shows the effectiveness of the present system of having three full-time firemen on duty at the fire station every hour of the day and night.

Two Lieutenants were appointed by Chief Mingo following an examination conducted by the Commission. The new appointments are Lieutenant John White, and Lieutenant Alphonse Desjardins. In addition, examinations for new call firemen were held on January 8, and November 26, 1955, and seven men have been appointed call firemen from those who qualified.

This Commission pointed out last year, in its first annual report, that the present work-week for full-time firemen averages 112 hours. It is likely, in the foreseeable future, the Town will be requested to adjust this long week by employing another full-time fireman, and possibly introducing a two-platoon system such as



adopted in other communities. This would reduce the average work-week to about 84 hours.

When closing our second year, we again wish to register our appreciation for the cooperation of the Selectmen, Town Manager, members of the fire department, and others.

To the Honorable Board of Selectmen and Citizens of Old Orchard Beach:

It is with extreme pleasure that I express my appreciation to the Honorable Board of Selectmen, to our Town Manager, to other Town Department officials and to the Citizens of Old Orchard Beach for the courtesy and cooperation extended me during 1955.

Early in the spring five members from the Chamber of Commerce met with five members appointed by the Board of Selectmen and proposed an agreed upon advertising and publicity program whereby the Chamber of Commerce would operate the Information Bureau and pay all expenses for its operation. In turn our town advertising appropriation would be spent for increased newspaper advertising. The program for 1955 was approved and the results were very gratifying.

All expenses for the Information Bureau including the director, and his secretary's salary, postage, telephone, stationery and printed matter were paid from the treasury of the Chamber of Commerce and totals over \$2,000.00.

Information and advice constitute only a small portion of the work at the office level. Bi-weekly inquiry lists were made available to resort owners at our town offices and mailed direct to Chamber of Commerce members.

Our program of newspaper advertising as set up by Mrs. James Cruikshank of the Frost Agency, Boston, in cooperation with our office returned 3,275 direct mail inquiries from people who were seeking aid in arranging accommodations for their vacation holiday. A town brochure, Chamber of Commerce Guide, and town lists of accommodations were sent in answer to each inquiry. My thanks to Mr. Cruikshank and his agency for their help.

Traffic records at the Bureau show that 1,235 parties for a total of 3,780 people were directed to various types of accommodations. Train and bus information was given to 5,390, route maps to 938, over 30,000 pieces of literature and 2,000 bumper signs were distributed at the Bureau. Many individuals came for personal services not recorded. Every effort was made towards satisfying their demands and retaining as much business as possible in Old Orchard Beach.

The Chamber of Commerce sponsored a booth set up of four Beach pictures at the Sportsmens Show in Boston, placed the same display for a period of a month in the window of the Montreal Star Travel Bureau in Canada and for a period of two weeks at the Maine Publicity Bureau in Kittery.

In cooperation with Town officials we entertained eight young ladies, members of the Hawaiian Air Cadets. They were welcomed to the Town by your Chairman of the Board of Selectmen, Dayton Benway, and were given the keys to our Town by Town Manager



Waldo Burgess. Following a shore dinner at the West Grand Avenue Lobster Pound, the young ladies were taken on a tour of the amusement area as the guests of the management.

Now just a word about the future. We need greater cooperation from those who benefit most. Many of our problems have a direct bearing upon you and your business to such an extent that, in my opinion, more people must take a greater interest in helping to solve the many problems that are before us.

1. The development of additional, easy-to-reach free parking facilities.
2. The elimination of the unsightly sidewalk merchandising on all Main streets. More unfavorable criticism of our Town is heard on this subject than on any other subject.
3. The need of directional signs on highways from Canada and States adjoining Maine. These signs to indicate the number of miles and point the direction to Old Orchard Beach.
4. The publication of rates, covering all types of accommodations, in promotional literature. The lack of rate sheets have prompted many to seek accommodations elsewhere.
5. Extensive study towards the use of outdoor film showing the many natural advantages of our beach. These films to be used in attracting conventions, outings, and additional visitors to our Town.

One notable achievement not easily recognized because of its intangible nature is the growing use of the facilities at the Information Bureau, by the many visitors to our town, community organizations, local and out-of-town business firms, and citizens of Old Orchard Beach.

This report would not be complete if I did not express my sincere appreciation to the following for their fine contributions toward the successful operation of the Information Bureau as intrusted to me for my supervision in 1955. To my secretary, Mrs. Elaine DeGrace; to Mrs. Ruth Neal of the Portland Press Herald; to Mr. Samuel Lublinsky and Mrs. Gertrude Wight of the Biddeford Daily Journal; to Mr. Paul Krause of the Springfield Republican, and to the officials of the Lewiston-Auburn, Me. Messenger, all for their help in preparing out-of-state and local news releases during the entire year, and to the Maine Publicity Bureau who has again awarded our activities with an award of merit.

In behalf of the Chamber of Commerce, Town officials, citizens and myself, I wish to express our sincere appreciation to for the free use of the space used at the 1955 Official Information Bureau headquarters.

## REPORT OF SUPERINTENDENT OF SCHOOLS

To the Superintending School Committee and Citizens of Old Orchard Beach:

The annual report of the Public Schools of Old Orchard Beach for the fiscal year ending December 31, 1955, reviews briefly education in the news today, progress at the local level, and concludes by summarizing teacher, pupil, and finance statistics.

### EDUCATION IN THE NEWS

The past year, a year of peace and prosperity, has been a good year for most Americans. But, it has not been too good a year for education. The birth rate has continued upward, critics have been vocal, local tax rates have been stretched in favor of rising school costs, and there were not enough of the right kind of teachers in the right kind of classrooms.

The two outstanding headlines had to do with a best-selling author who claimed to have discovered that Johnny could not read and the White House Conference on Education.

It took a good deal of time to explain that Johnny's problem was far more difficult than it seemed on the surface and that writer Flesch confused the issue by his many errors and false claims. Time Magazine on January 9 summed up the controversy as follows: "Flesch's accusations that the public school has abandoned phonics and that before it did, the United States had no reading problem, are as ill-founded as his claims that other countries use only phonics and have no reading difficulties". The review concluded that "there is no single way to teach reading, nor is there one panacea for the national reading problem".

There is hope for a better climate in education for the public is undeniably interested in the schools and their programs. Following the leadership of the National Citizens' Commission for the Public Schools, some 2600 communities held meetings on educational problems in connection with the state and national White House Conference.

Out of the many reports from the Conference, the question of federal aid gained prominence. The 1800 participants approved by a ratio of more than 2 to 1 the proposition that the Federal Government should increase its financial aid in public education. Those who were in favor of such increase approved again by an overwhelming majority the allocation of Federal funds for school building construction.

## THE JAMESON SCHOOL

1955

The new Jameson School opened on schedule September 1955 with an enrollment of 234 pupils. Teachers and pupils alike were proud of this community project. The effort of two and one-half years of work and planning of conscientious committee members seemed worth while on that opening day.

The building was dedicated on the afternoon of November 6, following the inspection of the school by hundreds of interested visitors. The program included talks by the co-chairmen of the Building Committee Henry Rudy and Howard Slaney; Mrs. Margaret H. Morton, Chairman of the Superintending School Committee; and Miss Helen Marshall, Principal of the Jameson School. Earle D. McKeen of the State Department of Education delivered the dedication address.

This new colorful unit of modern design embraces on one floor eight classrooms, a general purpose room, principal's office, nurse's clinic, teachers' room, kitchen, toilets, and storage room. Building features include: exit doors from each classroom on to the play area, individual toilets, sinks and drinking fountains in each of the four lower grade rooms, automatic heat and ventilation with individual room control, and a modern functional cafeteria and kitchen.

The building is planned for an expansion of at least four rooms when necessary.

### MAINTENANCE OF FACILITIES

Summer maintenance work as usual was carried on under the guidance of the regular building janitors. General repairs, thorough cleaning, painting, and grounds up-keep presents a busy work schedule.

Special projects involving extra labor included the outside painting of the Old High School and the shingling of one side of the roof of this building. All boilers and oil burners were thoroughly cleaned by men trained for this work.

All coal was removed from the Elementary and Federal Schools and accepted by the Town in exchange for labor used in cleaning the Federal School septic tank and installing a piped drainage system from this filter bed as well as from the filter bed of the new Jameson School. Aid was given, also, under the repairs account for surfacing the new elementary school grounds.

Considerable time and labor was involved in the storage and moving of equipment from the Federal School to the new Jameson School prior to the opening last fall.

New equipment placed in operation during the year included: two-way curtains, installed in the Elementary School, dictaphone machine for the office practice class in the high school along with an electric adding machine, new fluid duplicator for the Federal



School, one set of classroom tablet arm chairs for the high school, and outside flood lights for the new elementary school. The school lunch program purchased a new stainless steel stove for the kitchen in the high school and dishes and silverware for the Jameson School cafeteria.

### TEACHING PERSONNEL

With eight new classrooms to administer at the start of the fall term, it became necessary to change a number of teaching assignments. Miss Helen Marshall was appointed principal of the new Jameson School and Miss Catherine Neilon replaced Miss Marshall as principal of the Federal School. The eighth grade classes were then assigned to the Federal School and the high school absorbed the remaining annex rooms.

Two new teaching positions were required as it became necessary to add a new third grade and a new eighth grade over that of last year. The teaching roster now totals a new high of 46.

Once again a rather high turn-over was experienced during the summer when five teachers accepted teaching positions in communities with higher salary schedules. Miss Margaret Small and Miss Ruth Starrett accepted positions in the Portland School System while Mrs. Jane McDonald, Mrs. Barbara Ellis, and Mrs. Evelyn Smith resigned to accept positions in South Portland.

The sudden and untimely death of Ralph Hansen, high school science teacher for the past seven years, brought sorrow and shock to the entire school community on March 9. His loss has been keenly felt by his associates and the many pupils who attended his classes. Former Superintendent of Schools, Raymond Steward substituted in his position for the balance of the year.

The return of former teachers Mrs. Arline Fitzgerald, Mrs. Ella McKenna, and Mrs. Eleanor R. Smith was a welcomed event in this period of teacher shortages. They were assigned to vacancies in the Federal School. Mrs. Joyce Knight, a graduate of Franklin College in Indiana in the class of 1955, accepted a seventh grade position in the Federal School and Ralph Dodge of Kennebunk, who has taught in Maine and Florida for a number of years, replaced Mrs. Evelyn Smith who resigned shortly before the September opening of schools.

Miss Elizabeth Carr, a teacher with many years of experience who last taught in Freeport, accepted a fifth grade position in the Federal School and Mrs. Bernadette Egan of Old Orchard Beach, a former teacher in Aroostook schools was assigned to a third grade in the Jameson School.

Mr. John Shaw of Portland, a science teacher of thirty-two years' experience in Maine high schools, completed the high school faculty.



## EDUCATIONAL ACHIEVEMENT

**Elementary**—According to the annual summary sheets of achievement test in grades one through eight, Johnny can not only read in Old Orchard Beach, but he does work in the other subject fields equally as well. The curve of improvement in grade placement is definitely upward. For example, in 1953 the 8th grade battery median was one month above the average norm in grade placement but in 1955 the 8th grade was a year and one month above the grade placement norm. Since 1953 there has been an increase of 26 per cent in the number of individual subject matter classes whose grade placement is equal or above the normal pattern for grades one through eight.

**Secondary**—A new interest in reading during the past two years has been developed at the high school level. Stress has been placed upon quality and quantity of reading material. It is interesting to note that just as much encouragement and motivation is given to the reader without reading difficulties as to those with low reading interest or skill.

Book reports are presented orally or discussed in a written report prepared in the classroom. Books are selected from prepared book lists including the weekly best seller list from the New York Times. The school library shelves are exhausted at times and the search for books continues to the local town and state libraries.

Oral reading may be found once again in each of the regular English classes as well as in the remedial English group. Yes, the pupil at the secondary level is learning that reading for understanding is still one of the capital R's in Johnny's education.

**Higher Education**—It is interesting to find out what happens to graduates of Old Orchard Beach High School who attend schools of higher education. It is impossible to compile complete information on these pages but it is important to report that annually some 30 per cent of the high school graduates attend some one of our universities, colleges, junior colleges, or training schools. And what is still more important, their records are good and in many respects outstanding. For example, of the 22 graduates who elected to attend universities or colleges of arts and science during the past five years, 12 of their names appeared on the Dean's list of these institutions. A high percent of those attending the state teachers' colleges and junior colleges have done equally well.

## ATHLETIC ACHIEVEMENT

Students of local high school athletic teams through the years have learned to expect good team play. Year after year outstanding records have been made against schools much larger in school population than Old Orchard Beach. It is a fact that good coaches, good athletes, and good school spirit go hand and hand. Old Orchard Beach High School is blessed with these three attributes.

It is certainly worthy of note in these pages that during the past 1954-1955 school year alone, Old Orchard Beach High School won not only the Southern York County Championship in football, but it won the championship in basketball and baseball as well. And lastly, it should be recorded that seldom does a year go by without some Old Orchard Beach athlete gaining state-wide recognition.

### FINANCES

The fiscal year on December 31 closed with a balance in the school account to the amount of \$1,543.07. Once again aid from the Federal Government under Public Law 874 to the amount of \$2,198 was received.

Increased maintenance cost with the addition of a new school, teacher salary adjustments, improved health projects previously subsidized by a local service club, and the necessary appropriation for the athletic program will up-grade appropriation requests for the next fiscal year. Costs on a per pupil basis while moving steadily upward are still relatively lower than communities of comparable size and ability.

### CONCLUSION

In closing, I wish to extend to the Superintending School Committee and to the Old Orchard Beach Building Committee my personal thanks for their understanding and sympathy towards solving the current problems in education always from the viewpoint of the greatest good to the greatest number.

The examination was in the form of a limited general audit as recommended by the National Committee on Governmental Accounting and was conducted by representatives of the State Department of Audit. Audit analysis included all procedures which were considered necessary.

Insofar as could be ascertained within the scope of the examination, the financial transactions of the Town were appropriately handled, with such exceptions as may be noted in the accompanying comments.

The financial and statistical sections, incorporated in this report, present the result of the Town's financial operations for the period designated. Recommendations are also offered which are believed worthy of consideration.

**COMMENTS****Town of Old Orchard Beach**

January 1, 1955 to December 31, 1955

An audit of the financial records maintained by various officers of the Town of Old Orchard Beach has been completed for the municipal year ended December 31, 1955. The examination included a review of cash transactions as well as an analysis of available funds and expenditures, and the results are incorporated in the following text, exhibits and schedules pertaining to the fiscal affairs of the town.

The fiscal year's operations showed that expenditures exceeded available funds to the extent of \$1,078.06, per the following summary:

The Department of Attorney General has advised that overdrafts are not permitted by statute except in certain instances where emergencies arise in highway activities and then only to the extent of 15% of the highway appropriation.

The major overdrafts were reflected in the contingent, street lights, special sewers and abatement accounts. The contingent account overdraft of \$1,308.48 was due principally to a special interim audit by a firm of public accountants. The street light and special sewer accounts were overdrawn in the amounts of \$746.05 and \$1,291.30 respectively. This was occasioned, for the most part, by increased operational costs. An overdraft of \$3,281.78 in the abatement account was attributed principally to errors in the assessment of poll and personal property taxes representing primarily duplicate assessments and assessment of exempt properties.

Unexpended departmental balances for the year totaled \$16,927.92. Of this amount, \$8,650.00 was applied toward the payment of a note issued to finance expenditures for sewers and drains, sanitation, equipment and cleaning streets and beach. The use of current year surpluses for the reduction of debt was authorized by the townspeople at a special town meeting.

It was noted during audit processes that the following conditions warrant close attention of the municipal officers:



Authorized abatements of taxes, both current and prior, amounted to \$11,802.58 for the year. Accounts over three years old totaling \$8,520.80 were charged to the reserve for losses. Abatements affecting the current years commitment amounted to \$2,701.36 while those affecting prior years were \$580.42. By strengthening assessment procedures, such as addresses, elimination of exempt properties and duplications, etc., it is believed the necessity of large abatements can be eliminated as well as the overall improvement of other assessment methods.

In checking the 1955 tax commitment it was noted that the overlay was incorrectly stated by \$1,549.76. Such an error would be avoided by proving the tax detail in the commitment book to the warrant for collection before presenting the commitment to the tax collector.

Current application for abatements by the collector will assist the assessors in establishing future assessments.

The examination of prior years' taxes as to assessment and collection procedures revealed strengthening is needed. This is particularly true in regards to obtaining surety bonds for the town officials. Difficulties in this respect have been noted and they will not be lessened until steps have been taken to handle the town's fiscal affairs in an orderly manner. It is believed that a semi-annual audit in the coming year to determine the adequacy and accuracy of accounting procedures and whether or not the town's business is being handled in accordance with the audit recommendations would be of value.

It is suggested that disposition be made of the present tax anticipation notes of \$75,000.00 by the issuance of serial notes or bonds to be retired over a period of years. These notes have been renewed annually for the past several years with no provision for reduction. The cash position does not reflect these items as being in the category of temporary loans therefore an orderly reduction of this debt is advisable.

The examination of the Memorial Park Fund revealed that its financial operations were handled by the Park Commission. As this department is a municipal function it is recommended that the town treasurer, under the supervision of the municipal officers, should handle the financial transactions insofar as accounting for funds is concerned.

A record of municipal owned property and equipment is suggested in which to record costs and other pertinent information relative to municipal capital outlay.

## ASSETS

The cash balance of \$25,482.26 was reconciled with statements furnished by the depositories and count of cash on hand. The cash is segregated as follows:

Accounts receivable totaled \$2,753.98 at the year end which for the most part represented current reimbursable highway and charity expenditures.

The tax and tax lien accounts amounting to \$123,529.43 were reviewed and verifications undertaken on a test basis to determine their correctness. A total of 384 verifications were mailed covering items amounting to \$100,160.59. Of those mailed 40, representing \$5,844.78 were returned for reasons of faulty addresses and 81, representing \$23,351.72, were returned and verified the correctness of the accounts listed. Verifications totaling \$70,964.09 were not returned and it must be assumed they are correct for verifications were made on a negative basis. It is suggested, however, that the town manager continue to pursue all unpaid accounts by periodic verification process.

At the close of the prior year, unallocated tax collections had been set up by an audit firm as a suspense item amounting to \$4,416.57. This was necessary due to the lack of control which existed at that time for cash collections. It was possible, however, through verification processes to find errors amounting to \$3,299.30 which was charged to the suspense account thereby leaving an unallocated balance of \$1,117.27 at the year end. Every effort should be made to determine who may have paid these taxes but through negligence or error have not received proper credit.

The audit also revealed that certain prior years' uncollected real estate taxes had not been secured by tax liens or other processes. These taxes were checked against the tax collector's records and found listed as uncollected. They were further confirmed as such through information received from the York County Register of Deeds office. A summary of the unsecured real estate taxes as reflected on the records is as follows:

In this respect, it is suggested that the town officials, through legal counsel, consider the possibility of recovering these taxes through an action of debt process. This matter is deserving of prompt attention due to time limitations.

The reserve for losses of \$18,816.88 on taxes and tax liens, which was established in prior years, was reviewed. Net current year charges of \$7,433.11 to this reserve for taxes and tax liens and an adjustment of \$7,988.35 through the unappropriated surplus account resulted in a reserve balance of \$3,395.42. This balance is to provide for losses on personal and poll taxes from three to six years old and tax liens over six years old.

### LIABILITIES

Insofar as could be ascertained accounts payable at the close of the year amounted to \$1,513.89. This amount was determined by invoice and tax account examinations and represents, for the most part, an unpaid audit bill and overpaid tax accounts.

An amount of \$25.00 is on deposit in the First Portland National Bank for the payment of coupon No. 34 of a general municipal bond issue which matured in 1949 and which has not been presented for payment.

The general fund note liability at December 31, 1955 totaled \$77,500.00. This amount is comprised of a tax anticipation loan of \$75,000.00 due December 15, 1955 and a demand loan of \$2,500.00 due the Old Orchard Beach Library. The tax anticipation loan is a result of unpaid prior years' loans which have been renewed from year to year by the issuance of new notes.

The municipal debt limit for the town has been computed as \$487,036.88. The debt at the close of the current year amounted to \$354,038.89 which includes the \$75,000.00 listed as a tax anticipation loan.

### DEFERRED REVENUE

Deferred revenue amounting to \$4,334.77 represents 1956 excise taxes of \$3,928.23 and unallocated parking meter collections of \$406.54.

### RESERVES AND SURPLUS

The appropriation accounts reflect a net unexpended balance of \$30,925.93 (Exhibit D) at the year end and represented for the most part protection, highways, education and library account balances that are carried forward to the ensuing year in accordance with legal requirements and/or by authority of the municipal officials. It is suggested that appropriation account balances which are to be carried forward from year to year excepting those required to be carried forward by law, should receive the authorization of the voters.



The payroll reserve account of \$2,955.09 represents withholding taxes due the Director of Internal Revenue and group insurance premiums (Schedule A-10). The amount is on deposit in a special cash account.

The tax collector's suspense account of \$1,117.27 represents the remaining balance of the unallocated prior years' tax collections. Further verification of uncollected taxes by the municipal officials, as heretofore recommended, should reduce this account.

The unappropriated surplus amounted to \$2,769.25 at the beginning of the year. Adjustments affecting prior years' transactions, occasioned principally by an adjustment of the reserve for tax and tax lien losses and the payment of prior year's bills, resulted in an adjusted surplus of \$9,777.28. The reserve adjustment was for the most part due to abatements and adjustments of prior years' tax accounts. The current year excess of expenditures over available funds and an appropriation for sewer buckets reduced the surplus to \$6,199.22 at the year end (Exhibit C).

#### DEBT FUND

The debt fund, incorporated in the financial statement as a separate fund, reflects outstanding bonds of \$262,500.00 and notes of \$12,500.00 which are to be retired from future revenue. Following is a summary of the debt fund obligations:

#### AVAILABLE FUNDS AND EXPENDITURES

Available funds for expenditures amounted to \$672,818.44 for the year. Expenditures totaled \$673,896.50 with protection, health and sanitation, highways and bridges and education accounts reflecting the greater amounts. The invoice examination revealed that expenditures in the current year for bills applicable to the prior year totaled \$1,169.46. These items were charged to the unappropriated surplus account.

A method of effectively canceling paid invoices should be adopted. This may be accomplished either by perforation or a rubber stamp device.

### MEMORIAL PARK FUND

The Memorial Park Fund is a town function. Funds available for current year expenditures amounted to \$11,225.60 and consisted of a balance of \$62.72 from the previous year, parking revenue of \$11,154.05 and miscellaneous revenue of \$8.83. Expenditures totaled \$10,196.20 and were comprised principally of salaries, lights and repairs, materials and supplies and payment of debt and interest. The payment of debt and interest applies to a bond issue for First Street improvements which was issued in April, 1954. The annual retirement of bonds is \$1,500.00 with interest at 2%.

The cash balance of \$1,209.40 at the year end was reconciled with a statement furnished by the York National Bank, Old Orchard Beach, Maine.

The present system of collecting monies for parking is inadequate and a step should be taken to strengthen this phase of operation by providing prenumbered receipts or some other method of accountability for the funds collected. Furthermore, daily reports in triplicate should be prepared by the park attendant, showing the amount of money collected, and the inventory of unused tickets. The original report should be submitted currently to the town manager, the duplicate being made available to the Memorial Park Fund Committee. It is also recommended that the park attendant be bonded.

### GENERAL

The internal control and accounting procedures of the several departments of the town were reviewed. As a result, certain recommendations covering matters of minor concern were submitted directly to the departmental officials and town manager for their attention.

The system of accounting which was in use by the town at the time of audit was deemed inadequate and at the request of the town manager the State uniform system of accounting was installed.

Records maintained by the town clerk were examined and it was ascertained that transfers of \$2,500.00 from unappropriated surplus, excise taxes of \$20,346.08, parking meter revenue of \$6,980.28 and license fees of \$5,975.00 to various operating accounts were voted by the townspeople at the annual and special town meetings.

Licenses and permits issued by the town clerk and fees for same deposited with the town treasurer amounted to \$6,288.00 for the fiscal year. It is suggested that all licenses and permits be prenumbered by the printer for accountability purposes.



### SCOPE OF AUDIT

Count of cash was made and records checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as pertained to the handling of cash and other matters of financial concern. Receipts, vouchers and canceled checks were examined for a selected period. Demand deposits were reconciled with statements furnished by the depositories. Unused receipts were inventoried.

The 1955 tax commitment book was checked and proved to the warrant for collection. Outstanding taxes were listed and verification, on a test basis, was utilized to determine their correctness.

Tax liens on file were checked to the records and external verification, on a test basis, was made.

Tax abatements were examined and reserves for losses on taxes and tax liens were reviewed and adjusted.

Excise tax collections were examined, on a selected basis, with the copies of receipts retained by the collector. Computations were made on a test basis.

Unexpended balances and overdrafts of the departmental accounts were reviewed with the town manager and/or the superintendent of schools.

The Memorial Park Fund operations and the transactions relating to construction of the new elementary school building were checked.

Various laws relating to the fiscal operations of the municipality were reviewed to determine that related financial transactions had been properly administered.

Included in this report are exhibits and schedules pertaining to the financial status of the town. Audit procedures were followed to the extent deemed advisable to develop these statements.

It is believed that the accompanying statement of financial condition and supporting information fairly present the financial position of the town at December 31, 1955, and the result of its operations for the year then ended.

## FREE PUBLIC LIBRARY

January 1, 1955 to December 31, 1955

\*\*\*\*

Upon request of the Library Trustees an audit was made of the financial transactions of the Free Public Library for the period January 1, 1955 to December 31, 1955.

The examination revealed that funds available for current year operations amounted to \$3,946.99. This amount consisted of a balance of \$199.67 from the preceding year, a town appropriation of \$3,000.00, a transfer of \$400.00 from the building fund, and other miscellaneous revenue. Expenditures totaled \$3,540.83 and represented principally salaries, purchase of books, magazines and supplies. The cash balance of \$406.16 at the year end was reconciled with a statement furnished by the York National Bank, Old Orchard Beach, Maine.

It was noted that payments are made without written approval of the board of trustees. In this respect, it is recommended that all expenditures be approved by at least a majority of the board of trustees before payment.

The Free Public Library investments totaled \$7,198.03 at the close of the year and are represented as follows:

It was noted that the U. S. Savings Bonds, dated March, 1943, have matured. It is suggested that these bonds be liquidated and reinvested. Interest received on time deposits and investments totaled \$110.03 for the year.

**WARRANT FOR ANNUAL TOWN MEETING**

To J. Leo Farrington, a constable of the Town of Old Orchard Beach,  
in the County of York and the State of Maine:  
**GREETINGS:**

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach, qualified to vote in town affairs, to assemble at the High School in said Old Orchard Beach on Monday, the Fifth day of March, A. D. 1956 at 9 o'clock in the forenoon, then and there to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

Art. 2. To hear and act on the report of the Selectmen and other town officials.

Art. 3. To choose all necessary town officers for the ensuing year.

Art. 4. To see if the Town will vote to raise and appropriate the sum of \$50.00 to be used for decorating graves on Memorial Day, under the direction of the American Legion, said sum to be taken from Licenses Income.

**Budget Committee so recommends.**

Art. 5. To see if the Town will vote to raise and appropriate the sum of \$200.00 for defraying the expenses of the Memorial Day parade and exercises, under the direction of the Memorial Committee, said sum to be taken from License Income.

**Budget Committee so recommends.**

Art. 6. To see what sum of money the Town will vote to raise and appropriate to defray the expense of Town Administration for the year 1956.

**The Budget committee recommends that \$16,750. be appropriated, that the salary of each Selectman be \$75.00, the salary of each assessor be \$75.00 and the salary of the Town Clerk be increased from \$1,500. to \$2,000. annually and paid from the appropriation for administration.**

Art. 7. To see what sum the Town will vote to raise and appropriate for the hire of clerical assistance for the assessors.

**Budget Committee recommends \$1,000.00.**

Art. 8. To see what sum of money the Town will vote to raise and appropriate for the hire of an experienced Assistant Assessor from April 1st until date of commitment.

**Budget Committee recommends \$1,500.00**



Art. 9. To see what sum of money the Town will vote to raise and appropriate for planting flowers and trees, erection of signs and benches, and their care, in various sections of Town, outside Memorial Park. Said sum to be expended with the approval of the Town Manager.

**Budget Committee recommends \$750.00 from Parking Lot Income.**

Art. 10. To see what sum of money the Town will vote to raise and appropriate for the care and removal of shade trees.

**Budget Committee recommends \$250.00 from Parking Lot Income.**

Art. 11. To see what sum of money the Town will vote to raise and appropriate for heating, lighting and general maintenance of the Town Hall.

**Budget Committee recommends \$5,475.00 from License Income.**

Art. 12. To see what sum of money the Town will vote to raise and appropriate for the repair of the Hallway, Police Station and Court Room at the Town Hall.

**Budget Committee recommends \$2,000.00**

Art. 13. To see what sum of money the Town will vote to raise and appropriate for Civil Defense and Public Safety.

**Budget Committee recommends \$1,000.00 and that unexpended balance be carried forward as a credit balance in the following year.**

Art. 14. To see if the Town will vote to raise and appropriate the sum of \$176,289.00, for schools to be divided as follows: Common schools, \$95,098.00; High School, \$40,895.00; Textbooks, \$4,000.00; Repairs, \$4,500.00; Supplies, \$4,000.00; Maintenance (Utilities, Insurance, Equipment), \$7,676.00; Industrial Arts, \$3,570.00; Home Economics, \$3,180.00; Physical Education, \$7,665.00; Medical-Health (School Physician, Dental Hygienist, Dentist, Optometrist), \$1,635.00; School Committee, \$200.00; Supervision, \$2,870.00; Capital Improvement, (Landscaping), \$1,000.00.

**Budget Committee recommends \$176,289.00**

Art. 15. To see if the Town will vote to raise and appropriate the sum of \$7,500.00 for a chain-link fence to surround the High School athletic field.

**Budget Committee makes no recommendation.**

Art. 16. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for the purchase and erection of portable steel bleachers or grandstands for the High School athletic field.

**Budget Committee makes no recommendation.**

Art. 17. To see if the Town will vote to authorize the Superintending School Committee to appoint a school physician.



Art. 18. To see what sum of money the Town will vote to raise and appropriate to install a sprinkler system in the Elementary School on School Street and to make suitable water installation for servicing system.

**Budget Committee recommends \$3,938.00.**

Art. 19. To see what sum of money the Town will vote to raise and appropriate for the Public Works' Department, including highways and bridges, snow removal, surfacing, sewers and drains, sanitation, maintenance of Town dump, maintenance of Town Team, and maintenance of sidewalks.

**Budget Committee recommends, highways and bridges \$16,000.00 (\$5,000.00 from Parking meter income, \$11,000.00 from excise tax.) Snow removal \$8,500.00 all from excise tax. Sidewalks \$2,500.00 (\$1,000.00 from excise tax.) Surfacing \$10,000.00; Sewers and Drains \$7,500.00; Sanitation \$22,500.00; Maintenance of Town Dump \$7,500.00; Maintenance of Town Team \$3,650.00; a Total of \$52,650.00 from taxation, \$5,000.00 from parking meter income and \$20,500.00 from excise tax.**

Art. 20. To see what sum of money the Town will vote to raise and appropriate for the purchase of a rubber tired low bed wagon for the Town Team, at a cost not to exceed \$450.00.

**Budget Committee recommends \$450.00.**

Art. 21. To see what sum of money the Town will vote to raise and appropriate for the purpose of purchasing one truck for the Public Works' Department, and to see if the Town will authorize the Selectmen to dispose of one 1947 Ford dump truck, and one 1948 Dodge dump truck and apply the proceeds to the purchase price.

**Budget Committee recommends \$4,000.00, and that the authority be granted.**

Art. 22. To see what sum of money the Town will vote to raise and appropriate for the purchase of one pick-up truck for the Public Works' Department, and to authorize the Selectmen to dispose of the 1951 Chevrolet pick-up and apply the proceeds to the purchase price.

**Budget Committee recommends \$1,200.00 and the authority be granted.**

Art. 23. To see what sum of money the Town will vote to raise and appropriate for the purpose of paying valid outstanding indebtedness of the Town.

**Budget Committee recommends \$1,500.00 from the Parking Lot income, and \$28,000.00 from taxation.**

Art. 24. To see what sum of money the Town will vote to raise and appropriate to pay interest on notes and bonds for the year 1956.

**Budget Committee recommends \$8,400.00.**

Art. 25. To see if the Town will vote to authorize the Selectmen and Treasurer to borrow a sum not exceeding \$75,000.00, for the purpose of refunding valid outstanding indebtedness of the Town, and to issue and negotiate, bonds or notes, not exceeding \$75,000.00, of the Town for said purpose and upon such terms and conditions as may be determined by said Selectmen and Town Treasurer.

Art. 26 .To see what sum of money the Town will vote to raise and appropriate for street lights.

Budget Committee recommends \$16,755.00, and that the following improvements be made; the cost for 1956 is included:

1. Change the existing 18 - 10,000 lumen lights on Old Orchard Street to 20,000 lumen Mercury units at a yearly increase of \$486.00.
2. Change the existing 52 - 4,000 lumen lights on East and West Grand Avenues, etc., to 6,000 lumen units at a yearly increase of \$520.00.
3. Change the existing 1 - 10,000 lumen sodium light on East Grand Avenue to a 20,000 lumen Mercury unit at a yearly increase of \$27.00.
4. Change the existing 1 - 15,000 lumen Mercury light on Saco Avenue to a 20,000 lumen Mercury unit at a yearly increase of \$6.00

Art. 27. To see what sum of money the Town will vote to raise and appropriate for life-guard service for the year 1956.

Budget Committee recommends \$6,995.00.

Art. 28. To see what sum of money the Town will vote to raise and appropriate to clean the streets and the beach.

Budget Committee recommends \$10,200.00.

Art. 29 To see what sum of money the Town will vote to raise and appropriate for State Aid Road Construcion (in addition to the amounts regularly raised for the care of way, highways and bridges), under the provisions of Section 44, 49, or 50, Chap. 23 R. S. 1954 amended.

Budget Committee recommends \$3,464.00, and that an amount not to exceed \$4,000.00, of the Joint State Aid Fund, be expended on East Grand Avenue, balance on Temple Ave.

Art. 30.To see what sum of money the Town will vote to raise and appropriate for Workmen's Compensation Insurance, and Liability Insurance on Town Hall and Comfort Station.

Budget Committee recommends \$2,200.00 for Workmen's Compensation, and \$150.00 for Liability Insurance, and that the Town insure all property on a Five Year Plan, putting into effect a Master Policy through one agency, with other agencies re-insuring the same.



Art. 31. To see if the Town will vote to inform the State and Federal Officials involved that it is the desire of the Inhabitants of the Town that the proposed new entrance to Old Orchard Beach be constructed on the site as promised in 1941, 1950 and 1953; namely, via Ocean Park Road and Saco Avenue.

Art. 32. To see if the Town will vote to instruct the Selectmen to have removed the trees (and replanted) from the southerly side of Staples Street, and to extend the southerly side of Staples Street to its full width, and to have constructed on said southerly side of Staples Street a concrete sidewalk to extend from Saco Avenue to First Street, said sidewalk to be six feet wide, and to appropriate therefor the sum of six thousand dollars.

**Budget Committee recommends that \$6,000.00 be appropriated to carry out the provisions of Article 32.**

Art. 33. To see what sum of money the Town will vote to raise and appropriate to install a suitable driveway culvert on West Grand Avenue to the entrance of the Daniel Fenton property.

Art. 34. To see if the Town will vote to change the name of Brisson Street to "Scanlon" Street.

Art. 35. To see if the Town will vote to authorize the Park Commission to operate as a public parking area for hire during the Summer season of 1956, that portion of Memorial Field, so-called, as has been used for a like purpose for the past several seasons, and to authorize use of current income from said operation to pay all expenses of operation and maintenance, interest which becomes due during the current year on First Street Improvement Bonds, to retire any of said First Street Improvement Bonds callable during the current year and to pay to the Town Treasurer such sums as may be appropriated from Parking Lot Income.

Art. 36. To see if the Town will vote to authorize the Park Commission to operate the public parking area for hire and affiliated projects during the season of 1956, and to pay over to the Town Treasurer daily all receipts. Disbursements to be made by the Treasurer upon approved vouchers signed by a majority of the Park Commission and approved by the Board of Selectmen as prescribed in the Revised Statutes of 1954, as amended, and to authorize the Park Commission to pay to the Town Treasurer any and all parking lot funds now in their possession.

Art. 37. To see if the Town will vote to authorize the Selectmen to operate the Public Parking area, and to use 1956 income from said Parking Lot to defray the operational expenses, and to make payments of interest and First Street bond due in the fiscal year of 1956.



Art. 38. To see if the Inhabitants of the Town of Old Orchard Beach will enact an ordinance under authority provided in Chapter 91, Section 86, Roman Numerals VII and XV as well as Sections 88-92 of said Chapter of the Revised Statutes of the State of Maine, dated 1954 for the regulating and controlling of the business of hawking and peddling goods, wares and merchandise for sale and on display outside of as well as in front of the vendor's usual place of business, and to give the power and authority to the municipal officers of the Town of Old Orchard Beach to issue municipal licenses and the imposing of license fees and restrictions for the regulating and controlling of businesses as aforesaid.

Milliken Road westerly from Seaview Avenue—a distance of 100 feet.

Casco Avenue easterly from 9th Street—a distance of 50 feet.

Casco Avenue easterly from Sea Side Avenue—a distance of 200 feet.

Reggio Avenue extension from present terminus— a distance of 300 feet.

**Budget Committee recommends the acceptance of all, except Bluff Avenue, and North Street.**

Reggio Avenue extension—a distance of 300 feet.

Art. 44. To see what sum of money the Town will vote to raise and appropriate for the installation of one hydrant on the Cascade Road, one on Sunset Avenue, and one on Melvin Ave. Each to be installed to meet insurance requirements.

**Budget Committee recommends \$90.00, and that the installation be made.**

Art. 45. To see what sum of money the Town will vote to raise and appropriate to maintain the Fire Department for the year 1956.

**Budget Committee recommends \$24,000.00.**

Art. 46. To see if the Town will vote to establish a capital reserve fund for the purchase of fire equipment, as provided in Chapter 91, section 166, R. S. 1954.

Art. 47. To see if the Town will vote to authorize the Selectmen and Town Treasurer to deposit an amount qual to the un-expended balance in the Fire Department account at the close of the 1956 fiscal year, in the Town of Old Orchard Beach Capital Reserve Fund, known as the Fire Department Major Equipment Account.



Art. 48. To see what sum of money the Town will vote to raise and appropriate to maintain the Police Department for the year 1956, and the enforcement of parking meter regulations.

**Budget Committee recommends \$26,000.00 for Police and \$1000.00 for enforcement of parking meter regulations. (The \$1,000.00 mentioned above, appropriated from parking meter income.**

**Budget Committee recommends \$450.00 for painting curbs; \$500.00 for traffic signs; \$700.00 for new Police Car.**

Art. 52. To see if the Inhabitants of the Town of Old Orchard Beach will vote to give a quit-claim deed to John S. Gray and to Elmer Libby of that part of Old Saco Avenue, so-called, which crossed their land and has since been abandoned; and to accept as consideration for the quit-claim deeds, a conveyance from John S. Gray and Elmer Libby to the Town of Old Orchard Beach of that portion of their land necessary to extend Wildwood Lane through to the now existing location of Saco Avenue.

Art. 53. To see if the Inhabitants of the Town of Old Orchard Beach will vote to discontinue so much of the easterly end of Old Orchard Street to vehicular traffic as is hereinafter set forth, and authorize the municipal officers of the Town of Old Orchard Beach to estimate the damages suffered by any person thereby:—

Commencing at a point where the Westerly side of the bulkhead abutting the Beach intersects the Easterly side of the sidewalk curbing situated on the Westerly side of Old Orchard Street; thence along said Old Orchard Street in a Northwest-erly direction and adjacent to aforesaid sidewalk curbing Twenty (20) feet to a point; thence at a right angle to the last-described line and in a Northeasterly direction to a point and the Westerly side of the sidewalk curbing located on the East-erly side of said Old Orchard Street; thence along said sidewalk curbing located on the Easterly side of said Old Orchard Street

adjacent thereto and in a Southeasterly direction to a point where the Northerly side of the bulkhead abutting the Beach intersects the Westerly side of the last-mentioned sidewalk curbing; thence along said bulkhead abutting the Beach and adjacent thereto, to the point of beginning.

Art. 54. To see what sum of money the Town will vote to raise and appropriate for improvements of Central Park, so-called, under the supervision of the Park Commission.

**Budget Committee recommends \$300.00.**

Art. 55. To see whether or not the Town will vote to raise and appropriate the sum of Six Hundred Dollars (\$600.00) to be paid to the State of Maine Publicity Bureau to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine, in accordance with the provisions of Chapter 91, Section 108 of the Revised Statutes of 1954. (Note: The amount suggested is in accordance with an equalized schedule for all cities and towns based upon their respective assessed valuations.

**Budget Committee voted not to recommend.**

Art. 56. To see what sum of money the Town will vote to raise and appropriate for advertising purposes for the year 1956.

**Budget Committee recommends an amount equal to 2 mills on the 1955 valuation.**

Art. 57. To see what sum of money the Town will vote to raise and appropriate for Contingent Expense.

**Budget Committee recommends \$5,225.00.**

Art. 58. To see what sum of money the Town will vote to raise and appropriate to pay the salary of the License Inspector, namely, Mr. Fred I. Luce.

**Budget Committee recommends \$1,000.000.**

Art. 59. To see what sum of money the Town will vote to raise and appropriate for the Salary and Travel Expense of the Health Officer.

**Budget Committee recommends \$500.00 for salary and \$100.00 for travel.**

Article 60. To see what sum of money the Town will vote to raise and appropriate for Public Health Nursing Service and Immunization.

**Budget Committee recommends \$4,776.00 for Health Nursing Service and \$300.00 for Immunization.**

Art. 61. To see what sum of money the Town will vote to raise and appropriate for Public Assistance and for Aid to Dependent Children.

**Budget Committee recommends \$10,000.00 for Public Assistance, and \$1,400.00 for Aid to Dependent Children.**



Art. 62. To see what sum of money the Town will vote to raise and appropriate to assist the Library Association.

**Budget Committee recommends \$3,000.00.**

Art. 63. To see what sum of money the Town will vote to raise and appropriate for the Town's share of Social Security payments for the year 1956.

**Budget Committee recommends \$3,000.00.**

Art. 64. To see if the Town will vote to raise and appropriate \$375.00 to be paid to the Ocean Park Association for the Town's share of the cost of cleaning Temple Avenue and Ocean Park Beach.

**Budget Committee recommends \$375.00.**

Art. 65. To see what sum of money the Town will vote to raise and appropriate for the improvement of drainage in the Ocean Park area.

**Budget Committee recommends \$800.00.**

Art. 66. To see what sum of money the Town will vote to raise and appropriate for the construction of sidewalks on the following streets:

Saco Avenue from Atlantic Avenue to Sante Bros.— a distance of 1350 feet.

Highland Avenue on south side—150 feet.

Colby Avenue, northerly side—200 feet.

Hillcrest Avenue—270 feet.

Westland Avenue—75 feet.

**Budget Committee recommends the following:**

Saco Avenue—\$3,375.00

Highland Avenue—\$375.00

Colby Avenue—\$500.00

Hillcrest Avenue—\$435.00

Westland Avenue—\$187.00,

a total of \$4,872.00

Art. 67. To see what sum the Town will vote to raise and appropriate to construct a sidewalk on the Northeasterly side of Center Street, starting at the intersection of Saco Avenue to Charles Street—a distance of approximately 650 feet.

**Budget Committee makes no recommendation.**

Art. 68. To see if the Town will vote to raise and appropriate sufficient funds to construct a sidewalk from the Jameson School to Goosefare Brook via Ocean Park Road.

**Budget Committee makes no recommendation.**

2. He must not be a citizen of Old Orchard Beach.
3. He must have had a year's experience in some other community.

Art. 84. To see if the Town will vote to instruct the Manager and Selectmen to hold open meetings for the voters of Old Orchard Beach, at the regular meetings of the Selectmen.

Art. 85. To see if the Town will vote to instruct the Town Manager and Selectmen to hold open Budget Meetings for the voters of Old Orchard Beach at their regular meetings, and also to ask members to resign who do not attend meetings regularly.

Art. 86. To see if the Town will vote to authorize the Selectmen to employ the State Auditing Department for the year 1956, and that a mid-year inspection of the Town's financial affairs be made by that Department.

Art. 87. To see if the Town will vote to authorize the Selectmen and Town Treasurer to apply all un-expended balances at the end of the fiscal year of 1956 to Surplus Account, except those required by law, or by vote of the town, to be carried forward to the next fiscal year.

Art. 88. To see if the Town will vote to fix a date when taxes shall be due and payable, and to fix a rate of interest to be charged on taxes after said date.

**Budget Committee makes no recommendation.**

Art. 89. To see if the Town will vote to authorize the Selectmen and Treasurer to sell and dispose of property acquired by tax process, on such terms as they deem advisable and for the best interest of the town, and to execute quit-claim deeds for the same, or any action relative thereto.

**Recommended by the Budget Committee.**



Art. 90. To see if the town will vote to authorize the Selectmen to appoint a budget committee.

Art. 91. To see if the town will vote to authorize the budget committee to act in an advisory capacity to the Board of Selectmen and Town Manager and to meet with said Board and Manager at convenient intervals.

Art. 92. To see if the town will vote to petition the State Legislature to enact emergency legislation permitting the town to license seasonal businesses, the fees to be commensurate with the amount of tax that would apply based on a tax for personal stock plus the usual fee for that type of operation under the by-laws.

The Selectmen will be in session at the Town Hall on Thursday, Friday, and Saturday, March 1, 2, and 3 from 1 P. M. to 5 P. M., and on Friday evening, March 2, from 7 P. M. to 9 P. M. for the purpose of registering new voters and correcting the voting list.

The polls will be open on the day of said meeting from 9 A. M. to 7 P. M.
