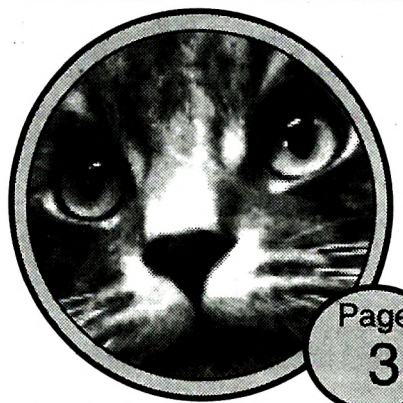

IN THE WORKS

. Tidbits gleaned from week's news

STILL MORE TRASH TALK - A Town Council committee will gather at 6 p.m. tonight (8/13), to continue the discussion about what to do with this municipality's trash now that the multi-million dollar trash-to-energy processing plant in Hampden is in legal receivership and trying to avoid bankruptcy.

The councilors are likely to simply stay the course, now that the trash and recyclables have been diverted to the Penobscot Energy Recovery Co. (PERC) plant in Orrington. None of the material is going to landfills, as it did while the Fiberright-developed Coastal Energy plant in Hampden was floundering. The fees are unchanged at PERC but the town's hauling cost is lower.

MEANWHILE, with uncertainty continuing to swirl about the long-term solution for processing rubbish throughout much of Maine, the Municipal Review Committee, which is the original contract for more than 100 communities to use the Hampden plant, is trying to hold the coalition together to see what can be developed for a more long-range solution.

INFLATION - With the cost of many projects on the rise, Town Councilor Mark Eastman wants to start the process to up the limit the council can spend without going to the voters by \$50,000 - to a new cap of \$300,000.

An amendment to the Town Charter will be given a first reading tonight (8/13), and a public hearing on Aug. 20. Eventually the idea will be decided on the Nov. 3 municipal ballot.

Local man accused of sexual exploitation

BUCKSPORT - A 55-year-old resident of the Town Site has been charged with possession of sexually explicit material and the sexual exploitation of a minor, both Class B felonies.

William Meier was arrested in Bangor late Friday (8/7) on warrants obtained by Bucksport police after a roughly two-month investigation.

The police also seized items after obtaining a search warrant for Meier's home here. The home also was searched on June 20.

The police offered few details, except to say the materi-

als were stored in an electronic format and it's not clear at this point who the alleged victims may be or where they may have been photographed.

The investigation is continuing, and additional charges may be filed, police said.

Meanwhile, Meier remains at the Hancock County Jail in Ellsworth.

The Bucksport investigation was aided by a special Vassalboro-based state police unit specializing in unlocking the contents of electronic devices.

Cruise ship firm scuttles Maine tours

Bucksport council's pared decision

BUCKSPORT - The town manager didn't want to make a recommendation until she had more guidance from people who know more about COVID-19 than she does.

The town councilors were on the verge of making a decision a lot of residents wouldn't like no matter how they voted.

But on Monday afternoon everyone got to slip the hook when American Cruise Lines sent word they won't be bringing their cruise ships to Maine this year after all.

Paul E. Taitlet, the president of the Guilford, CT-based line, said in an e-mail, "after thoughtful consideration with the utmost concern for the health and safety of your residents and our guests, American Cruise Lines has suspended all visits to Maine for the remainder of the 2020 season."

The decision came after a decision last Thursday by a major cruise industry association to which American Cruise Lines belongs, to suspend all domestic cruises, regardless of the size of the vessel, for the rest of the year.

The line came knocking at Bucksport's door the day after its bid to visit Bar Harbor with a reduced number of passengers failed on a 6-1 vote. And last week the top officials in Boothbay Harbor listened to a similar plea, and simply tabled the idea.

It was becoming increasingly questionable whether American Cruise Lines could cobble together enough Maine communities to

make even a shortened season with fewer passengers per boat possible.

Like many other industries, the cruise companies are piling up massive debts by the day as a result of COVID-19 concerns. American Cruise Lines is especially vulnerable because in February it ordered four more cruise ships to be built, with two of those to be delivered this year.

In February, the reality of the COVID-19 pandemic began to sink in, and the line's rosy outlook for a very prosperous 2021 floundered.

The financial loss for Bucksport will be minimal, as the

town had not expected the \$98,000 to \$100,000 in estimated dock fees the late-summer and fall visits would have generated.

And, in letters shared with the Town Council, local business people noted that they generally have not been positively impacted by the visitors the cruise line has brought.

That's because the cruise boats in recent years generally have arrived only when the captains have sought safe harbor dockages when stormy conditions were on the horizon on the open water. In previous years, the few scheduled cruise stops here generally were overnight stays, with the passengers being bused to Fort Knox and Bar Harbor via the Acadia National Park. The time spent visiting in Bucksport has been minimal.

Taitlet, the president of the firm, this week thanked the Bucksport town manager and town councilors "for your support as American Cruise Lines prepared to visit Bucksport in September."

He said, "We value our relationship with all of our community partners throughout Maine... We look forward to working with Bucksport to prepare for the 2021 season so that American Cruise Lines' ships may visit on a regular schedule. We wish your community all the best as you work through this difficult time."

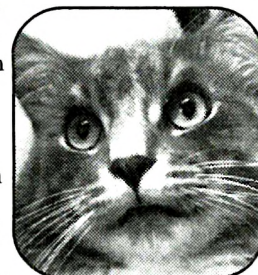
RSU 25 schools job is moving to full-time patrol duties.

Set course for 2021

It proved to be much ado about nothing, but the Town Council tonight (8/13) will avoid having to toss about a very hot spud. The councilors were to rule - mid-pandemic concerns - on whether American Cruise Lines could include Bucksport as a port of call for its few remaining cruises this year. Whether to let the small cruise ships to stop here proved more controversial than most had expected.

The council had been leaning toward allowing the few remaining cruises to dock here, but a boatload of verbal and written comments from the local citizenry showed a wide division over that idea. **EDITORIALS** *The Bucksport Enterprise* was prepared this week to air more than a page of comments from the public - some enthusiastically supportive, some adamantly opposed, others covering all of the shades of opinion in between.

However, on Monday afternoon American Cruise Lines pulled the plug on all of its Maine cruises this year. The Guilford, CT company failed to cobble together enough ports of call and passengers to make those 2020 cruises viable. Instead, the line continued to incur thousands in expenses each day with no revenues coming in. (*A cabin rents for \$4,750 per week and the "owners' suite" fetches over \$15,000.*)

While scuttling its operation this year, the line said it plans to return to Bucksport next year. COVID or no-COVID, the town shouldn't enter into a new arrangement blushing with innocence. Local businesses report the financial impact of the cruise visits is, at best, minimal. The town, at the least, should move to a more realistic dock fee for the cruise ships, which find the town a safe harbor in a storm, and a cheap one, too.

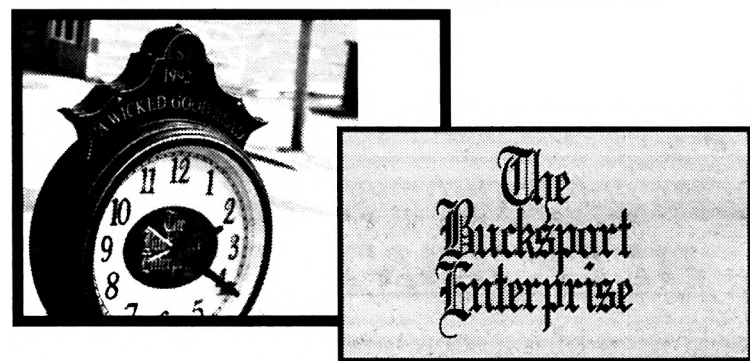
Don't vote . . .

. . . at least not until after the debates. While many are urging everyone to vote as soon as possible, we say, What's the rush? Maine voters this year are being inundated more than ever with 30- and 60-second commercials that illuminate little about those who would be president or Maine's senator. While televised political debates frequently disappoint, they at least provide opportunities for both candidates to show how they behave under pressure, while candidly displaying how they think when deprived of teleprompters and spin doctors.

One of Maine's Senate candidates says she wants five debates, the other would up that to 16, one in each county. If we're lucky we suspect there'll be no more than two or three. (Only one has been scheduled, and that won't occur until Sept. 11. That's all the more reason voters should keep open minds while holding onto their voting options.)

Too many of today's candidates revel in being marketed like "My Pillows" lest their true character and positions be exposed to public scrutiny. Ironically, we hear them advertise more about why their opponent should be defeated than why the sponsoring candidate should be elected.)

This nation pines for the days when more candidates said what they meant, not what they think we want to hear. Those who fail to speak decisively usually enact poor policies. Still, we continue to hope. In the meantime, don't vote until you've heard these candid exchanges. The only thing worse than a non-voter is to be an uninformed voter.

Making the case for masks

This is in response to Kerry Zimmerman, a volunteer "chastised" for not wearing a mask at a committee gathering in a cemetery. It's ironic that the incident took place in a cemetery, a place where you are surrounded by dead people. Literally. No sly metaphor. No epic analogy. (*Keep that in mind for later when dead people return.*)

My condolences to Zimmerman's peers, especially Christopher Johnson, who not only witnessed but tolerated her boorish and infantile behavior. Zimmerman said she felt, "threatened" and made a "harassment" claim against Johnson.

The mask requirement is posted on the town's website, so in this case Zimmerman was clearly in the wrong. Johnson states he will, "continue to do what he believes is best for the town." My advice to Johnson: "Continue being a sane community member."

My advice to Zimmerman is threefold.

• One. Get your facts. When COVID-19 first

appeared, the Center for Disease Control was uncertain about the benefits of masks; however, as we learned more, professionals realized masks greatly reduce the spread of COVID-19.

To date COVID-19 has killed 140,000 Americans; 1,214 in Maine. (Think of that cemetery.) That is fact, not media bias. Cherry-pick your stories, but facts are facts. And don't name-drop Orwell- He would disdain your rationales.

• Two. Grow up. This is not kindergarten. You have rights, but so do the other residents in Hancock County: they have the right to live.

• Three. Wear a mask. Don't tell residents to "mind their own business" because your lack of a simple mask might just kill them.

Zimmerman asks for a return to civility and claims that mask-proponents are "dangerous." Let's just take a poll at that cemetery.

ON THE LOCAL BALLOT -Thomas Foster, of 1310 River Road, North Bucksport, the incumbent chair of the RSU 25 School Board, is the first to qualify for the Nov. 3 ballot. He returned his signed papers to seek one of the two three-year terms available to Bucksport residents

Town Councilor, Mark Eastman of 3 Thomas Street, and Mayor Peter Stewart of 766 State Route 46, have taken out nomination papers to seek three-years terms on the council.

BOWING OUT? - After a public flap between two members of the Bucksport Cemetery Committee over wearing masks during the pandemic, one has offered to step aside if requested. Christopher Johnson of North Bucksport, a backer of mask-wearing, offered to resign if that's necessary to have Kerry Zimmerman of Holden, an opponent of masks when social distancing is possible, remain on the panel. The two traded words at a recent gathering of several people in a North Bucksport cemetery.

Johnson said he wants to do what's best for the town, and acknowledges Zimmerman's savvy in identifying and protecting the graves of veterans, especially those in this nation's earliest wars.

27 MAIN STREET - The broker seeking to continue the marketing of the town's empty 1.1-acre lot at 27 Main Street has submitted a two-page proposal to enhance the sales effort. Kathy Coogan of Two Rivers Realty of Bucksport is offering to expand the marketing push in return for a \$5,000 commission if the effort is successful, or \$3,000 if the town finds a buyer.

The town would incur no expense until the lot is sold, Coogan wrote. The Town Council has invested some \$3000 in acquiring and then clearing the site.

HANDS-FREE SIREN - The police department tonight (8/13) is expected to get Town Council authorization to buy a 2020 Ford Interceptor cruiser from Quirk of Augusta for \$39,359. While not the lowest of the three bids, the vehicle the department already owns has most of the required lights except for the light bar on top. That will "save time and money", according to the Town Council resolve to be discussed tonight (8/13).

The police also want to add \$4,550 worth of graphics and cruiser equipment including a \$430 hands-free siren with nine switch lights and a \$1,250 trunk organizer.

SIRENS II - The 2013 Ford Explorer the police department is "retiring" will be turned over to the deputy fire chief, who previously has not had his own assigned vehicle. Giving the deputy chief his own vehicle will help with his out-of-town travel and his 24-hour-a-day responses when summoned from home, according to the paperwork.

The public safety director and the deputy police chief already have their own assigned, take-home vehicles.

OOPS! - Months ago, the Town Council agreed to spend \$60,000 to add diesel fuel and upgrade the gas pumps at the municipal marina, with half coming from the state. However, the bids are in, and the lowest is \$50,000 over the budget. The town will have to ante up the extra or risk losing the state cash because the work has to be done by Dec. 31.

Town officials are asking the state to split the extra \$50,000 but at mid-week there had been no response.

Michael David Kelley, 1954 - 2020

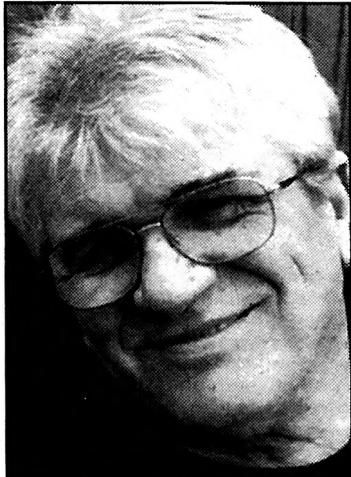
