We inclose herewith the seven blank certificates which we referred to yesterday in our telephone conversation. These are to be attached to certain certificates furnished us by Mr. Welch which are copies from his records of vital statistics. Inasmuch as these certificates are to be used in the English Court, it becomes necessary for them to be finally authenticated by the State Department in Washington, and it is our understanding that the only way that we can do is to have appear somewhere on the certificates the seal of the State of Maine, as the only thing to which the State Department will certify is the genuineness of the State seals.

We inclose also herewith, cheque for seven dollars in payment for same, as we understood the charge was one dollar for each time the seal was used. If you will have these certificates signed and sealed by the Secretary of State and return them to us we will be very grateful.
