## Dedication: The Ballpark Volunteers

It is a pleasure to dedicate this Annual Report to the host of Volunteers under the direction of Tom LaChance who have revitalized and restored the Ballpark.

2009 was the year that Old Orchard Beach's Ballpark came back to life. In the 1980's used by the Maine Guides minor league baseball team, and in the late 1980's through 1997 as a venue for concerts, the Ballpark since then had fallen into disuse.

The media declared that "the volunteer movement to bring the idle property back to life has seen a rebirth of interest in the vision for the Ballpark. The ball field, long a field of seedlings, has been cleared out and leveled and electrical wires from the old sound system has been removed; the field has been sodded, a baseline painted, and a warning track laid out. New roofs have been put on buildings, the old concession stand has been refurbished, and handicapped accessible bathrooms are in working order."

In May of 2010 the Ballpark will host the United States Collegiate Athletic Association's national baseball tournament for small colleges. Tom LaChance, a home-town boy, born and raised in Old Orchard Beach, is the man leading an extraordinary two-year effort to bring back the Ballpark for the citizens of Old Orchard Beach. Along with Town Council Vice-Chair Robin Dayton, Linda Jenkins, and Dana Furtado, there has been an organizational impetus on moving projects forward. The group sings the praises of the volunteers who are responsible for the significant turning point of this publicly owned facility. Hundreds of volunteers, some of whom head to the Ballpark every Saturday at 8:00 a.m. have and are doing their part, removing debris and graffiti, installing fencing and turf on the infield and rehabilitating the buildings that make up this property. The Ballpark which was devalued because of its lack of care and a 2008 fire in the Stadium, will, as a result of the incredible work of the volunteers be revalued in the April 2010 tax season.

The Ballpark rejuvenation is a significant project that is bringing together people from all over Maine. Individuals from Scarborough, South Portland, Biddeford, and several other communities are here working on the Ballpark, most of them passionate about the project because of memories of the Ballpark at its height. In addition to physical labor, local business owners and interested individuals have contributed over \$250,000 in materials. All for the citizens of Old Orchard Beach.

## TOWN CLERK'S OFFICE

I am truly honored to provide you with information about the activities of the Town Clerk's Office. The Office of the Town Clerk is responsible for all the records of the town, including all birth, death and marriage records, issuance of marriage licenses, all meeting minutes from the Town Council, School Board, as well as all boards appointed by the Town Council. This Office is also responsible for Elections, hunting and fishing licenses, horse permits, as well as dog licenses, transfer station and parking permits. The Town Clerk's Office also issues Passports, and sells trash bags. The breakdown of licenses issued is as follows:

The real estate market for Southern Maine properties, particularly for seacoast communities such as Old Orchard Beach, has slowed down when compared with the past several years. In FY '09 the assessing office reviewed several hundred permits resulting in approximately \$16,580,500 of new growth. The Town's total valuation went up approximately \$23,300,000. The mill or tax rate went up from \$12.56 to \$12.94. The median assessment ratio (assessment ratio = assessment divided by sales price) is approximately 94% which means properties are being assessed at about 94% of their fair market value. This is an increase of 2% from the FY'08 ratio indicating a slight softening in some areas of the local real estate market. The assessment ratio has moved closer to fair market value as of April 1, 2008.

Our goal has been and will continue to be to provide an equitable and accountable real estate based assessment program that is fairly administered as outlined in the State Statues governing property assessment. The assessment ratios will also continue to be in compliance with the standards for quality assessment as outlined by the International Association of Assessing Officers.

There are programs such as the Homestead Exemption and Veteran Exemption available to those residents who qualify to help alleviate some of the tax responsibility and are outlined on the Town's website and are also available in our office in the Town Hall. These forms are due in the Assessor's Office by April 1<sup>st</sup> in order to be applied to the next fiscal year.

**Planning Department and Planning Board  
Annual Report – 2008 - 2009**

Planning staff prepared application materials for the Planning Board for subdivision and site plan review developments as well as design review certificates. Staff met with applicants, prepared memos and other documentation necessary for informed board decisions. The Planning Board conducted workshops on the first Thursday of every month, followed one week later by a voting meeting. Planning Board members were Chairman Win Winch, Eber Weinstein, Don Cote, Mark Koenigs, Karen Anderson, and Tianna Higgins. The Board regrettably dealt with resignations of Ken Mac Auley, Ivan Most and Robert Quinn, but thankfully accepted Eber and Karen as new members. The Board presently has one vacancy.

Assistant Town Planner Jessica Wagner continued her fine grant work with the receipt of \$150,000 of Community Development Block Grant funds for downtown façade renovations. This work will be completed in 2010 and should greatly improve our downtown appearance. It is a staff intensive process but well worth the effort.

Eight new or amended Subdivision plans were approved resulting in 16 new lots and 73 new condominiums. Site Plan Review and Conditional Use approvals resulted in 54 new campsites, one home day care, hot sauce, firearms and RV sales, contractor home office, home dog groomer, home chair caning and one accessory apartment.

Staff worked many hours on LD 1119, a bill signed by the Governor to move the OOB boundary three miles out from low water. Many trips to Augusta were made to testify before the State and Local Government legislative committee. Staff continues to be involved in this situation as the boundary should be changed during 2010.

Staff continues to work with Eastern Trail, New England Passenger Rail Association, DEP storm water permitting update for town storm drains, and Maine DOT and PACTS on various transportation issues.

## DESIGN REVIEW COMMITTEE

### *Sec. 78-246. Purpose.*

*The design review committee shall be responsible for conserving the cultural and architectural heritage of the town, providing technical design assistance to property owners, and promoting quality architectural design and historically sensitive building renovation as a means of sustaining economic vitality and stable property values. (Ord. of 9-18-2001, § 13.1)*

### Membership (FY 2009):

The Design Review Committee (DRC) meets the first Monday of each month throughout the year. The DRC is responsible for the recommendation of *Design Review Certificates* for activities in the Downtown Districts and the recommendation of *Certificates of Appropriateness* for activities in the Historic Overlay District. The Committee is also responsible for the issuance of seasonal *Boarding-up Permits* throughout town. During FY 2009, the DRC approved the following activities:

### Recommendation for Design Review Certificates (issued by the Planning Board):

- 4 Boisvert Avenue: reconstruction of a two-family home.
- 29 West Grand Avenue: renovation of the Beachwood Motel façade.
- 80 First Street: addition of a second story to existing single story building.

### Issuance of seasonal Boarding-up Permits:

- 71 West Grand Ave: The Ocean House
- 68 & 70 West Grand: The Drift Wood Motel

Each of these proposals required meetings to review architectural, design, streetscape and landscaping plans for referral to the Planning Board for a Design Review Certificate. The Design Review Committee is a dedicated group of residents interested in promoting the future of the community by insuring the development of the downtown districts meets the standards of the Comprehensive Plan and Ordinance.

### Administrative Design Review Certificates:

Minor building improvements visible from a public street that are less than 500 square feet in area are reviewed administratively by Planning and Code Staff.

*Administrative Design Review Certificates* have included the construction of fences, improvement of decks and minor renovations to building facades visible from a public street in the Downtown Districts. During FY 2009, Planning and Code Department staff reviewed and approved 13 *Administrative Design Review Certificates* and renewed 8 *Boarding-up Permits*.

## **BUILDING INSPECTIONS & CODE ADMINISTRATION**

**July 2008 – June 2009**

### **Annual Report**

The primary responsibility of the Building Inspections and Code Administration Office is to protect the public health, safety, and general welfare of all of the Citizens and Visitors of the Town of Old Orchard Beach through the administration of various Local, State and Federal Laws and Ordinances. To help achieve that goal, the office reviews plans and issues general building permits, electrical permits, internal plumbing and septic system permits. The Staff also conducts progress inspections relative to each of those permits, as well as all Business License application sites for compliance with applicable provisions on the Housing, Plumbing, Electrical, Life Safety/ Fire Codes and the Town's Zoning Regulation. This is limited to new licenses, changes in ownership or licensed properties that have delayed their renewal or for which complaints have been filed. Our staff responds to hundreds of complaints annually about violations of the Town's various Ordinances. Our Department works very closely with the all of the Town's Departments and State Agencies to maximize service to our broad range of clients.

Our personnel continue to improve their code knowledge by attending continuing education classes and seminars sponsored by various governmental agencies. Staff members also maintain memberships in the Maine Building Officials & Inspectors Association, the National Fire Protection Association, and the International Code Council. This year Michael Nugent became the State of Maine's first International Code Council Certified Building Official. Michael also successfully completed the Advanced Floodplain Management Concepts (1) Seminar at the FEMA Training Center at the National Fire Academy in May of 2009.

Our State and Nationally Trained and Certified Staff assists residents in determining flood zones, base flood elevations, and requirements relative to Federal Emergency Management Agency (FEMA) Floodplain Management Standards. We also assist in identification of location, setbacks, activities, and permits required in area regulated by the State Department of Environmental Protection (DEP) pursuant to the Natural Resources Protection Act (NRPA) The areas include: Coastal and Inland Wetlands; Rivers, Streams, and Brooks; Significant Wildlife Habitat; Resources of Special Significance; and Coastal Sand Dune Systems.

Old Orchard Beach participates in the Community Rating System through the National Flood Insurance Program (NFIP) overseen by FEMA. Because the Staff is committed to provide an elevated level of services, The Town has been awarded a level 8 which is an improvement from a level 9 in the last rating period. Each rating improvement creates a reduction in the Flood Insurance rates for our eligible property owners. FEMA has released new Flood Insurance Rate Maps which should be in effect by mid-2010. On the draft maps 1551 properties are in flood zones that were not in the 1984 maps. Our staff has attended conferences at FEMA headquarters to be specially trained to be able meet the challenges of the additional flood prone properties. There will be significant Community outreach during the comment period and appeals to the maps may be filed through this office.

The Code Enforcement Officer and Administrative Staff are the staff support to the Zoning Board of Appeals which meets monthly as needed to consider a variety of Zoning Appeals.

- Due to budget limitations and eliminations Deputy Chief John Fitzpatrick returned to the rank of Firefighter-Paramedic and resumed regular shift work.

- Continued our Fire-Police program to assist with security and traffic direction at major incidents and added new personnel.
- Continued to participate in the Maine Healthy Beaches program.

We continue to pursue fire prevention through inspections and educational activities and have reduced the number of accidental fires annually in Town. Our in-house training program has been expanded to include more firefighter safety programs for personnel.

## OLD ORCHARD BEACH LIFEGUARD SERVICE



Lifeguard Captain, Keith Willett, provided a report this week on the services of the Old Orchard Beach lifeguards during the summer month. It was noted that they responded to 66 emergency calls over the eleven week period; thirteen more than last summer. There were 50 swimmers that were rescued from the surf by the lifeguards; seven were transported to the hospital via ambulance. On the Saturday in August as a result of Hurricane Bill which sat off our shore causing the surf to reach 20 feet at times which created multiple riptides along the four miles of beach, lifeguards responded to a call at the Pier for ten swimmers trapped underneath the Pier. For the first time in fifteen years on a Sunday, after making twenty-two rescues, the beach had to be closed. On top of rescuing multiple swimmers from the surf, lifeguards also responded to 27 medical emergencies, removed three predators from the beach, assisted the Police twelve times with multiple unruly subjects and reunited 106 lost children to their parents or guardians.

The Lifeguards also found time to play. For the first time in over twenty years, the Northern New England Lifesaving Championship came back to Old Orchard Beach. The event brought roughly 200 lifeguards and spectators from as far away as Cape Code. The competition was a great success as Salisbury, Massachusetts edged out Ogunquit by one point. On an even higher note, the competition raised \$1,500 for the Maine Children's Cancer Program and the Make a Wish Foundation.

Over the winter months there will be lots of repairs to make the lifeguard towers, radios and rescue torpedoes up to their needed use. Chief John Glass praised the work of the Lifeguards who protect the lives of so many during the summer months.

## **POLICE DEPARTMENT**

### **ANNUAL REPORT 2008-2009**

I am, once again, pleased to present the 2008-2009, Police Department annual report which summarizes the accomplishments and services provided by the men and women of the Old Orchard Beach Police Department. Fulfillment of our mission would not be possible without the support we receive from the Town Manager, the Town Council and by the many relationships we have developed with members of the business community, civic organizations, citizens and our Community Watch groups. I would also like to acknowledge our Fire/Police volunteers who have provided an invaluable service to both departments. We certainly appreciate their efforts.

Statistically, crime in Old Orchard Beach was similar to 2007-2008. There was a reduction in four of the seven part 1 crimes we report but there was an increase in three, which include, rape, robbery, and burglary. Property crimes which include, larceny, vandalism, and burglary are the most prevalent problem and showed an increase in most areas, with vandalism being the most significant. The number of traffic citations decreased. The number of liquor related violations also saw a significant increase. Through a grant from the University of New England, we increased our enforcement of liquor related violations by assigning additional personnel to deal specifically with underage drinking and other alcohol related issues. Underage drinking is something that we feel strongly about and will continue through education and strict enforcement of liquor laws to reduce the number of alcohol related incidents in Old Orchard Beach.

Among our accomplishments last year was the completion of our second Citizen Police Academy. Sgt. Vincent Mattia coordinated this effort along with help from department personnel. It was, by all accounts a huge success and well received by those attending. There are plans for an advanced class which will be held this fall. I am also happy to report that Gunther, our police K-9, is now certified in drug detection and tracking. This is a huge accomplishment and I would like to thank his handler, Patrolman Chris St Pierre, for his outstanding efforts with the K-9 program.

The men and women of the Old Orchard Beach Police department and Communication personnel are professionals dedicated to our mission: The delivery of responsive, compassionate and professional police and dispatch services in partnership with the community to reduce crime and make Old Orchard Beach a better place to live. It is an honor to serve.

## GRANTS

This year we have received several grants:

1. The Edward Byrne Memorial Justice Assistance Grant (2009-2010) \$49,364.00  
These funds will be used to purchase Tasers and related equipment for the officers as well as a Portable Message Board.
2. Eastern Trail Grant – The Scarborough Police Department and the Old Orchard Beach Police Department jointly received a grant in the amount of \$8,336.00 for expenses related to officers conducting patrol details on the Eastern Trail. The patrol details took place during the months on May, June and July 2009. This grant was offered through the Department of Inland Fisheries and Wildlife.
3. Coastal Healthy Communities Coalition – In partnership with the University of New England a coalition has been created which is called Coastal Healthy Communities Coalition. This organization offers grants to local police departments in York County to address issues related to underage drinking. The Old Orchard Beach Police Department has received \$10,673.50 towards this initiative..
4. Bulletproof Vest Partnership Program - \$1,665.00 these funds reimburse the department towards the purchase of ballistic vests.

## CRIME WATCH

### The Community Watch Council 2008-2009 Report

The Community Watch Council was established in 2006 in response to the growth of our Neighborhood Watch groups and community programs. The Council consists of 6 active community members that work jointly and in cooperation with the Police Department and 2 representatives of the Police Department. The CWC meets monthly to establish goals, objectives and guidelines to assist the Neighborhood Watch groups during the implementation of the new programs.

### Growth

In 2008-2009, the CWC developed new Neighborhood Watch areas throughout town which include Homewood Park and Orchard Terrace. These are in addition to the existing areas such as the Campground Neighborhood Watch, Ocean Park, Town Hall, Pinebrook Terrace, Patoine Place and Cider Hill. Much of the development started with “walkabouts” and many neighborhood meetings.

CWC Volunteer Coordinator, working closely with the Police Department, fulfilled the summer staffing needs at the Sub Station.



### Events

CWC participated in the October Fire Station Halloween Night promoting a positive response for community awareness.

CWC participated in the Old Orchard Beach November elections distributing informative handouts to the voters. People expressing an interest in Neighborhood Watch.

Launched a town-wide program Vial of Life, a brief summary presentation was given Town Council meeting in December.

On February 6 and 13, the CWC in concert with Town Manager participated in the Junior Achievement day at Town Hall. School Resource Officer Peter Guay (SRO) and the CWC President gave a brief talk on internet safety and handed each a Vial of Life.

April 25, sponsored a town-wide Clean up Day in concert with DPW.

May 2, CWC participated in the Fire Station yard sale as a fundraiser.

May 3, CWC participated in OOB365 Taste of OOB. Table set up with printed handouts for community awareness.

May 9, CWC President attended Salvation Army Health Fair to promote CWC.

May 19, CWC presentation to town council giving an updated report on CWC accomplishments.

## **ANIMAL CONTROL – POLICE DEPARTMENT**

Old Orchard Beach Animal Control is continuing its mission to ensure the health and welfare of all animals within the town. This year the ACO and the Police Department answered 902 calls relating to animal welfare, most involved domestic animals, but several complaints were related to wild animals.

Working with the Town Clerk, we have begun to make contact with the large number of unlicensed dog owners that were identified by a new state law requiring, all veterinarians to send copies of all rabies certificates they issue to the Department of Agriculture. So far this program has been a success as the number of licensed dogs in Old Orchard Beach has increased by 121 animals, from 863 in FY 07/08 to 984 in FY 08/09. We urge everyone with an unlicensed dog to license it as soon as possible by visiting the town hall.

Over the course of the year there were three calls that stood out as being unique. In the spring time Animal Control, the Fire Dept. & the Marine Animal Lifeline worked together to try and save an injured/ill adult seal in Old Orchard Beach. Once the animal was recovered from the surf by the ACO & FD and examined by Marine Animal Lifeline staff it was determined that its injuries/illness were too great and it was not able to be saved. Additionally a small python was recovered in the parking lot of a local motel, and sent to a local veterinarian for treatment of burns. Once the snake was treated, it was adopted by a responsible new owner. This makes the third python that has been recovered in the wild by the ACO and Police Dept. in the last 5 years. If you have a snake as a pet and no longer wish to keep please contact the ACO, he will try and assist you in placing your snake or contacting a reptile rescue. Additionally a dog was removed from a locked car with the assistance of a local wrecker company; the temperatures were extremely hot that day and the temperature measured well in excess of 100 degree's in the vehicle. Once located the owner was charged with animal cruelty.

Unfortunately we have noticed the number of animals taken in by our kennel has again increased. We are more than willing to try and assist pet owners with placing animals that they can no longer care for. However at this time we do not accept owner surrenders, and stand by our policy that the placement of a pet is the responsibility of the owner. ## Annual Report 2008-2009

### **FY09 Annual Report**

The wastewater department is staffed by six full time employees and one seasonal employee. There are two individual departments that handle maintenance and operational duties.

The Maintenance Department consists of Mike Hersey, Dan Deshaies and Carl Sawyer. The maintenance staff has worked diligently to address major maintenance issues. This has paid off in the form of reduced call-ins and fewer instances of equipment failure. Catching up with past maintenance needs has allowed the maintenance staff to address some of the major repairs and upgrades in-house, thereby saving the town money in hiring outside contractors. The largest of these upgrades is the SCADA project. Once this is complete, the staff will be able to monitor and control most aspects of the pump stations from a remote computer located at the wastewater facility. Rather than hire a general contractor, incur engineering fees and sub contract the construction activities; the department chose to fill all of these roles in this design-build project. While the project schedule itself has fallen behind the original timeline, we feel that this will be the best product for the town. I would especially like to thank Mike Hersey for his assistance in coordinating the work associated with the SCADA project and his input in the design phase. I would like to congratulate Daniel Deshaies for his promotion to Senior Mechanic!

The operations staff consists of Allen Burnham, Larry Thomas and Daniel Creighton. The Operations Department is responsible for all chemical and biological operations. The facility contains a mix of older and newer technologies

creating challenges in meeting the state and federal discharge limits. Despite this, the department continues to operate the facility to surpass its mandated 85% removal rate of the pollutants. Although they are a small piece of the puzzle to a larger upgrade, some of the in-house upgrades have enabled the staff to be more efficient in all areas of operation. This year the facility was granted a new five year discharge license without any additional restrictions, due in part to operating the past five years without any major violations.

In October of 2009, the town council received a report detailing some of the needs this department has. Within this report Wright-Pierce has identified three separate phases of capital upgrades to the facility and pump stations. This document could be considered a comprehensive plan for this department and gives the town the framework for any future upgrades. The report also contains funding sources and grants that are available from federal and state authorities. It is my hope that once the town has chosen a permanent town manager, we can work collectively to formulate a capital improvement plan for this department.

## **PUBLIC WORKS DEPARTMENT 2008 – 2009 ANNUAL REPORT**

The Public Works Department is responsible for protecting the public's investment in the complex infrastructure that is necessary to support the physical operations of the Town. Our team is responsible for streets, sidewalks, parking lots, sewer and storm drain lines, beach, parks/green space, transfer station, solid waste, recycling, fleet, and facility management. To summarize FY08, our team focused on Capital Funding,

**CAPITAL FUNDING:** We gained approval from the voters in November 2007 supporting an infrastructure bond package of 5.3 million in an effort to more efficiently and effectively carry out the strategic plans of DPW. The following projects are targeted for major infrastructure improvements over the next eighteen months as financed through the new bond package:

### **WEST GRAND STORMWATER/ROADWAY PROJECT:**

- Goals:** Provide safe passage for emergency vehicles  
Provide a safe evacuation route  
Address street flooding
- Scope:** Upgrade the stormdrain/sewer infrastructure  
Raise the roadway to the 100 year flood level  
Adjust the tide gates

### **SUMMIT STREET SEWER PROJECT:**

- Goals:** Address a failed sewer system  
Address street flooding
- Scope:** Replace and redesign the existing sewer system  
Add new storm drain infrastructure  
Rebuild the roadway

### **ROSS ROAD CULVERT PROJECT:**

- Goals:** Address a failing storm drain system  
Improve public access to the marsh
- Scope:** Replace temporary culvert  
Raise the roadway to the 100 year flood level

### **OCEAN/SEAVIEW SEWER PROJECT:**

- Goals:** Address a failing sewer system
- Scope:** Replace and redesign the existing sewer system

9. **DIRIGO DRIVE SAND SALT FACILITY** - Public Works Dept. designed a new lay out for permanent 6ft concrete walls for holding more material for the winter months and having all material under cover.
10. **EAST GRAND AVE** – Repaired existing pavement with cut out.
11. **EXTREME CLEAN** – Coordinated cleaning of downtown area, 3 public restrooms, and 75 municipal trash barrels.

27. **PARKS & RECREATION** – Supported Parks and Chamber of Commerce in annual events.
28. **PARK BENCH PROGRAM** - Installed (3) park bench, (4) beach benches, (1) town hall bench, and (1) bench in Orchard Hill Terrace.
29. **ROAD STRIPING** - Painted all the roads and crosswalks, arrows and stalls in an effort to cut cost compared to contracting the work out
30. **ROSS ROAD** – Replaced two 12” culverts with new 15” culverts on Saco end and box cut and paved 550 lf by Patoine Place.
31. **ROSEDALE STREET** - Drainage problem around the house next to the beach, added a concrete pad in front of garage area to divert the water shed.

32. SACO AVE - Continued with the emergency 911 9inch w/logo street signs from the Spur to Cascade Rd. Also grind and repave 840 lf.
33. SIDEWALK REPAIRS – Patched select sidewalks throughout town.
34. SMITHWHEEL ROAD – Repaired existing pavement with cut out.
35. STREET SWEEPING CLEANING - Street sweeper picked up 140 yards of material, swept all town roads twice.
36. STREET TREE PROGRAM – Planted six new trees on Portland Ave.
37. TRANSFER STATION ACCESS ROAD - Built a new road from the top of the transfer station down to the pit area with the spoils from the ball park.
38. UNION AVE – Installed 200 lf of curbing.
39. WESTLAND AVE – Installed speed bumps.
40. WILD DUNES WAY - Repaired existing pavement with cut out.
41. WILDWOOD – box cut and new pavement 134 sy.
42. WINONA AVE - Repaired existing pavement with cut out.
43. WINTERGREEN ST – shim and overlay 3,478 sy.
44. WINTER OPERATIONS - Responded to (14) winter storms (81” of snow) and continued to have great success with the salt brine mix on all the primary roads.



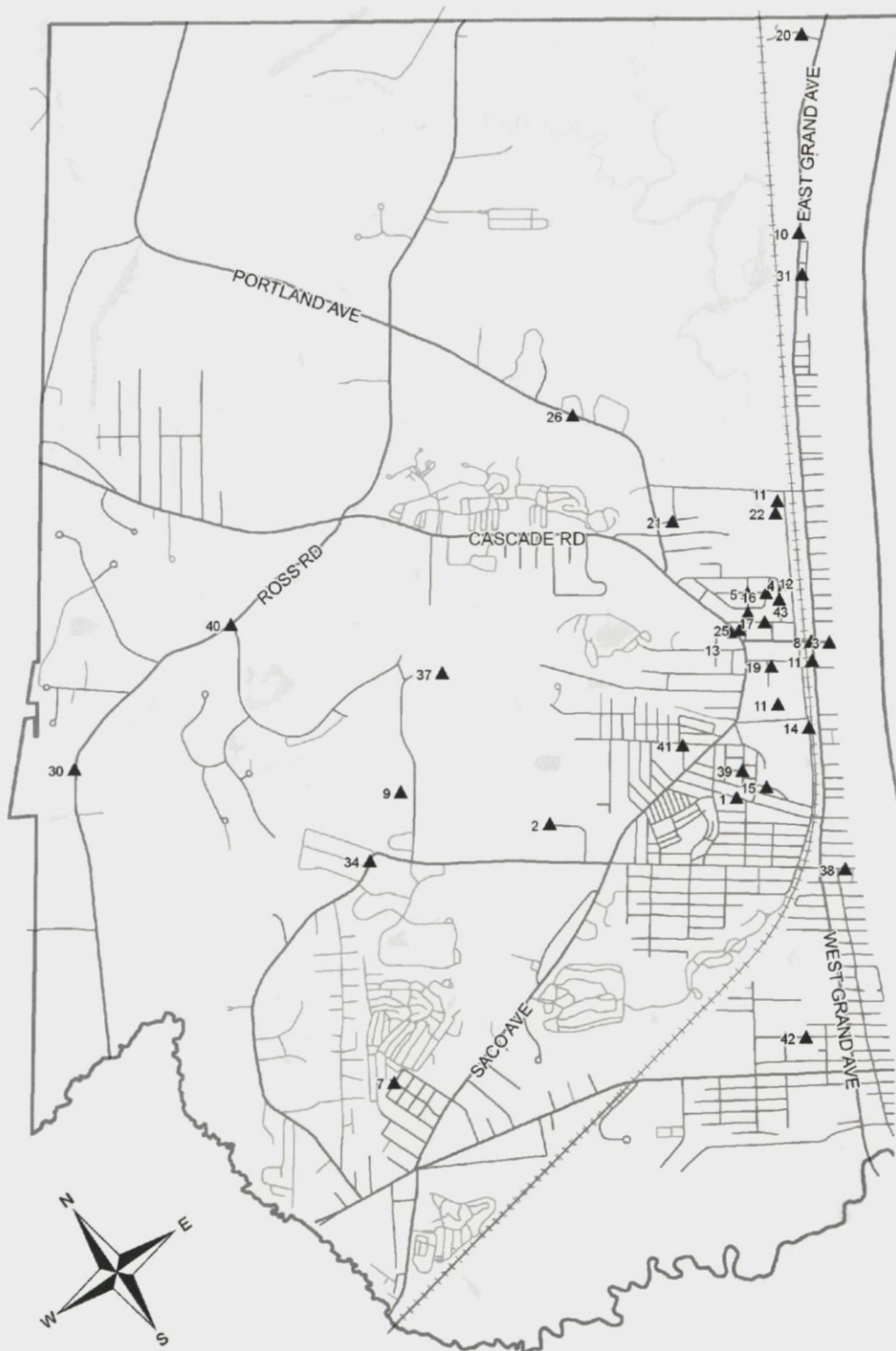

## E.E. Cummings Boulevard Sidewalk Improvements

### Old Orchard Beach, Maine

Wright-Pierce was retained by the Department of Public Works to develop bidding and construction documents for the provision of sidewalks improvements along portions of E.E. Cummings Boulevard.

The boulevard is a high traffic area in a school zone. Increased vehicular traffic, in conjunction with the student pedestrian traffic, warranted improvements. Wright-Pierce developed a bike/pedestrian path that meets American Disability Act (ADA) and Manual on Uniform Traffic Control Devices requirements. A landscaped buffer separates the pedestrian traffic from the vehicular traffic. Other safety measures incorporated into the design include raised crosswalks to slow traffic and to delineate a clear pedestrian crossing area, and a flashing sign to warn vehicles when school is in session in the area.

The project was partially funded by the Maine Department of Transportation (MDOT) Safe Routes to School and the Federal Highway Administration (FHWA). Wright-Pierce worked with the Town and MDOT to meet funding requirements.

Wright-Pierce participated in public meetings to present the project and solicit feedback from school staff and other citizens. Significant effort was spent incorporating public feedback into the final design.

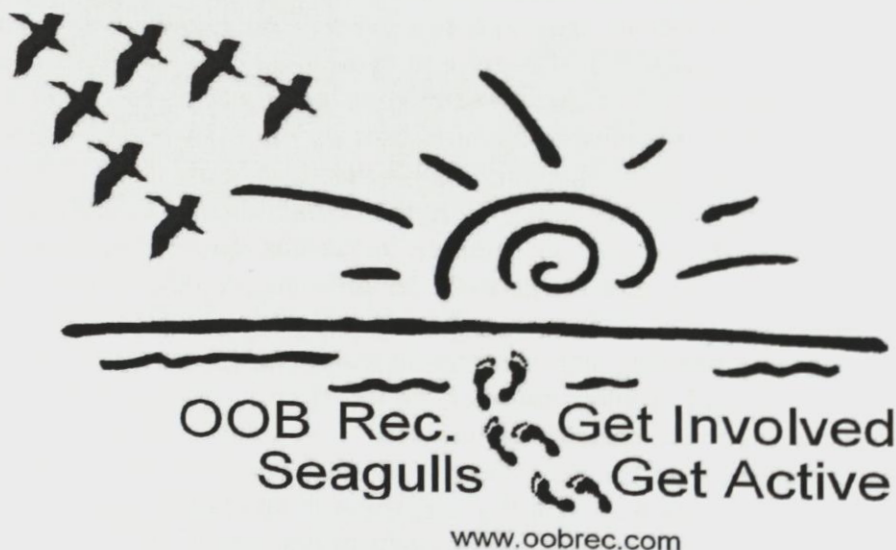

Along with nearly 100 annual program options, members of the 50 +/- group benefit from quarterly newsletters, meetings to share program ideas, and also from the use of the Recreation Department's fitness equipment. This year was spent building a strong foundation of dedicated followers, and the coming year will bring the expansion of overnight and extended travel options to this aging and active population.

**Community Events Division:** Our department coordinates and/or assists in several special events throughout the year. Some of the major community events include: Summer Concerts in the Park, Egg-stravaganza, 4th Grade Theme Trees, Seaside Art Festival, Celebration by the Sea, Christopher Cash Memorial Race, and Jimmy the Greek's "Frozen 4 Miler." In addition, our department has been instrumental in the newly formed group, OOB365. We have participated in the coordination of such programs as: Taste of OOB, Autumn Celebration, Woofstock, and First Night. We look forward to continuing these efforts and building on this success in the coming year with Winter Carnival and more.

**Child Care Division:** We are proud of growth and quality of our Gull Care After-School Program. Coordinated by the Assistant Director, Nikki Duplisea. We strive to provide a program that meets and/or exceeds the State of Maine Day Care Regulations. As a Recreation Department, we are not obligated to meet such high regulations; however, we do so in order to provide quality care for our students and families. Other child care opportunities include: School Vacation Camps, Teacher Workshop Days, Early Release Days, Summer Day Camps, Gull Challenge, and Before-School Care. This coming summer will bring about some new and innovative changes that we believe will even better serve our community and improve the overall quality of our summer day camp experience.

## **Annual Report 2008-2009**



The Harmon Museum was open to the public from June 23, 2009 to September 5, 2009 with hours Tuesday through Friday, 11:00 a.m. to 4:00 p.m. and on Saturday, 9:00 a.m. to noon. The sagging economy, along with the rainy weather, caused a drop in our total visitors from 390 in 2008 to 356 in 2009.

The Historical Society received a grant of \$1,200 from the Maine State Museum for the preservation of our extensive clothing collection. Museum member, Judy Hurst, donated 57 passes to Aquaboggin Water Park and they were given away for a \$10.00 donation, saving people \$10.00 per ticket, and raising \$570 for the Museum. Our sincere appreciation to Judy.

We had 18 gifts of deeds this summer, all in excellent condition for our collection. We purchased a collection of 16mm and 8mm family films pertaining to aviation on the beach, along with family footage taken at the Bob Hazzard Estate at Grand Beach. This collection contains 90 films and will be edited this Spring.

The Aviation/Train room was painted by museum member, Peter Flaherty. Another upstairs room has been finished this summer adding much needed space for our collections. The roof has been patched and hopefully will be replaced next Spring plus the North side of the building has been touched up with primer and paint.

## LIBBY LIBRARY OLD ORCHARD BEACH FREE PUBLIC LIBRARY STATISTICS

Some explanation is needed for the following figures. In November of 2008 the Libby Library was flooded during a northeast storm. Fortunately, very few items from the library collection were lost, but there was some loss of equipment and furniture, as well as severe damage to all flooring and some staining of walls etc. As a result of this event, the library was forced to close for two months while extensive repairs and some renovations were made. During this time, staff tried to provide at least minimal services, which was difficult at best and often impossible. These problems are of course, reflected in annual circulation and operational figures. Circulation and some expenses were reduced because of being closed; some expenditures will be, or have already been, rolled over to fiscal year 2009/10. The 'silver lining' in this is that everyone has been so supportive and very pleased with the improvements; and the permanent repairs made should prevent such an event from recurring under similar conditions in the future.

**SUPERINTENDENT'S ANNUAL TOWN REPORT**  
**Jack Turcotte, Superintendent of Schools**



I am delighted to report to the citizens of Old Orchard Beach the following information relating to the Old Orchard Beach School Department. Normally, reports of this nature review information of the previous calendar year, however this report will reflect the current 2008-2009 school year due to changes in personnel.

In August of 2008, the Old Orchard Beach School Department hired a new Superintendent of Schools as a replacement for Rick Matthews. Rick was an Old Orchard Beach High School administrator and the Superintendent for a number of years. Since my tenure as the new Superintendent has been only 7 months, the comments reflected in this report will only encompass the months of August 2008 through February 2009.

In keeping with the theme of the recent presidential election, the year has been a year of change for the Old Orchard Beach School Department. The school's administrative team lost the services of Superintendent - Rick Matthews, Curriculum Coordinator - Pat Hayden, and recently, Special Education Director - Donna Ford. The loss of these three educational leaders has indeed resulted in a difficult challenge for the entire school community. However, this year's greatest challenge has centered on the lack of funding to support the approved budget. A very lean budget approved by the Town last spring has been negatively impacted by after-the fact financial surprises.

Currently, heating oil pricing, which is now under \$1.75 per gallon, was locked in during the fuel crisis at \$3.77. In addition, under-budgeted bus fuel and teacher education costs have added additional financial hardships. Along with these, the State of Maine's current state of economy resulted in a reduction of State aid to schools. The school department designed a budget based on \$1,088,684.00 in State support. Recently, we were notified that Old Orchard Beach Schools would receive \$54,000 less than promised. This shortfall in State aid coupled with other revenue shortfalls has caused a financial hardship for Old Orchard Beach Schools.

To address this financial problem, the School Dept. has frozen all expenditures, other than direct student programs. This action is anticipated to save approximately \$95,000. However, even with \$95,000 saved by the freeze of spending, the current budget will need additional financial support in order to remain in the black at the end of the school year. I am pleased to report that the

School Board and the Town Council are working together to address this serious financial situation.

In addition to the financial concerns, the new State law directing the need to consolidate school systems has had great influence on the Old Orchard Beach School Department throughout this school year. In November of 2008 the communities of Dayton, Saco and Old Orchard Beach voted to become a totally new single school department, which will be called Regional School Unit #23. The organizational structure resembles the current School Administrative Districts or SAD's that exist in other areas of the State of Maine.

A single Superintendent's office will administer the RSU structure and develop one single budget, which will be voted on collectively by the citizens of all the towns in the RSU. Currently RSU #23 is under "initial construction" with many questions remaining unanswered. We are diligently exploring and designing the new school organization that will soon serve students in Dayton, Saco and Old Orchard Beach.

This is a major change in the governing structure of the existing three independent school systems; however, the goal of reducing educational costs, and a desire to increase educational opportunities for students is exciting. It is my belief RSU #23 will continue to develop in the years ahead, and will provide excellent educational opportunities for all of our students. In February 2009, a new RSU #23 School Board will be elected and the organization will begin its existence on July 1, 2009.

I have had many positive experiences as the new Old Orchard Beach Superintendent of Schools. I have been overwhelmed with the quality, dedication and commitment of the Old Orchard Beach School staff. It is my belief that the employees of the Old Orchard Beach School system are outstanding employees who strive to meet the needs of students and the school organization. In spite of the financial hardships, the staff remains upbeat and professional. Student test scores are improving annually, our curriculum continues to adjust to the 21st century and classroom practices steadily adjust to the educational data that guides our teaching practices.

Our mission to develop and sustain educational experience for all of our students is consistently reinforced by the actions of all school employees. It is the consensus of all in the Old Orchard Beach School Department that the K-12 students are indeed, a wonderful asset to the Old Orchard Beach community.

I would like to thank the School Board for their trust in me and for the opportunity to be the Old Orchard Beach Superintendent for this 2008-2009 school year. The challenges of my assignment are many and the rewards of leading the Old Orchard Beach School system are plentiful. Thank you for the opportunity to serve as your Superintendent of Schools.

It was an exciting year at the Jameson School, and hundreds of learning and growing activities took place over the school year. As a kindergarten through 3<sup>rd</sup> grade school, students learned the basic ABC's, counting to 10, and spelling beginning words, all the way to writing a multiple paragraph paper, doing multiplication and reading chapter books for learning and pleasure. Combined with all of the fundamentals of learning, students also were taught about being part of a greater community, the world around us, health and wellness, and social skills (sharing, being honest, helping others, and not bullying). It was a very productive year, one that helped our youngest citizens grow and learn.

**New Staff** – Two new teachers were added to the Jameson School this year. Angela Hatch was hired as a Reading Recovery teacher. Reading Recovery is an intensive reading program designed to help 1<sup>st</sup> grade students gain needed skills to be a grade level reader. Darlene Boissonnault was hired as a Special Education teacher to work with students who may need some specialized instruction in math or reading to help them gain skills to be at grade level. Both teachers were great additions to the Jameson School, and they replaced teachers who left the district to take teaching jobs in other communities.

**University of New England Partnership** – During the 2008/09 school year, many positive connections were made with UNE. We hosted 27 UNE student interns who wanted to get direct classroom experience by observing and helping. All of the interns were studying to become teachers. Also, we were able to have different activities after school for our Jameson students that were led by UNE college students. They offered a Science Club, and game activities that were well received by our students. In addition, the UNE faculty made available data and information from their experiences and classes that our teachers at Jameson could use to help them better meet the needs of our students. It was a very worthwhile partnership this year, and we will hopefully continue with it in the future.

**Professional Learning Communities (PLC)** - Our third grade teaching team did a lot of research about best practices the year before, and this past year they implemented a PLC model for teaching literacy. The premise of PLC's is that each student needs to be met at his/her learning level, taught in a classroom setting, but with individual needs in mind. The PLC teachers meet together before and after school regularly to check progress, look at learning goals, and make adjustments to gain the most from every student. It was a productive method of team teaching, and we hope to continue with this model next year.

**Volunteers and Parent Teacher Organization** – Our Jameson parents and volunteers were very busy this year at school. We had over 25,000 hours of volunteer time logged at Jameson, and we were very fortunate to have that level of support. Our students were able to have many classroom presentations, field trips paid for by our PTO, after school activities offered, and assemblies held on many learning topics, in addition to one on one support and volunteers helping in individual classrooms. We appreciate all that our volunteers do to make our school a better place for learning. It is great to be supported as we are and to be a part of a community school.



## Town Report Loranger Middle School – 2008-2009

Loranger Middle School is one of three schools in Old Orchard Beach. It is home to students in grades 4 through 8. We started the year with 352 students and ended the year with 340 students. Our enrollment represents approximately 38% of the 886 students in Old Orchard Beach. Due to a higher enrollment of 4<sup>th</sup> graders, we added another teacher at the 4<sup>th</sup> grade level. In doing so we welcomed back Lynn Gierie, who had been on a two-year leave of absence. We also welcomed to our staff Linda Harding, who replaced Jackie Drown as our library/media specialist, Marilyn Sell as our new French teacher, and Traci Emory as a new Special Education Teacher. During the school year Assistant Principal Julie Smyth was out for three months having her second baby. In her absence George Shabo, our well known instrumental/band teacher, served in the capacity of interim Assistant Principal. In August of 2008, Jack Turcotte was hired as the new interim superintendent for Old Orchard Beach. Jack's experience and strong leadership qualities led us through a very difficult school year, due to the many financial challenges we were faced with. In November the OOB school district went into a budget freeze, which challenged our ability to support programming for our students.

In February the community of OOB voted to consolidate with Saco/Dayton, to become Regional School Unit #23. With this merger came many challenges and potential benefits. Much of the rest of the school year was devoted to consolidating services, and designing a central office staffing structure that would support this new RSU school district.

### Highlights of the 2008-09 school year:

- ❖ Continued development and support of strong & effective PLC's (Professional Learning Communities).
- ❖ The entire 8<sup>th</sup> grade class spent a full week at Camp Kieve, where they were immersed in adventure-based learning experiences, team-building activities, responsible decision making activities, effective communication skill-building, development of leadership skills, and bullying & harassment awareness.
- ❖ 7<sup>th</sup> Grade students spent a day at Camp Kieve in the spring, to do some adventure-based activities on the new indoor climbing wall. The purpose of giving some of our 7<sup>th</sup> graders a chance to experience this, was to give them a sense of what they will experience next fall as 8<sup>th</sup> graders.
- ❖ In November we celebrated "Red Ribbon Week" with student activities and a parade that included the Jameson school as well.
- ❖ The 6<sup>th</sup> grade participated in two 6<sup>th</sup> grade awareness days, one in the fall and one in the spring. The fall awareness day focused on team-building activities, while the spring awareness day was focused on peer relationships, communication, and tolerance & respect.
- ❖ We had a very supportive Loranger PTO this past year. The highlights of the year were the Scholastic Book Fair, the Penny Social, and supporting a number of school-based programs (i.e. Camp Kieve, LMS Band, 8<sup>th</sup> grade social).

- ❖ For the 2<sup>nd</sup> year in a row the 4<sup>th</sup> & 5<sup>th</sup> graders, along with the LMS Band, were involved in supporting “Wreaths Across America”, as their caravan came through Old Orchard Beach.
- ❖ We had a very successful STAR Day in January. The day is organized around the themes of Safety, Tolerance, Awareness, & Respect. Some of the activities were flags of nations, Holocaust History, anti-harassment & bullying w/ staff from the Center for Prevention of Hate Violence, and Camp Kieve follow-up.
- ❖ The 4<sup>th</sup> grade participated in the “Festival of Trees” celebration at the OOB Town Hall in December.
- ❖ The 5<sup>th</sup> grade was again involved in a Junior Achievement career shadow day, which included participation of students in a mock town council meeting at the OOB Town Hall.
- ❖ The 8<sup>th</sup> grade class participated in a History Day competition in February. A number of students earned the right to compete at the state History Day competition where they shared state championship honors.
- ❖ In February, LMS students participated in the annual LMS Talent Show. There were 26 acts/performances that included students from all five grade levels.
- ❖ In the spring, the 7<sup>th</sup> grade team hosted a “JA in a day” for the second year in a row. Students were engaged in different units focused on “economic success”.
- ❖ In the Spring, LMS hosted the annual “Evening of the Arts”. Student art work, representing every student in the school was displayed. There were performances by the LMS Instrumental and Choral groups.
- ❖ In June, the Drama Club, under the direction of Jessie Hemphill, performed a musical. The group of student thespians involved in drama, represented students in grades 4-8. The production was performed for the community and for the student body at LMS.

The 2008-09 school year was a very successful year, even with the difficult financial challenges we were faced with. As a second year principal, I was very proud of our students’ academic achievement and their involvement in the many activities that we hosted throughout the year. For my second year in a row we made AYP at all 5 grade levels, as determined by results on the state Maine Educational Assessment tests. I am proud of a staff that is dedicated and committed to supporting students emotionally, socially, and academically. The OOB community of parents and citizens continue to support our efforts, and we are very appreciative of their involvement.



## **Old Orchard Beach High School**

### **ANNUAL TOWN REPORT 2008-2009**

The Old Orchard Beach High School enrollment began in September 2008 at 292 students and ended in June 2009 at 285. The first day of school, September 2, was devoted to the freshman class. To start the day, students were welcomed and introduced to all of the faculty and staff. They then met with their advisors to go over rules and school policies, walk through their schedules, and met with their teachers. The day concluded with a scavenger hunt and the distribution of "Class of 2012" t-shirts. On September 3, all students were back at the high school for their first official day. An assembly to welcome students and introduce new faculty and staff started the day. Students then met with their advisors before attending a full day of classes. Our Open House was held on Thursday, September 18, and we had a strong showing of freshman and sophomore parents. The evening was designed to have parents of students from the same grade level spend a block of time with the teachers from each academic department. The scope and sequence of each curriculum area were shared with parents along with the specific expectations for each grade level. Parent feedback was very positive. The High School held its fourth annual Freshman Cookout on the lawn in front of the high school on September 11. We had a wonderful turnout of parents and students on a glorious fall evening. My thanks go to Mr. Trull and Mr. Walsh, who took on the grilling responsibilities. Mr. Steckino, Freshman advisors, teachers, and the three high school secretaries all helped out to make it an informal opportunity for parents and teachers to introduce themselves and put a face with a name. It was a good evening for all. Homecoming took a different slant this year, with more focus on school spirit and the recognition of our successful teams. With the weekend rainout, the Friday night football game was moved to Monday night. Old Orchard Beach was featured on Channel 13 preceding the rescheduled Monday game. Sportscaster Dave Eid arranged for Outback Steakhouse to host a tailgate party for the Homecoming celebration and bonfire prior to the game.

October started with a College Information night held on Wednesday, October 8, in the high school cafeteria. Mr. Bob Pecchia from the admissions office at the University of New England covered topics including: How to find the right college, what college reps look for in an application package, responsibilities of the student, and how the college process is completed at OOBHS. On Tuesday, October 14 all sophomores attended Sophomore Awareness day at Camp Ketcha in Scarborough. Students discussed a wide range of topics including anti-harassment and alcohol and drug education awareness. This program has been extremely informative and beneficial to our students.

In November, 6 students accompanied by Ms. Slack attended a conference at Keeley's Banquet Center sponsored by the Maine Attorney General's Office for Civil Rights Teams from the Greater Portland area. Our Civil Rights Team is currently comprised of 6 permanent members from grades 9 – 12, but the team promotes an open-door policy to anyone who wants to attend a meeting. Its purpose is to provide students an opportunity to discuss the importance of respecting people who may hold ideas or beliefs that are different from their own, and meetings are



designed to promote self-acceptance and the free flow of ideas. Discussions centered on issues of discrimination in schools and how to take action to address it.

Our math team, coached by Ms. Conley may be small in numbers, but is competitive in nature. We once again sponsored a math team that competed with twelve other high schools in Southern Maine. The team attended the first two meets out of a schedule of five. Our goal is to have more of our math students take advantage of this opportunity. This year we had 10 students participating in the Regional Fine Arts Program. Our students took part in the dance, theater, oil painting and writing programs. Each year we have had between 10 and 12 students take advantage of these opportunities. Since our last school board meeting, the high school was officially notified by the State's High School Assessment Program that we made Annual Yearly Progress in Reading and Mathematics. Last year we were placed on monitor in Reading. This status is determined through junior SAT testing as well as a new science augmentation that was piloted this year. Also in November, our High School Jazz Choir, along with Mrs. Andrade and Mr. Manduca, were invited to perform at the opening of the MPA Fall conference held at Holiday Inn by the Bay in Portland. They performed 3 pieces of music, and the students received a standing ovation and a letter of recognition from Phyllis Deringis, assistant director of the Maine Principals' Association.

The 8- member high school Student Assistance Team is working on a system and policies that aim to define a target population of students who may be slipping through the cracks and develop a plan to help those students overcome challenges interfering with their school success. The SAT attended a 2-day training in Portland with 5 other teams to begin the team building process. Ms. Inez Dudley, a member of the Maine Computer Crimes Unit presented a workshop on the Hazards of entering personal data on websites such as "Facebook" and MySpace".

On December 23, 37 of our seniors attended a Financial Seminar at the Captain's Galley. Saco Biddeford Savings Institute and a Phoenix Foundation Grant sponsored the seminar. Our seniors spent the day covering topics on establishing credit, planning financially for college and beyond, and being cognizant of marketing techniques.

In January, we hosted an Alumni Visiting Day on the 8th, in which 11 alumni from the class of 2008 came to the high schools for a pizza lunch while meeting with our current seniors and advising them on the ins and outs of college life.

We had 3 students take part in District 1 honors festival held at Noble H.S in January: Ben Lampert – trombone in band, Kate Nowicki-percussion in band and Lauren Murphy soprano on chorus.

On February 11, our musicians turned their attention to jazz. The jazz ensemble performed at the district jazz festival, qualifying for the state jazz festival. This was a significant step for a band with 13 freshmen on the roster. They also took part in the non-competitive MBDA jazz festival on Feb. 7 in Westbrook. February 26, Ms. Poisson took her accounting I students to the Glickman Library on USM campus to participate in the 3rd annual Maine Junior Achievement Titan Challenge in which teams of students are challenged to outperform other teams in this simulation of profit, sales, and market share. The following students attended: Zack Descoteaux, Tyler Smith, Dean Perrone, Megan McLaughlin, Conner Rague, and Matt Lauzon.

Senior Lauren Murphy has auditioned for and been given one of the lead roles in Biddeford City Theater production of the light opera Der Fledermaus. Junior Emma Brown was also awarded a role. On March 4, we hosted our annual transition night for all 9th graders and their parents. Well over 125 people were in attendance. Parents and students have the opportunity to learn about the variety of electives that are offered here at OOBHS. The Maine Principal's Association recognized one senior from every high school for outstanding academic achievement and citizenship at a banquet held on April 4. This year Ashley Johnson was recognized for this outstanding distinction. The Western Maine Conference Principals recognized two seniors from each of the 17 conference schools for their outstanding achievements at a Citizenship Awards Banquet that was held on May 5 at Verillo's Restaurant in Portland. This year's recipients from OOB were Anna Snow and Austin Rowell. On May 2, thirteen students were administered the AP U.S. History exam. The evening before, students from TA along with Ms. Slack and our 13 students met for a 3-hour study group review night. On May 15, the high school held its annual prom at Verillo's in Portland. We had 86 students attend. It was an enjoyable night for all. On May 20, the high school hosted its 4<sup>th</sup> annual Special Olympics for York and Cumberland County Special Olympians. Special Education Annual Report  
July 2008 – June 2009**

The Special Education Department of the Old Orchard Beach Schools is responsible for providing an appropriate education to all students with disabilities in accordance with Federal and State laws. The State of Maine defines the following disability categories to which schools must be responsive:

The school is responsible for developing an Individual Educational Plan (IEP) for each student with a disability. This plan is developed in an IEP team meeting attended by the student's parents, classroom teacher, special education teacher and a school administrator. Parental consent is required before a student can be evaluated or receive services through the special education department.

155 students received special education and supportive services in the Old Orchard Beach Schools. The special education teachers who provided services to our students are as follows:

In addition, speech and language therapy is provided to eligible students in grades K-12 by Deborah Maksut, Maureen Butler and Sandra Welzel. Lisa Kurtz and Molly Walrath provide occupational therapy. Amy Traska is our physical therapist. Dr. Linda Naaman, consulting psychologist who provides evaluations and consultation for our special education students.

A total of 5 students were placed in special programs outside of our public schools in order to receive appropriate special education programming.

The Old Orchard Beach Schools also provide Title I services to students in grades K-8 who could benefit from remediation in reading and in math. ## **OOB/Saco Adult & Community Education Program Areas**

GED program that includes pre-testing, instruction and testing for high school equivalency and through an adult high school diploma program that provides the opportunity for individuals to complete their graduation requirements.

Through classroom instruction or tutoring, this program area teaches the basic reading comprehensive and numeracy skills necessary to function in our literate community. Specific areas of literacy programming include English as a Second Language instruction and Family Literacy, an approach integrating both early childhood and adult education and parenting skills.

Dear Friends:

As we begin this New Year, I want to thank you for the opportunity to offer warm greetings to the people of Old Orchard Beach. We continue to face many historic challenges together as a nation, as a state, and as individual towns and cities. At this time when we consider where we have been, and look ahead to the year to come, I appreciate this opportunity to share with you my thoughts on some of my goals and priorities for 2010.

Unquestionably, our economy remains the foremost challenge facing us today. We are confronted by an economic crisis that has already lasted for more than two years. Indeed, the national unemployment rate has doubled to 10 percent since the onset of the recession in December 2007, while 7.2 million Americans have lost their jobs. Furthermore, Maine's unemployment rate has risen to 8 percent from 6.2 percent a year ago, while 56,200 of our fellow citizens are jobless. There is still much to be done, with some Maine counties still experiencing a rate over 10 percent.

Congress must embrace bipartisan initiatives that will provide effective solutions to address the critical issue of job creation, and promptly direct essential resources to those people and businesses facing unprecedented challenges and an uncertain future. I strongly support the extension of unemployment and nutrition assistance, in addition to pro-growth policies such as those to promote job-creating small business investment. At the same time, given the federal deficit for FY2009 was a staggering \$1.4 trillion, we must do more to pair the resources targeted to job creation with reductions in other areas. We have an obligation to ensure that each and every dollar we spend either creates jobs at a greater rate or protects displaced individuals at a lower cost than competing policies on the table. Moreover, to the degree that either tax or spending proposals Congress or the Administration seek to enact are more beneficial than proceeding to obligate funds still available in the American Recovery and Reinvestment Act, we should assess the possibility of redirecting those resources.

Here in Maine, I am working to help expand high-speed broadband access in northern, western, and Down East Maine, which could serve as a boon to businesses across the state. The plan, known as the "Three Ring Binder" project, which I supported, would build a 1,100-mile network stretching from the Saint John Valley to the coast and across to western Maine. The network would pass through 100 communities and serve 600 institutions, including the University of Maine, thanks to \$25.4 million in federal aid. This funding will foster entrepreneurial innovation, education, and job growth throughout the state.

As Ranking Member of the Senate Committee on Small Business and Entrepreneurship, I am working to swiftly enact legislation to increase small business loan limits to as high as \$5.5 million and extend through 2010 the fee eliminations and increased guarantee on those loans, measures that will otherwise expire under the Recovery Act. By extending the authorization to temporarily provide higher loan guarantees and eliminate fees for borrowers, I am continuing my effort to build upon what has worked well in the American Recovery and Reinvestment Act. Given the timely necessity of getting 15.3 million unemployed Americans back to work, it is critical that we expeditiously pass this bipartisan bill to help our nation's small businesses spur a sustained and job-filled recovery.

Dear Citizens of Old Orchard Beach:

In 2009, I began my third term in the United States Senate. I remain deeply honored by the trust the people of Maine have placed in me, and I appreciate this opportunity to report on some highlights of my recent work in the U.S. Senate.

A significant accomplishment came in December when the President signed transportation legislation that includes a provision I authored to create a one-year pilot project to allow trucks weighing up to 100,000 pounds to use federal highways in Maine. This is moving heavy trucks off Maine's secondary roads and out of our downtowns and onto our modern, multi-lane, controlled access highways for one year, during which time a study of the impact on safety, commerce and road wear-and-tear would be conducted. In addition, this change helps to level the economic playing field, as neighboring states already have this exemption.

My appointment in early 2009 to the powerful Appropriations Committee has allowed me to have greater influence on the funding of priorities that are important to Mainers, such as shipbuilding, health care, education, and transportation, while also giving me the ability to continue pressing for the elimination of wasteful spending that exacerbates our federal deficit.

As a member of the Senate Armed Services Committee, I continue to be an advocate for Bath Iron Works, the Portsmouth Naval Shipyard, the Maine Military Authority in Limestone, and the many other defense contractors and institutions in Maine that contribute so much to our national security. In August, I traveled to Iraq and Afghanistan and had the opportunity to meet with many service men and women from Maine. My conversations with them were the most important aspect of my trip to the region. Our troops are brave, dedicated, compassionate, and highly skilled. I will continue to work hard to ensure that they have the support their difficult missions require.

Perhaps the greatest challenge facing our nation continues to be the struggling economy, and among my highest priorities are getting our people back to work and our economy back on track. That is why in early 2009 I joined a bipartisan effort to pass the American Recovery and Reinvestment Act. The bill contains robust infrastructure spending, significant funding for state aid and education, and tax relief for low- and middle-income families and for small businesses. As a result of this bill, Maine is receiving approximately \$133 million for highway investments, more than \$50 million combined for the Clean Water and Drinking Water State Revolving Funds, and \$70.5 million for weatherization and energy efficiency projects.

Energy policy remains another great challenge: America's reliance on foreign oil harms our economy, our security, and our environment. Meeting the challenge of developing energy alternatives will provide great opportunities for Maine to build an economy for the future, with new industries and thousands of good jobs. This endeavor received a significant boost last October when the U.S. Department of Energy announced an \$8 million grant for deepwater offshore wind research at the University of Maine, and Congress also approved \$5 million I sponsored for the Maine Offshore Wind Initiative at UMaine. This January, the U.S. Department of Commerce announced a \$12.4 million laboratory construction grant for the University of Maine. I strongly advocated for these projects because, with some of the strongest winds in the nation off our coast and some of



the best engineers in the field, Maine has great potential as an ideal location for offshore wind projects and can take the lead in the development of clean, renewable, and affordable energy for America. Estimates are that development of five gigawatts of offshore wind in Maine – enough to power more than 1 million homes for a year – could attract \$20 billion of investment to our state and create more than 15,000 green energy jobs that would be sustained over 30 years.


Of course, this past year brought not just successes. A disappointment was the failure of Congress to produce bipartisan health care reform legislation that would contain soaring costs and provide more choices for struggling families and small businesses. I am deeply concerned about the nearly \$500 billion in Medicare cuts included in the bill.

It is fiscally irresponsible to raid Medicare – a program which already has long-term financing problems – to pay for a new entitlement program, particularly at a time when the number of Medicare beneficiaries is on the rise. The bill would saddle Maine's hospitals with some \$800 million in Medicare cuts over the next ten years, and could push one in five hospitals, nursing homes, and home health providers into the red. Ultimately, such cuts could jeopardize access to care for millions of our nation's seniors.

As the Ranking Member of the Senate Homeland Security Committee, I am committed to ensuring that our nation is as safe as possible and that government is better prepared to respond to disasters. The Christmas Day terrorist attempt to detonate explosives on an aircraft reminds us of the dangers we continue to confront. My homeland security priorities include further strengthening our defenses against terrorism and providing our first responders with the resources they need.

On March 19, 2009, I reached a personal milestone when I cast my 4,000th consecutive roll call vote, continuing a record of participating in every single roll call vote since I first came to the Senate in 1997. I am grateful for the opportunity to serve York and Maine in the United States Senate. These basic financial statements are the responsibility of the Town of Old Orchard Beach, Maine's management. Our responsibility is to express opinions on these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinions.
