#### CHECKS

RETRO - The Division of Administrative Services reports that they hope to issue all retroactive salary increase checks this week. It's possible, however, that some of the paperwork will not get done in time despite their best efforts. If you don't receive your retro check this week, and your co-workers do, please don't dismay; we haven't forgotten you. We'll get your long-awaited and well-deserved payment in the mail to you as soon as possible.

#### MEETING

ANNUAL - DOC supervisors will soon receive registration forms for the Annual Supervisors Meeting set for February 26-27 at the Augusta Civic Center. Safety, time management, legislation, budget, and agency mission and goals are on the agenda. Suggestions for other topics are requested; send them to Will Harris in Personnel. Entertainment is planned for the evening of the 26th.

#### PARK FORESTER

BAXTER - A cooperative working agreement signed today by the Baxter State Park Authority and the Maine Forest Service provides the full-time services of a forester for the Park's 28,000 acre Scientific Forestry Management Area. Under the agreement, the Baxter Park Authority will provide annual funding for the forester, necessary equipment and office space. The MFS will supervise the forester and pledges the cooperation of the Management & Utilization Division and related insect and disease detection/protection programs.

#### TRAIL MAPS

SNOWMOBILE - A map showing over 1,700 miles of Maine snowmobile trails is now available from the Snowmobile Division. The map includes the Interconnecting Trail System (ITS) on one side and four State-administered trail systems located in Greenville, Island Falls, Beddington and Mount Blue-Rangeley on the other side. Single copies of the map are free and "very popular" according to Frank Farren, Snowmobile Division Supervisor.

#### VOUCHERS

TRAVEL - Effective January 8, all travel expense vouchers submitted must have the traveler's social security number listed. Vouchers received without the travelers SS# will not be paid so to avoid delay, make sure you put the number on when submitting.

#### INSURANCE REFUNDS

HEALTH - A recent arbitrator's ruling has directed the State to pay 50% of the total dependent health insurance coverage for each employee. This means that the State will now pay the total dependent coverage for those employees with split contracts. Furthermore, the arbitrator ruled that the State would refund deductions made on dependent coverage from employees with split contracts. The deductions for dependents of those of you on split contracts ceased on the last pay period. The refunds are currently being processed by the office of the Employee Health Insurance Program. If you have questions regarding this change, you should direct your inquiries to that office at 289-3626.

## SCHOLARSHIP - For several years, the Maine Forest Service has provided money for the James C. Durham Scholarship Award which is given to a forestry student at the University of Maine at Orono. Any DOC employee who has a child currently enrolled in Forestry at UMO is eligible. Contact Bob Umberger for details at 289-3897. Funds for the scholarship are derived from timber sales from a 100-acre Northport woodlot established for the support of the scholarship by the heirs of James C. Durham. The Maine Forest Service manages the woodlot.

Joe has been a member for 18 years...Glenn Angell, LURC, has been elected to chair the Land Use Planning and Design Working Group of the New England Society of American Foresters...On January 17, Walter Anderson, MGS, and Judy Kany appeared on WCBB's "Statewide" to discuss low-level radioactive waste disposal in Maine... Joe Kelley, Marine Geologist, received a Sea Grant to study Casco, Sheepscot, and Machias Bay in conjunction with other University of Maine at Orono personnel.

#### Greg Foster, Public Lands, has begun a series of slide STUDY TOUR -SLIDE SHOWS presentations on the study tour of Scandinavia which he participated in this past Fall. Greq was chosen to take part in the Society of American Foresters-sponsored forest management study tour by an anonymous fellow-SAF member, who offered to pay $\frac{1}{2}$ the base cost of the trip.
