**goals:** To educate the public about the varied fisheries associated with the Gulf of Maine and its shoreline.

current programs: Various teacher recertification courses are being taught in conjunction with the University of Maine, and curriculum materials are being developed for elementary and middle school teachers on the subject of marine science. Current educational programs include: angler education clinic – a mini-sport fishing clinic offered to those interested in participating in the rod loaner program; coastal habitat tour – a guided tour around McKown Point to heighten public awareness of the marine environment, the human impact upon it, and the need for stewardship; research laboratory tour – a guided tour through the research facility to educate the public about the functions of the agency; and hands-on presentations around the lobster trap, the shark tank, and the touch tanks.

## The Maine Coastal Program: A Balanced Approach to Managing the Coast

Maine comprises a remarkable geographic area. The state has a variety of landscapes and ecosystems unparalleled in the Eastern United States. To many residents and visitors, the State of Maine's identity is most closely linked to its coastal environment. More than any natural feature, it defines the character and image of Maine.

Each year over six million people visit the Maine coast to enjoy its waters, wildlife, and landscapes. Residents are also compelled by its allure: 43 percent of the state's population lives in the coastal region, which comprises only 12 percent of the land area. With this remarkable resource comes an obligation of stewardship. Coastal resources must be protected and conserved, yet present and future residents must be able to thrive economically. A balance is needed between human uses and the protection of the very resources that make the area so appealing. The goals of the Maine Coastal Program and its many partners are to help achieve that balance.

For generations much of the nation's coast was resilient to human pressures. But then came the post-war and baby-boomer generations. Populations grew. Coastal areas had to accommodate more people -- and more uses. Coastal land and waters suffered from pollution and habitat destruction. Traditional public access arrangements changed.

Congress answered these threats in 1972 with the passage of the Coastal Zone Management Act. The law, administered by the National Oceanic and Atmospheric Administration, authorizes funding for state coastal programs around the country to work in partnership with the federal government to balance conservation of the coastal environment with human demands and activities.

Established in 1978 and administered by the Maine State Planning Office, Maine's Coastal Program is a partnership among local, regional, and state agencies. It also collaborates with many private organizations, such as local land trusts and economic development groups. Through this networked program, no one agency or department is responsible for the entire coast. Rather, all partners help ensure its proper management. The result of this balanced approach is a healthier coast -- and a better future for communities.
