Trumpers revel at local rally

Honkin' good time

BUCKSPORT - The truly faith-filled came hours early, anxious to chat with others who support President Donald J. Trump.

Soon, the Labor Day gathering was joined by hundreds more, including almost 100 motorcycles bearing half again as many Trump supporters.

Thirty small craft, each loaded with Trump backers and festooned with Trump flags and stickers arrived by ones and twos in Bucksport Bay.

The boaters were eager to take their messages up the Penobscot to Brewer and Bangor and then on to Hampden for a full-throated Trump rally.

Still more trucks and cars, also ablaze with political stickers and Trump flags, moved up and down Bucksport's main street. Bursts of horns signaled who was there to support the president. Others simply drove by unimpeded, keeping their political leanings to themselves.

There was amplified country music, but no political speechifying, just occasional shouted bursts of enthusiasm for Trump.

No din, clatter, or even whimper on town's ballot

BUCKSPORT - A local race for a seat on the Town Council last week evaporated like the autumn morning dew.

Former Mayor David Keene, who took out nomination papers last week, just as quickly, changed his mind and didn't return them.

While his backers encouraged him to make the run, Keene apparently decided not to return the paperwork by the deadline for getting on the municipal ballot, the end of the business day last Thursday (9/3).

That leaves two incumbent councilors - Mayor Peter L. Stewart and Mark Eastman - vying for re-election to the two open seats on the Nov. 3 ballot.

The deadline also passed with but two candidates - Thomas Foster and his sister-in-

law, Abigail Foster - seeking the two of the Bucksport openings on the eight-member RSU 25 School Board. Foster is the chair of the board, while his sister-in-law is seeking the seat that's just been vacated by Jennifer Therrien. Therrien's term was to expire in January, but Abigail Foster could be sworn in upon being elected.

In an interview yesterday (9/9), Keene, 70, said he decided to run if Eastman didn't return his nomination papers. He withdrew when Eastman filed.

"I've done my duty," said Keene, who served several terms and often was the top vote-getter. He plans to remain active in assisting when requested, as he did recently in finding a low-cost alternative to spending up to \$1 million on a new swimming pool.

Cemetery issue rekindles

BUCKSPORT - A deal to sell a house at 917 River Road fell through last year after it was alleged the owner's heirs failed to disclose that an ancient cemetery was on the property.

The pending sale resulted in reactivating the town's Cemetery Committee to find out what the community's legal obligation might be for maintaining the long-neglected Old Methodist Church Burial Ground.

A member of that panel now is questioning the role of Town Councilor Mark Eastman, in the latest bid to sell the property. Eastman also is a member of the municipal cemetery group.

In the 1980s the then-owner convinced the then-town manager to have the town crew remove many of the headstones and bury the rest on the site. This was done

without relocating any remains, including those of Revolutionary War-era veterans.

The property now is listed by Eastman's Ocean's Edge Realty. In July, Ocean's Edge offered the residence and lot for \$200,000. The property now is under contract and a closing is tnear.

According to Kerry Zimmerman of Holden, a member of the local cemetery panel, the real estate disclosure states the, "cemetery was relocated." She alleges Eastman knows that's not true.

However Town Manager Susan M. Lessard said all the parties know all of the facts. That includes knowing the town stands ready to fence and perform minimal, twice-a-year-maintenance at the graveyard.

New spending limit asked

BUCKSPORT - The Town Council tonight (9/10) will hold a public hearing on its request to the public that it be allowed to spend up to \$300,000 without seeking voter approval. That's \$50,000 more than the current limit. The hearing will trigger a public referendum vote on the idea Nov. 3.

The councilors also are expected to enter into a new

three-year agreement to allow the former municipal sewage sludge site to be mowed in return for the mulch hay the fields produces. (A Frankfort man has asked to renew his arrangement.).

The hay harvesting issue has sparked a renewed request that the town protect two old but long-abandoned cemeteries said to exist under the site.

Power out? Osprey did it!

BUCKSPORT - The power went out for a couple of hours early Friday (9/4).

It seems the wind blew a branch out of an osprey nest at the rear of the paper mill on River Road. The branch shorted out the high tension power line. Darkness ensued.

OBITUARY

John Linwood Fickett, 1933 - 2020

BUCKSPORT — John Linwood Fickett died peacefully at his home on Saturday, Sept. 5, 2020.

He was born on April 4, 1933, the second of five children born to Jeanette Fossett Fickett Robinson and Erven Fickett. He grew up in Richmond, and attended local schools.

John forfeited his education and left school early to enter the workforce to support his mother and siblings after their father abandoned the family. John joined the U.S. Air Force after his mother married Maurice (Robie) Robinson in 1950, and he no longer was needed to support the family.

A local girl, Helen Friend, captured John's heart and was swept off her feet when John returned to Richmond and proposed John spirited her away to Shreveport, LA, where they were married in 1953. They welcomed their first child, Andrew, named for her father, in 1956. Helen stayed at home to raise the family while John received advanced training in electrical and mechanical maintenance, resulting in a transfer to Grenier Field in Manchester, NH in 1957.

John and Helen welcomed their second son, Donald, on March 11, 1960. John worked as an Instrument technician at the New Hampshire site location until 1960 when the base closed, and he was honorably discharged from the U.S. Air Force on May 18, 1960.

Now with two young children in tow, John and Helen moved to North Anson, Maine where John worked with Helen's father, Andrew Friend, clearing a large woodlot. He then took a position with the Arthur Redman Lumber Co. which manufactured gun stocks for the US military. He was a steam plant operator. The family enjoyed living back in Maine, and joyfully welcomed their daughter, Carole Anne. Tragedy befell the young family when Carole died in infancy of congenital heart and lung defects.

The family left North Anson in 1965 when John took a position in at the Portsmouth Naval Shipyard as an Instrument and power control systems technician. Eager to return to Maine, the family moved to Bucksport in 1969 when John accepted a position with the St. Regis Paper Co. John stayed with St. Regis (later Champion, International Paper, and Verso) Paper for 22 years, retiring as an instrument superintendent and mill energy coordinator, where among many other accomplishments, he was instrumental in converting systems to computer controlled processes, and reducing the mill's energy consumption by 25 percent.

John's sons, Andrew and Donald, followed him in careers in the papermaking industry at St. Regis, Donald continuing until the mill was permanently closed in 2014.

John, Helen, Andy and Donald enjoyed life in Maine. The entire family enjoyed fishing adventures, snowmobiling, camping and motorcycling together. Yes, Helen drove a motorcycle! She and John would take off for places unknown, each with a son riding as a passenger. The boys eventually had their own motorcycles, and the family of four would take off down the road, a sight to behold!

The recreational passion the family enjoyed turned to tragedy when Andrew was killed in a motorcycle accident in 1978. The strength of John and Helen's commitment to, and love for each other sustained them after the deaths of their two children.

John had more to do. He went to tractor trailer driving school at Cole's Training Institute, drove for Cole's and Sunbury until he purchased three tractors and became an owner-operator, leasing his vehicles to Allen's Transfer and Storage of Augusta, Maine.

Helen accompanied John on a few long haul trips, but the South was not to her liking. Helen was content to prepare all of John's meals for his journey, along with clothing and other necessities. John said Helen was, "an outstanding wife".

John sold his trucks after six years, bought a motorhome and travelled the country with Helen. Oh, what fun they had! Their travels were planned around winter stops in Zephyrhills, FL, where they would spend the winter close to John's sister, Cloe.

John and Helen spent their remaining years in Bucksport, close to their son, Donald, who checked in on them most every day. John remained very independent, venturing out on his motorcycle with Don until he was 85 years old. Tragically, in January of this year, Helen died unexpectedly of a cerebral hemorrhage.

John was lost after 67 years of marriage, Helen had been providing assistance with daily living as John's health had begun to fail. Donald managed the monumental task of dealing with his mother's unexpected illness and tragic death while simultaneously caring for his father by moving into John's home and becoming his caregiver. Don is grateful for the last nine months he has spent with his father, sitting on the back porch sharing stories, enjoying meals together, and taking occasional trips in the car with his faithful dog, Susie.

John passed peacefully at his home, as he wished, on Saturday, Sept. 5, 2020, with Don's loving care.

John will be dearly missed by his son, Donald, his devoted dog Susie; and his extended family.

John was predeceased by his wife Helen; son Andrew; and daughter Carole Anne; as well as his parents, his stepfather, Maurice Robinson, Helen's parents Andrew and Justina Friend, brother in law Arthur Friend. He also was predeceased by his brothers Albert and Bernard; and sister Cloe Curtis. He is survived by his sister, Charlene Perkins Carr of Bowdoinham.

Don would like to express gratitude to the Bucksport Ambulance crew; the team from Northern Light Hospice who helped him through this difficult time as singular caregiver; and his cousin, Kelly.

John had a long and fulfilling life with Helen, a wonderful family, and lived life to the fullest for 87 years.

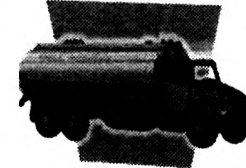

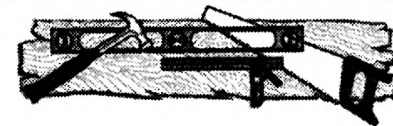

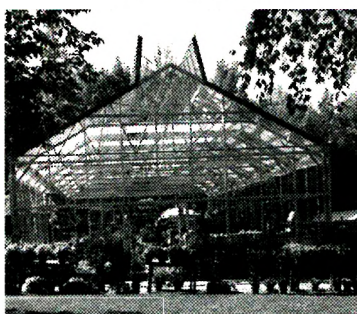

The town manager of Bucksport has been in contact with the owners of the property and the agent for the buyers to seek permission for ground penetrating radar to be used to determine where the burial sites are. A similar process was used by the town to condemn off an area around a cemetery on the grounds of the town's sewerage treatment plant on U.S. Route 1.

However, Lessard said the owners denied the town the legal access it will need to maintain the older Methodist cemetery.

Zimmerman contends the buyers have a clause in their contract that says nothing can be disturbed on the property, and it must be sold exactly as it was when it was placed under contract.

The town's lawyer has suggested the town do nothing now, and deal with the new owners later. Zimmerman believes the law is clear that nobody can deny public access to an ancient cemetery.

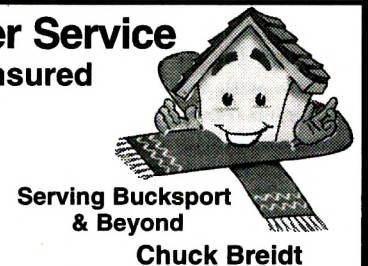

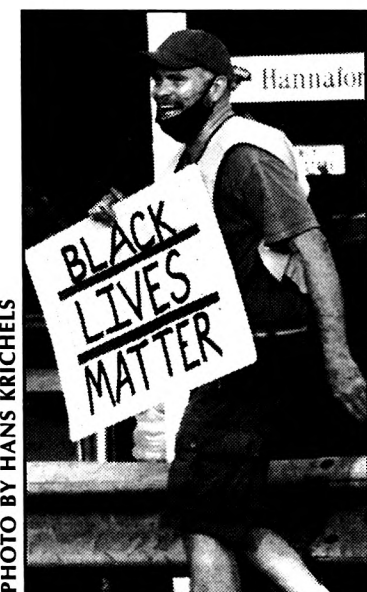

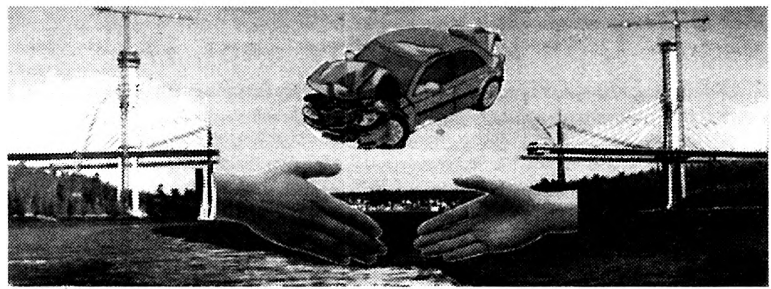

Excitement ran high throughout the school system, for the schools have been closed to in-class learning since early last spring.

The students seemed especially pleased to see their classmates once again, and both teachers and students seemed anxious to settle back into the familiar routine.

The RSU schools today (9/10) were to resume remote learning sessions for those who have selected that option.

Here's the opening day census:

- Bucksport High School: 358 students, with 51 of those choosing to be

full-time remote-learners: 308 with 71 selecting the full time remote learning option.

- Miles Lane School: 288 with 70 utilizing the full-time remote learning via computer choice.

- G. H. Jewett School: 128 with 24 listed as full-time remote learners.

All in all, the opening day RSU 25 enrollment totalled 1,081 students.

Boothby offered rave reviews to the staff, the parents and the students for the comparatively smooth transition to all of the COVID-19 health and safety guidelines.

A couple furlled their national flag, one of dozens and a man in a motorized wheelchair reclaimed his seat in a waiting van. There, on the back of the chair, was a single red, white and blue sticker proclaiming a single word: "Trump".

We always try to make sure our kids have new pencils, notebooks and sneakers for back to school. Yet, many of us don't have a will appointing a guardian for them if we die unexpectedly.
