COMPLAINT FOR CIVIL VIOLATIONS

INTRODUCTION

 This is an action to obtain civil penalties for violations of the Motor Vehicle Examination and Inspection Law pursuant to 29 M.R.S.A. §§ 2501-2525 (1983).

JURISDICTION AND PARTIES

2. This Court has jurisdiction over this action pursuant to 17-A M.R.S.A. § 9(3) (1983).

3. Plaintiff, STATE OF MAINE, a sovereign state, commences this action pursuant to 17-A M.R.S.A. § 4(2) (1983) and 29 M.R.S.A. §§ 2507 and 2507-A (Supp. 1984), by and through the Attorney General.

4. Defendant, GOVE TOYOTA, INC., a Maine corporation, is licensed by the State of Maine as a new and used car dealer. Gove Toyota, Inc.'s principal place of business is on Western Avenue in the City of Augusta, Kennebec County, Maine.

COUNT I

(Violation of Maine's Examination and Inspection Law - Sale Of A Motor Vehicle Which Did Not Meet Inspection Standards)

5. On or about October 8, 1984, in the City of Augusta, Kennebec County, Maine, the above-named Defendant, a dealer of used motor vehicles, sold or transferred a certain used motor vehicle to wit: a 1978 Toyota Landcruiser, serial number FJ40259361, which vehicle was owned or controlled by Defendant, to Van D. or Michelle A. Vanden Bosch for operation upon the highways when said motor vehicle, in fact, failed to meet the inspection standards required by 29 M.R.S.A. § 2503 (Supp. 1984) and the rules and regulations promulgated thereunder and did not have displayed thereon a valid certificate of inspection issued during the last 30 days prior to the date of sale or transfer.

6. Defendant's conduct as described in the preceding paragraph constitutes a violation of 29 M.R.S.A. § 2507-A (Supp. 1984).

RELIEF REQUESTED

WHEREFORE, Plaintiff respectfully requests that this Court:

1. Declare that Defendant has violated 29 M.R.S.A. § 2507-A (Supp. 1984) by selling or transferring a used motor vehicle for operation upon the highways when said motor vehicle failed to have a current valid inspection sticker affixed to it and failed to meet the inspection standards required by 29 M.R.S.A. § 2503 (Supp. 1984).

2. Order the Defendant to pay civil penalties pursuant to 29 M.R.S.A. § 2507-A(3) (Supp. 1984) for violating 29 M.R.S.A. § 2507-A(1) (Supp. 1984).

3. Any other relief the Court deems necessary and proper. DATED:

3. Pursuant to 29 M.R.S.A. § 2507-A(3) (Supp. 1984), Defendant shall pay to the State of Maine civil penalties in the amount of \$250.00.
