Original Title: An Act To Make Maine Safer by Collecting DNA from Those Convicted of Felonies. New Title: An Act To Require the Collection of DNA from Persons Who Committed Felonies Prior to 1996 Who Then Reoffend by Committing Offenses for Which They Would Not Otherwise Have To Submit to a DNA Test. Presented by Representative MARLEY of Portland. Referred to Joint Standing Committee on Criminal Justice and Public Safety. Public Hearing 02/26/07. Majority (OTP-AM) Accepted 06/01/07. Amended by: CA (Changed Title) H-368. Final Disposition: Enacted, Signed 06/14/07, PUBLIC LAWS, Chapter 294.
