Dear Sir:

Some time ago a local selectman came to our house and told us that if either my wife or I had parents, either of which was born in a foreign country we would have to register our names under the alien registration. We both did, even though we did not regard ourselves as aliens. Shortly thereafter my wife wrote you about the matter and you replied that the selectman erred in his requirement. She is a citizen of the United States and so am I.

In my own case, I was born in Bensenville, Illinois in 1911. Enclosed herewith is my birth certificate, which I am sending you so that you may read it and know that I am not an alien. My father was born in Alsace-Lorraine, while my mother was born in this country. My father has been a citizen of the United States for many years.

Will you please be so kind as to correct your records and cross off my name from the list of aliens, since I am a citizen? I shall be most grateful to you for your attention to this matter.
