**WHISTLEBLOWERS' PROTECTION ACT**  
**Protection of Employees Who Report or Refuse to Commit Illegal Acts**



All employers are required by Title 26 MRSA, Section 839 to prominently post this notice in their places of business so that employees are informed of their protections and obligations under this subchapter. Failure to post this notice is a civil violation which could result in a fine.

**SUMMARY OF THE "WHISTLEBLOWERS' PROTECTION ACT"**

(This is a brief summary in plain language and should not be taken as the exact law. The actual law can be found in Title 26 MRSA, Chapter 7, Subchapter V-B)

It is illegal for your boss to fire, threaten or treat you differently because:

1. You reported a violation of a law;
2. You reported something that risks someone's health or safety;
3. You have refused to do something that will endanger your life or someone else's life and you have asked your employer to correct it; or
4. You have been involved in an investigation or hearing held by the government.

You are protected by this law **ONLY** if:

1. You tell your boss about the problem and allow a reasonable time for it to be corrected; or
2. You have good reason to believe that your boss will not correct the problem.

To report a violation, unsafe condition or practice or an illegal act in your workplace, contact:
