## HOMEMAVERS' COLUMN.

Recipes.

### DRAINED LIVER WITH PEPPERS.

Lay some strips of fat fresh pork in a small earthenware pot and place over the fire until they begin to brown; add half an onion, sliced, two ripe peppers, also sliced (rejecting the cores), and two pounds of fresh pig's liver deeply gashed and larded on top with more strips of pork. Dredge thickly with flour and fry slowly for ten minutes, turning the meat once. Scrape half a dozen carrots and cut in strips lengthwise; place these around the liver with a handful of minced parsley or celery tops and salt and sweet herbs for seasoning; lastly add one cup of boiling water and half a glass of currant jelly; cover closely and bake in a very moderate oven for two and one-half hours. This is a most savory and satisfying dish, made from an inexpensive piece of meat.

### APPLE BISCUIT.

To one pint of light bread sponge add one-quarter cup of molasses, one tablespoon of lard and graham or whole wheat flour to make a stiff dough. Knead thoroughly, and finally work in a large cup of chopped apple (greenings or russets), cut in bits as large as the end of your finger. Shape in muffin pans, sprinkle with brown sugar and let them stand until very light before baking. Good either warm or cold.

### DICKED LIVER.

One pound of calves or lamb's liver, one-half pound of bacon; cover with water and simmer very gently for two hours, or until thoroughly tender. Drain and cut in small cubes, return them to the fire and cook for ten minutes, seasoning with salt and pepper and tossing frequently, that they may brown lightly and evenly. Serve on a plate of hot buttered toast, moistened with the liquor in which the meat was cooked. Chill or Worcestershire sauce should be offered with this savory supper dish.

### TOMATO PUMPKIN.

One pint of canned tomatoes, one cup of mashed potatoes, one cup of chicken or veal stock; simmer for fifteen minutes, thickening with one tablespoon of four season highly strained through a vegetable sieve and serve with small hard crackers buttered and browned in a cup of cold split peas. Instead of potatoes, make a good variation.

### MISSOURI GINGERBREAD.

Bake soft gingerbread in very thin sheets, and when done, place with brown sugar and butter. This is a lump of butter until it "chairs."

### CHERRY PUDDING.

Cream one cup of sugar with three teaspoons of butter. Add slowly one cup of sweet milk, two cups of flour sifted with two teaspoons of cream of tartar and one teaspoon of soda. Add one and one-half cups of cranberries and bake one-half hour in a moderate oven. Serve very warm.

### CHESTNUTS AND PRUNES.

Do many housewives realize what a delicious result results when Spanish chestnuts are added to the homely broken dish of stewed prunes? This is a foreign confection worthy the attention of Yankee cooks. We use it as a dessert when other ideas fail, rather than merrily, as prunes are served. Wash and soak prunes overnight as usual. Boil chestnuts twenty minutes after cutting a "Y" in each shell. Peel, removing shell and the disagreeable skin. Then stew with the prunes. Serve cold, or at least cool, with plain cake.

### AUNT LEBBE'S PUDDING.

Pare, core and quarter tart cooking apples, using enough to cover the bottom of a buttered pudding dish. Make a sponge cake batter according to any favorite formula and pour over the pieces of apple. Bake in a moderate oven until the fruit is soft enough to be easily pierced by a straw. Serve with hard sauce, Vanilla, lemon or apple will do.

### HARLEQUIN PUDDING.

Three tablespoons of melted butter, mixed with warm water and a cup of sugar. Add one cup of milk gradually, the yolk of one egg which has been beaten until thick, two cups of flour which has been sifted three times through a fine sieve, and one cup of baking powder, and either one cup of cranberries or three-quarters of a cup of raisins cut out in half-pinch pieces, or two cups of sliced nuts, or three-quarters of a cup of chopped nuts, or one cup of raisins. Flour the dish, and pour the mixture into it. Bake in a moderate oven for one hour. To the bottom, add lastly flour in the stiffly beaten white of one egg. Bake in twenty-five minutes in a moderate oven. This pudding is very good with a half-cup of maple syrup and one cup of whipping cream and beat until stiff. Packed in ice and salt three hours, this sauce makes a delicious moussé.

### CHILE CON CARNE.

Soak one pint of dried lima beans overnight, and in the morning arrange in the bean pot with one pound of salt lean beef, two ounces of sweet fat, a red pepper cut in rings and half of an onion, shaved. Cover with water, season with salt and a half teaspoon of mustard, and cook for three or four hours. This is a dish adapted from Mexican cookery.

### BACON AND PEAS.

Is an equally savory change from the traditional "peas and beans." Soak one pint of yellow split peas overnight; in the morning pour off the water and add fresh, with one pound of salt, a half teaspoon of mustard, and a half cup of water. Cook for three or four hours. This is a dish adapted from Mexican cookery.

### SPICED APPLE JELLY.

Cook tart, under-ripe red apples in the usual way and to every three quarts of juice add one pint of vinegar, three quarts of sugar (four cups), and three time ounces of mixed whole spices tied up in this muslin. Finish as usual.

### CARROTS WITH GREEN SAUCE.

Soak one cup of whole green peas (dried) overnight; drain, cover with fresh water and boil until perfectly tender. Wash, scrape and coarsely enough carrots to make one pint, boil in salted water for forty minutes. Drain, season with a little salt, and mix with the peas. Pour the sauce, which should be as thick as a puree, around the carrots and send smoking to table. Fresh green peas and sweet carrots may be used for the same combination.—Good House-keeping.

### Change in Gloves.
