

LIBRARY NEW YORK Stin Maine Increased by Over 10,000 Between the Third Quarters of 1996 and 1997



Reported employment¹ increased by 10,162 statewide between the third quarters of 1996 and 1997. Increases ranged from 112 in Lincoln County to 4,898 in Cumberland County. Of the three counties registering losses, declines ranged from 86 in Piscataquis County to 511 in Sagadahoc County.

¹Employment reported by employers subject to the Maine Employment Security Law. Also included is reported employment of federal government installations within the state. The primary exclusion from this employment count is the self-employed. Unemployment Falls in March


State Labor Commissioner Valerie Landry announced that Maine's seasonally-adjusted unemployment rate fell to 4.3 percent in March from 4.6 percent in February.


"Seasonally-adjusted unemployment fell by 2,400 between February and March," said Commissioner Landry. "Unemployment was also down from March 1997, with an over-the-year drop in unemployment of 8,200 and a decline in the unemployment rate from 5.5 percent to 4.3 percent."

Over the past year seasonally-adjusted nonfarm wage and salary jobs rose by 11,800, with the strongest growth in services, retail trade, and finance, insurance, and real estate. Manufacturing and government registered slight declines.

Other New England states which have reported their seasonally-adjusted March unemployment rates include New Hampshire, 2.9 percent, and Vermont, 3.4 percent. The adjusted national rate for March was 4.7 percent.

Maine's not-seasonally-adjusted unemployment rate was 5.5 percent in March, down from 6.0 percent in February and from 6.7 percent in March 1997. The unadjusted national rate was 5.0 percent in March, unchanged from February and down from 5.5 percent in March 1997. Not-






seasonally-adjusted March unemployment rates for Maine counties ranged from 3.0 percent in Cumberland County to 13.5 percent in Washington County.

Not-seasonally adjusted nonfarm wage and salary jobs rose by 1,100 from February to March, Employment in services increased by 800, with several services industries recording small gains. Finance, insurance, and real estate registered a gain of 500. Retail trade jobs rose by 300, as seasonal gains in eating and drinking places, food stores, and automotive dealers were partially offset by a loss of 600 in the other retail trade category. Manufacturing jobs fell by 600, with small



losses recorded in leather and leather products, food and kindred products, and lumber and wood products.

Over the year, not-seasonally-adjusted nonfarm wage and salary jobs rose by 11,800. Services industries added 6,200, with business, social, health, and educational services all recording gains. Retail trade increased by 2,200, with gains in other retail trade, food stores, and automotive sales and services. Finance, insurance, and real estate rose by 2,100.


