LD 337 / SP0132

AN ACT to Amend the Municipal Employees Labor Relations Law. Presented by Sen. Bustin of Kennebec; Co-sponsored by Rep. Clark of Millinocket. Labor Hearing 03/11/87. Majority OTP-ND SP0557 / LD 1667 Accepted by Senate and Engrossed; Minority ONTP Accepted by House. Senate - Insisted on Engrossing; House - Adhered to ONTP. Died Between Houses.
