Estes of York; Co-sponsored by Rep. Crowley of Stockton Springs, and Rep. Norton of Winthrop. Education Hearing 05/15/91. OTP-AM Accepted 06/10/91. Amended by: CA (Changed Title) S-308, SB/CA S-426. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Final Disposition: Enacted, Approved 07/30/91, PUBLIC LAWS, Chapter 612.
