An Act Concerning Indian Territory under the Maine Indian Claims Settlement Laws. Presented by Rep. Bailey of Township 27; Co-sponsored by Sen. Ludwig of Aroostook, Sen. Vose of Washington, and Rep. Townsend of Eastport. Judiciary Hearing 05/17/91. Majority OTP-AM Accepted 03/18/92 (Minority ONTP). Amended by: CA H-1125. Enacted. Final Disposition: Veto Sustained 10/06/92.
