An Act Authorizing the Commissioner of Inland Fisheries and Wildlife to Award 5 Moose Hunting Permits through Public Auction to Fund Youth Conservation Education Programs. (GOVERNOR'S BILL). Public Hearing 02/24/94. Majority OTP-AM Accepted 03/22/94. Amended by: CA S-437. Final Disposition: Enacted, Signed 03/31/94, PUBLIC LAWS, Chapter 577.
