LD 1978 / HP1449

An Act Authorizing the Kennebec County Commissioners to Issue Bonds in the Amount of \$1,500,000 for Renovation of the County Court House in Augusta. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.)
