

charged with the crime of stealing, taking and
carrying away sundry goods and chat-
tels, belonging to *Charles O. Clarke*
and *Nathanil G. Marshall*, of said

a fugitive from the justice of this State, and supposed
to be within the limits of the

Commonwealth of Massachusetts.

I DO HEREBY, BY VIRTUE OF THE AUTHORITY IN ME VESTED,
appoint you the said *Nathanil G. Marshall*,
Agent, to receive the said *Samuel B. Auston*,
from the Executive of said
Commonwealth of Massachusetts, and him to
bring within this State, that he may be dealt with as
to law and justice may appertain.

IN TESTIMONY WHEREOF, I have caused the seal of this State to be
hereunto affixed, at AUGUSTA, this *twenty third* day of
May in the year of our Lord one thousand
eight hundred and *forty two* and of the Independence of
the United States of America, the *sixty sixth*.
