LD 2333 / HP1656

An Act Authorizing an Advisory Referendum on Whether the Congress of the United States Should Establish a National Health Insurance Program. Presented by Rep. Paradis of Augusta; Co-sponsored by Rep. Martin of Eagle Lake, Sen. McCormick of Kennebec, and Rep. Rydell of Brunswick. Banking & Insurance Hearing 02/25/92. Majority OTP-AM Accepted 03/05/92 (Minority ONTP). Amended by: CA H-1015. Enacted in House; Indefinitely Postponed in Senate. House - Adhered to Enactment: Senate - Adhered to Indefinite Postponement. Final Disposition: Died Between Houses 03/17/92.
