AN ACT to Clarify the Sales Tax Exemption on Scheduled Airlines. Presented by Rep. Cashman of Old Town; Co-sponsored by Sen. Twitchell of Oxford, Rep. Jackson of Harrison, and Rep. Zirnkilton of Mount Desert. Taxation Hearing 05/03/88. Majority OTP Accepted 05/04/88 (Minority ONTP). Amended by: SB S-549. Enacted, Approved 05/11/88, PUBLIC LAWS, Chapter 865.
