And now the Commissioners on examination of said account, do find the charges for support of prisoners in said Gaol, unable to support themselves, confined by due process of law, on charge, or conviction of crimes or offences against the State, from the 6th day of April, 1831, to the 6th day of September 1831 inclusive, amount to the sum of, thirty six dollars, and ninety five cents, and that said Prisoners have not been able to pay any part thereof: Whereupon it is ordered that the same be allowed and paid, out of the County Treasury, and charged to the State, agreeably to the Statute, in such case provided
