And now the Court, on the examination of the within account, find the charges for support of prisoners in gaol, unable to support themselves, confined by due process of law on charge or conviction of crimes or offences against the State, from the 12th day of ^{October 1831} ~~May~~ to Jan. 10th ¹⁸³² inclusive amount to the sum of one hundred & eleven dollars and fourteen cents, & that said prisoners have not been able to pay any part thereof - Whereupon it is ordered that the same be allowed & paid out of the County Treasury & charged to the State, agreeable to the Statute in such case provided -
