Court, and the Court upon examination of the same finding
the charges for support of prisoners in Gaol unable to support
^{themselves,} confined by due process of law on charges or conviction of
crimes or offences against the State from said 20th of Nov to
the 23^d of April inclusive, amount to the sum of Fifty six
dollar & twenty eight-cents and that the said prisoners have not
been able to pay any part thereof, Order, that the same be allowed
and paid out of the County Treasury, and charged to the State
agreeably to the Statute in such case provided.
