The within account being presented, the Court on examination of the same do find the charges for support of prisoners in goal, unable to support themselves, confined by the process of Law on charge or conviction of Crimes or Offenses against the State from the 14th day of May to the 5th day of June 1834 inclusive amount to the sum of twenty two Dollars and that said prisoners have not been able to pay any part thereof; Whereupon It is ordered by the Court that the same be paid out of the County Treasury & charged to the State agreeably to the Statute in such case provided.
