I Albert Smith of Portland in the County of
Cumberland on oath depose & say that some
time last March I took the depositions of
five or six witnesses of good character for
truth & veracity, & of respectable standing
in society viz Daniel Walker Josiah Sam-
son, James Inish, of Portland & Edward
Cobb and Joseph Moxley of Westbrook -
who testified, that from the twenty sixth
day of November 1835, the beef in Snow
bridges pack house in Portland, was
so badly frozen, that ^{it} could not be
properly cut & packed - that Daniel
Winstow the Inspector, to their knowledge
used his best endeavours to have the
same packed before frozen - that
he protested to the owners of the beef
against said pack house, as unfit for
packing - that said house was open
leaky & cold - & that S Winstow con-
tinue the owners of the beef against leaving

their keep there - That said Winslow
always had as many ^{workmen} as could work
in packing during that fall - I was
always attentive, vigilant, & care-
ful in the discharge of his duties -
as inspector, as well as impartial

I further say that said deponents
were men who are acquainted
with the business either as Cutters
or packers - or Coopers -

I further say that said Irish & Samson
testified that in the fall of 1834 Mess
Johnson & Butler, who drove a large
lot of Cattle to Portland Market, I believe
150 or more head - stated that they were
perfectly satisfied with Mr Winslow's in-
spection, & that they believed he had done
impartial justice
