## HEALTH OFFICER

---

To the Selectmen and Citizens at Old Orchard, Maine:

The Health Officer submits his Annual Report:

It is pleasing to be able to report that Old Orchard continues to maintain such a high standing of healthfulness.

Our locality and environment constitute a natural sanitarium, and we, as a community, should be united in our efforts to remove any conditions that will detract from Nature's generous provision for our health and prosperity.

In order to keep up this high standard, we must have a liberal appropriation for our sanitary department. Numerous complaints this year relative to nuisances have been investigated, and all such have been abated, so far as possible.

On account of the merchants' opening their places of business early and the incoming summer visitors and the large accumulations of rubbish during the autumn and winter, we were obliged to start our work the first of May, a month earlier than ever before. With so many winter residents in Old Orchard, there should be a dump provided near the town, where they can dispose of the waste after the teams are taken off. It has become a necessity now in order to preserve the health of the town.

Owing to the increase of visitors at Ocean Park, the man who collects the rubbish there, will need a helper this year, and this will necessarily increase the expenses of the Sanitary Department.

The approach to the dump at Ocean Park will have to be filled in with gravel this year and this is also an



extra expense to be provided for in the amount set aside for the Sanitary Department.

## CHIEF ENGINEER'S REPORT

---

To the Citizens and Tax Payers of Old Orchard:

The Department has responded to 23 calls during the year. A majority of them were grass fires, however, and in most cases no damage resulted, or very little. A very serious fire was fought on the W. L. White property, July 2. Help was called from Portland, Biddeford and Saco, and with their efficient aid the conflagration, which threatened to sweep the business section, was held on the property where it originated, except that some sparks set fire to the Payheur building on Imperial street, which caused some damage.

On the evening of October 2 a dwelling house at Pine Park was totally destroyed. While out of the fire district, the company with fire truck was sent to render assistance.

The Titlebaum residence on Imperial street was damaged by fire Nov. 19th as was the Breen cottage on Walnut street, Nov. 24th.

We should have 1,000 feet of new hose this year.

The Fire Alarm system was all rewired with new No. 9 triple plate wire, and work was done according to the fire underwriters' rules.

I would recommend at least two summer firemen for duty under pay.

As you know, our Fire Company is a call company and not always readily accessible when a call is rung in. We should also have more room for apparatus. As the stable needs repairing I would suggest that the building be enlarged at the time of the other work.

## DENTAL EXAMINER'S REPORT

---

To the Superintendent of Schools, Old Orchard, Maine:

I herewith submit my report as Dental Examiner in the public schools for the year ending December 31, 1922:

While I did not find as much improvement in the character of the teeth as I had hoped for, yet I found a decided improvement over last year.

Last year, out of 171 pupils examined, I could report only three with perfect teeth, while this year, I am able to report twenty-six out of 205.

By a comparison of records obtained through the examination of 127 pupils for two consecutive years, the first year's records show a total of 670 cavities, while the records of this year, show a total of 587 cavities, making a difference of 83 cavities.

This does not look much on paper, but when you consider that this period extended only over eight and one-half months, it will show that some parents did heed the examination to a limited extent, particularly if you consider the number there would have been had there not been any care taken at all.

## SCHOOL REPORT

---

To the Citizens of Old Orchard:

The problems of the future, rather than the details of the past year are the matters which your superintendent should outline at this time in the space which is allotted to him. This is his duty, not only to the school children, present and future, but also to the tax-payers who are seeking for the development of a school system on the basis of true economy. The past year has been one of intensification of work, rather than the development of new educational projects and the progress has been most satisfactory in matters of curriculum and of extra-curricular activity. With this assurance, supplemented by examples in the remainder of the report, we can well turn our attention to the future.

### Old Orchard Is Progressive.

Old Orchard is a most progressive town. Its citizens may well point with pride to the many improvements which have been made in the past few years. The unusual number of cement sidewalks, the improvement of the fire department through modernized fire fighting apparatus and increased water pressure, the successful advertising of the natural advantages of the town as a summer resort, the efforts to remedy the dust nuisance by oiling the streets, the oiling of the marshes, the up-to-date health station, the first class lighting system, the cleaning of the beach during the summer, and perhaps most of all, the proposed installation of septic sewage tanks, recommended by experts, and to be installed at a considerable cost,—all of these are evidence of the progressive spirit of the town. Old Orchard has bene-



fitted from these improvements. In the short period of nine years, the valuation of the town has considerably more than doubled.

### Her Schools Are Progressive.

Old Orchard has also been progressive and fortunate in the development of its school system. It is fortunate in having a consolidated system which lends itself to economy and efficiency. School officials, all over the country are endeavoring by every possible means to bring about conditions which we already enjoy. Through the wisdom of former town officials, thoughtfully supported by the citizens of the town, the vexing problems of consolidation and transportation have been solved for us.

Furthermore, we have the most approved school organization,—with the Junior-Senior High School plan, and able teachers. Larger educational systems have endeavored, even during the past year, to employ our teachers, but, thanks to the fact that the town has voted sufficient money to maintain this excellent corps of teachers and to supply them with all the material they can use in our present school buildings, efforts to "raid" our force have been unsuccessful. Continuation of service, professional spirit, and cooperation marks our teaching staff through the entire twelve grades. It is significant that teachers of our lower grades are now working on some projects which are primarily for the benefit of the higher grades.

For all of this, we may well be truly thankful. We may well consider with gratitude the good judgment of past officials and the splendid spirit of present teachers. But a chain is no stronger than its weakest link, and the very weak link which endangers our present and future system is the entirely inadequate school buildings.

The developments of the past year, while produc-

ing no tangible results, were, nevertheless, indicative of progress. The problem was carefully studied by the committee of twelve citizens, to whom the town owes its gratitude. The best types of school plans were submitted by an expert in school architecture. Dr. Payson Smith, commissioner of education for Massachusetts, a man whose opinion is respected throughout the country, studied the situation and saw not only the need but also the advisability of the proposed plans. Josiah W. Taylor, state agent for secondary education most heartily recommended our project. Even the fact that the project was finally defeated should not blind us to the thoughtful attention which was given to the needs and to the desire for the best which was in evidence.

### We Need a New Building.

The need still exists and is still increasing. The registration for the fall term of 1922 showed an increase of nearly seven per cent over the registration for the fall term of 1921. In the ten years since 1912, the school census has shown an increase of over 36 per cent.

If we do not provide adequate school houses for these children, we lay ourselves open to several dangers. First, a distinct loss will come to the town when native boys and girls go away to secure the elementary and high school education necessary for successful preparation for life. They will thereby become, to a certain extent alienated from their home town, and because they, in later years, will feel that it did not do its duty by them, they will be "knockers" rather than "boosters". Again if we do not begin a progressive plan of improvement of our school plant, we may eventually be compelled to resort to teachers of lower ability. Our teachers will be glad to put their shoulder to the wheel and help matters along, but nothing discourages like stagnation.

Perhaps most important to the tax-payer is the fact



that we are inviting ever increasing financial leaks by continuing with our present plant. During the next year, for instance, we must provide a room for proper storage of school property, used in various places, because of the congestion, during part of the year and demanding attention during the remainder of the year. While town officials deserve our thanks for allowing the use of the court room and town hall, the use of these places brings additional financial burdens. During the next year, also, we must provide a new furnace and improvement of the sanitary conditions at the high school. On account of the inadequacy and deterioration of the present heating plant we are unduly wasting the energy and patience of our good-natured janitor and consuming an unnecessary amount of coal. While a program for permanent improvement is being developed, even if it were to be started today, we will have to continue our expensive patching processes.

Thus under present conditions we are wasting money, fuel, and, most important, the energy of teachers and pupils who are working under poor conditions.

#### True Economy.

True economy is our watch-word. It is becoming more and more necessary. For several years, owing to the saving possible through our consolidated system and the plan of state grants, we received almost enough money from the state to run our schools. This year, owing to the new apportionment of the state school mill fund and the common school mill fund, the town received \$2,178.66 less from those funds than it did in 1921.

We must make a start. If it is still necessary, let us again reopen the question and employ the best experts that can be found to assist in determining the best location, type of building, etc., to meet present and future

needs. Let the town, if it seems desirable, begin to set aside a regular sinking fund to accumulate while we are discovering what is best. The new building is necessary for the present physical plant cannot be thought of as the foundation for future building. Let us do something speedily toward laying the foundation for a school system which will be enduring.

We have, in Old Orchard, an efficient school board, to which I wish at this time to express my sincere appreciation of the splendid and thoughtful way in which they have attacked school problems during the past year. We have a splendid staff of teachers, to whom our successes have been largely due. We need a still stronger community interest and understanding of the educational work of the town. That is the foundation on which any successful work must rest and with it, we will solve our present plant problem without delay. Then we will replace the weakest link in Old Orchard's chain of progressiveness by a school plant which will be a monument to the wisdom of the present generation.

To the Superintendent of Schools:

School opened September 11 with the largest registration we have ever had. Our attendance this year has been the best since our organization as a Junior-Senior High School six years ago. We have the same corp of teachers as last year with one exception. Mrs. Dolly was engaged to teach Music. Under her very efficient direction we are obtaining excellent results.

Our dental and medical inspections were carried out this year the same as last. In addition this year we had the assistance of our district nurse, Miss Dunn.

The Oceanic this year will be just as good as in years past if not a little better. This will be ready about March first. Our athletics this year are not occupying quite as prominent a place in our school life as in the past few years. We had no track team last fall and have no boys' basketball team this winter, due to lack of material for such teams. The girls, however, have an excellent team this year and under the very able coaching of Miss Hughes are certain to be a credit to the school and town.

A few new books have been added to our library this year. We have also availed ourselves of the opportunity of using one of the state traveling libraries.

I wish to bring to your attention the fact that your teachers are all doing their very best under the conditions which they have to work. Until the people of Old Orchard interest themselves in the schools and become acquainted with the existing conditions, until they compare these conditions with more modern and up-to-date conditions they must not expect further advancement. Your teachers have all done their very best to make Old Orchard schools second to none. They have done their



part. Further advancement is dependant upon the citizens and upon them alone.

We as teachers appreciate the hearty cooperation and support which you and the Superintending School Committee have always given us. We sincerely thank you for this loyal support.

## WARRANT

---

To Elmer E. Googins, Constable of the Town of Old Orchard, in the County of York:

Greeting:—

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of Old Orchard, qualified to vote in town affairs, to assemble at the Town Hall in said town, on Monday, the 5th day of March, A. D. 1923, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

1st. To choose a moderator to preside at said meeting.

2nd. To choose all necessary town officers for the ensuing year.

3rd. To hear and act upon the reports of the town officers and all special and standing committees.

4th. To see what action the town will take in relation to pay of town officers.

5th. To see what sums of money the town will raise: 1st, for common schools; 2nd, for free high school; 3rd, for free text books; 4th, for making and repairing highways and bridges; 5th, for the support of poor; 6th, for the pay of town officers; 7th, maintaining street lights; 8th, for contingent expenses; 9th, for sanitary expenses; 10th, for town interest; 11th, for repairing school houses;

12th, for the public library; 13th, for heating, lighting and care of town property; 14th, for moth nests; 15th, State road patrol; 16th, public toilet; 17th, school supplies; 18th, for transportation of high school scholars; 19th, for advertising; 20th, for payment of serial bonds.

6th. To see what sum of money the town will vote to raise to pay collector's commission and abatements.

7th. To see what compensation the town will vote to pay the collector for collecting taxes for all moneys actually collected.

8th. To see if the town will vote when the taxes shall be committed to the collector for collection and what rate of interest, if any, will be charged thereon, thereafter.

9th. To see if the town will authorize the Selectmen and Treasurer to hire money in anticipation of taxes.

10th. To see if the town will authorize the Selectmen and Treasurer to issue town notes to pay those, if any, which fall due the present year.

11th. To see if the town will authorize the Assessors to make such abatements as they think reasonable.

12th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct and maintain sewers and drains; to maintain fire department; to maintain town team; for hydrant rental; for interest on debt incurred in fire department, sewers and loans, all within the limits set out in Section IV, of the act of incorporation of the town of Old Or-



chard, to be a separate tax, to be assessed and collected as provided in said act.

13th. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State aid as provided in Section 20 of Chapter 130 of the Public Laws of 1913.

14th. To see if the town will raise and appropriate the sum of \$1,196.00 for the improvement of the section of State Aid Road as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the above amount being the maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 130 of the Public Laws of 1913, or such other sum as is deemed necessary.

15th. To see if the town will vote to set apart the sum of \$1,000.00 from the regular appropriations for sidewalks and highways, for the purpose of maintaining and constructing highways and sidewalks in that part of Old Orchard known as Ocean Park, to be used by and under the direction of the Ocean Park local committee, Road Commissioner or Selectmen.

16th. To see if the town will vote to appropriate a sum of money sufficient to pay for the services of a school physician as required by Chapter 73, of the Public Laws of 1909.

17th. To see what sum the town will vote to appropriate for the purpose of cleaning beach during the summer season.

18th. To see if the town will vote to provide extra lighting on the sea wall during the summer months, and how much it will appropriate therefor.

19th. To see what action the town will take in regard to extra lighting of streets during the summer months and how much it will appropriate therefor.

20th. To see what streets or parts of streets the town will vote to lay dust during the summer months, the cost thereof to be assessed against the property thereon as now provided by law.

21st. To see what action the town will take and what sum of money, if any, the town will raise to maintain a winter patrolman.

22nd. To see what action the town will take in regard to lighting sign, now located at foot of Old Orchard Street, and what sum of money they will raise therefor.

23d. To see if the town will vote to grade and gravel Odena Avenue from W. Grand Avenue to South Avenue, South Avenue from Odena Avenue to Sea Cliff Avenue, and Sea Cliff Avenue from South Avenue to land of Boston & Maine R. R., and how much it will appropriate therefore.

24th. To see if the town will vote to maintain a permanent fireman at the Town Hall for the purpose of driving the fire truck when required and doing other work about the building and grounds, and what sum of money they will appropriate therefor.

25th. To see if the town will vote to raise the sum of \$200, or such sum as is deemed necessary to purchas :



oil and apply the same for the extermination of mosquitoes.

26th. To see if the town will vote to instruct the Selectmen to appoint a building inspector for the ensuing year and determine his compensation.

27th. To see if the town will vote to instruct the Selectmen in regard to permitting peddling on the Beach, or the taking of pictures thereon by transient photographers.

28th. To see what action the town will take in regard to permitting automobiles, motorcycles, aeroplanes and other fast moving vehicles on the Beach during the so-called Beach season.

29th. To see if the town will authorize the Selectmen and the Chief of Police to employ two or more special officers to act as life-savers along beach during July and August and what sum they will appropriate therefor.

30th. To see if the town will vote to grade and gravel Tioga Avenue from Grand Avenue to Surf Street, and what sum of money they will appropriate therefor.

31st. To see if the town will vote to pay J. H. Goodkowsky the sum of \$49.50, being part of amount paid by him for constructing a cement sidewalk on easterly side of Cleaves Street.

32d. To see if the town will vote to extend Maplewood Avenue sewer a distance of about 150 feet northerly toward Sixteenth Street, and what sum of money they will appropriate therefor.

33d. To see if the town will vote to construct a sewer on Park Avenue and what sum of money they will appropriate therefor, or under what arrangement or condition said sewer shall be constructed.

34th. To see if the town will vote to grade and gravel Grove Avenue and what sum of money they will appropriate therefor.

35th. To see if the town will vote to accept Eleventh Street as laid out by the Selectmen.

36th. To see if the town will vote to accept Wesley Avenue as laid out by the Selectmen.

37th. To see if the town will vote to accept Maplewood Avenue as laid out by the Selectmen.

38th. To see if the town will vote to establish a yearly light near residence of Katherine Daley in place of a summer light; to change lights on East Grand Avenue from three months to four months, and to include therein lights at Grand Beach; to establish yearly lights on Circuit Avenue near residence of Mrs. Brown in place of a four-month light; to establish yearly light on Cliff Avenue in place of four-month light; to establish yearly light at corner of Tunis Avenue and Seaside Avenue, also yearly light at corner of Hillcrest Avenue and Central Avenue; to establish a three months light at junction of Eden Lane and Pine Lane; to establish a yearly light at corner of Fountain Avenue and Third Street, and change a summer light now located on 15th street to a yearly light, and what sum of money they will appropriate for said lights.

39th. To see if the town will vote to accept First Street as laid out by the Selectmen.



40th. To see if the town will vote to accept Pine Lane as laid out by the Selectmen.

41st. To see if the town will vote to grade and gravel Pine Lane and what sum of money they will appropriate therefor.

42. To see if the town will vote to accept Casco Avenue as laid out by the Selectmen.

43d. To see if the town will vote to name a private way as shown on Plan No. 2 of Mrs. M. H. Kinney, now unnamed, Graham Road or Lane.

45th. To see if the town will vote to extend the cement sidewalk on the northerly side of Francis Street easterly about 300 feet and what sum of money they will appropriate therefor.

45th. To see if the town will vote to construct a line of sewer on Francis Street from Imperial Street to new line of sewer recently constructed through Seaside Park, and what sum of money they will appropriate therefor or under what conditions said sewer shall be constructed.

46th. To see if the town will vote to reimburse The Maine Investment Co \$600—money paid the town toward construction of sewer through Seaside Park, so-called.

47th. To see if the town will vote to raise the sum of \$300 or such other sum as may be thought reasonable, for the purpose of exterminating the white pine blister

rust, said work to be done in conjunction with State and National government.

48th. To see if the town will vote to grade and gravel Kinney Avenue and what sum of money they will appropriate therefor.

49th. To see if the town will vote to accept a reserved way on a plan of lots of Thomas L. Cleaves, running from East Grand Avenue to the sea, said way to be known as Durocher Avenue, as laid out by the Selectmen.

50th. To see if the town will vote to place two or more firemen on regular duty at the fire station during the summer season, and how much money they will appropriate therefor.

51st. To see if the town will vote to enlarge the fire station and stable and how much money they will appropriate therefor.

52d. To see what action the town will take in regard to Daylight Saving.

53d. To see what action the town will take in regard to pay of Superintendent of Schools.

54th. To see if the town will vote to build a cement sidewalk on the Northerly side of Saco Road from Union Avenue in a Westerly direction about 500 feet, and also extend the cement walk on Easterly side of Portland Avenue 300 feet more or less; also extend the cement walk on the Southerly side of East Grand Avenue at Surfside a distance of 500 feet; also build a cement walk on the Northerly side of Forest Avenue from Union Avenue to



Sea View Avenue, also to build a cement walk on West-  
erly side of School Street from Saco Road Northerly  
about 300 feet, and what sum of money they will appro-  
priate for said walks.

55th. To see if the town will vote to relay the Mil-  
liken Street sewer, also to lay a line of culvert to take the  
place of the open drain on said street, and what sum of  
money they will appropriate for said purposes.

56th. To see if the town will vote to install a Hy-  
drant on Saco Road at or near the residence of H. A. C.  
Milliken, and what sum of money they will appropriate  
therefor.

57th. To see if the town will vote to accept Ode-  
na Avenue, South Avenue and Sea Cliff Avenue, as laid  
out by the Selectmen.

58th. To see if the town will vote to have a plumb-  
ing inspector, and what sum of money will be voted  
therefor.

59th. To see if the town will vote to locate a fire  
alarm box on the easterly side of the railroad tracks on  
Old Orchard Street, and what sum of money they will  
appropriate therefor.

60th. To act upon any other business that may leg-  
ally come before said meeting.
