I Hzekiah Statton, a resident citizen of the United States of America, an inhabitant of Sumner in the County of Oxford and State of Massachusetts, on oath declare that at Pembroke in said State I enlisted into the Army of said United States on the continental establishment for the term of eight months as a private soldier in Capt Freedom Chamberlins Company and joined said Company on the first day of May A.D. 1775 at Roxbury, in Col John Baileys regiment in the Massachusetts Line, which term of eight months I served at said Roxbury, and at the expiration thereof, without leaving the service, having previously enlisted. I entered upon a service of one year as a corporal in Capt Wm Reeds company in the regiment and line aforesaid, which term of one year I also fully served in said Reeds company. From January A.D. 1776 to April following I served at said Roxbury, thence to New York and continued in the State of New York until the 2^d of December, when we marched into New Jersey where I spent most of the remainder of my time, tho' I was in the State of Pennsylvania. At the expiration of said year being at Trenton, I was solicited to continue, and did continue in said service six weeks longer, when I was verbally discharged. I further testify that I am sixty five years of age; am not borne on any pension list of the United States and by reason of my reduced circumstances in life I stand in need of assistance from my country for support. therefore I pray that this declaration may be transmitted to the Secretary of war to the end that I may be placed on the pension list of the United States agreeably to the

the provisions of an Act of Congress passed March 18. 1818 entitled "An Act to provide for certain persons engaged in the land & naval service of the United States in the Revolutionary war" I was in the battles of Trenton & Princeton, at the taking of Burgoyne, & in several small skirmishes.

Hezekiah Stetson

I Elisha Bissie of Sumner aforesaid on oath declare that I was in the continental service in the revolutionary war during the whole time that the above named Hezekiah Stetson served. We both went from the same town and served in the same Regiment the term of eight months first aforesaid, and in the same company during the periods of one year and six weeks aforesaid, excepting a short time that I was detached from the Company. We were informants most of the time & to my certain knowledge said Stetson served as a brave and active Soldier during the terms & in the manner he has stated in the above declaration by him subscribed.

I James Keen of Sumner in the County aforesaid on oath declare, that I was in the continental service in the Revolutionary war and served in the same company with the above named Hezekiah Stetson during his term of eight months and during eleven months of his years service above mentioned, which terms said Stetson served to my certain knowledge as he has stated

On this 14th day of August aforesaid personally appeared in open Court before said District Judge Hezekiah Stetson a resident of Sumner in the County of Oxford in said Maine District, aged seventy nine years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the act of Congress passed June 7th 1832. That he the said Hezekiah Stetson enlisted at Pembroke in the County of Plymouth State of Massachusetts into the service of the United States sometime in the spring of 1775 and served eight months in the Company commanded by Capt Freedom Chamberlin in the Regiment commanded by Col John Bailey and was stationed at Roxbury during said eight months. That he the said Stetson again enlisted on the first of January 1776 and served one year in the Company commanded by Capt William Reed in the Regiment commanded by Col Bailey aforesaid and was stationed the most of said year near the City of New York, and was dismissed in the State of New Jersey at the expiration of said year. That he the said Stetson again enlisted sometime on the 1st of Jan'y 1777 and served six weeks in the Company commanded by Captain Reed in Col Bailey's Regiment aforesaid and served said time in the State of New Jersey

That he the said Stetson again enlisted sometime in the fall of 1777 and served three months in the Northern Army and was at the taking of Burgoyne in the company commanded by Capt Bradley in the Regiment commanded by Col Gill, that he has no positive proof of this service - that he has been on the pension list under the Act of March 1818 that he was dropped from the same on account of property - that he served as a Corporal in the years service - that he has resided in Sumner aforesaid for about fifty years. He hereby relinquishes every claim whatever to a pension or an annuity, except the present, and he declares that his name is not on any pension Roll of any agency in any State, or (if any) only on that of the agency in the State of Maine

The undersigned Hezekiah Stetson of Sumner in the County of Oxford & State of Maine, respectfully states in reply to the letter of Benjamin L. Bull, dated, War Department, Pension office, Sept. 15. 1832, that the cause of not mentioning the time of service for three months in the fall of 1777, in his declaration for a pension under the act of 18 March 1818 which he has stated in his present declaration, under the act of June 7th 1832 he supposed to have been, that then it would have been of no avail; whereas in the present declaration, it is important, as it makes up a part of the period required by the law - 2 years for a full pension.

But the said Stetson says that it is, at this time impossible for him to prove by witnesses this service, as there are no surviving witnesses to the service nor has he been able to find any person, who is knowing to the fact. Yet still said Stetson says that he did actually serve said three months, as he has stated in his said last made declaration; and he earnestly requests that the same may be allowed him in the computation of the time, in the allowance of his new pension as now applied for, believing his request to come within the construction of the law, given by your Honour, by the instructions issued from the war office. If however this part of his time cannot be allowed, consistently with the rules of the Office & by the law, said Stetson, requests that the granting of a pension to him for what service he is admitted to have proved, may not be delayed for the purpose of giving him further opportunity to prove this period, not proved, as he has no hopes, at this late day of being able ever to

to procure the testimony necessary to support the claim -
