I, Mary Stevens, of Norway, in the county of Oxford, and State of Maine aged eighty seven years, do, upon oath, declare, in order to obtain the benefit of a Resolve of the Legislature of Maine, passed March 17, 1835, entitled a "Resolve in favor of certain Officers and Soldiers of the Revolutionary War, and the Widows of the deceased Officers and Soldiers," that I am the widow of Jonas Stevens, late of said Norway, who died at said Norway, on the month - day of February A.D. 1833. That I have reason to believe, and do fully believe, that my said late husband, Jonas Stevens, did enlist into the service of the United States, and served as a sergeant, in the company commanded by Capt. Paul Ellis, in the regiment commanded by Col. Timothy Bigelow, in the Massachusetts line - He first enlisted as a private, and was placed on the Pension Roll of the United States, by a certificate, dated January 22d. 1818 and numbered 5604, which certificate was cancelled at the War Department, and another certificate issued from the Department, increasing his monthly pay as a sergeant - Which last certificate was granted under the Act of Congress of June 7th. 1832. & was given <sup>up</sup> to the Agent of the United States, for paying pensions, in Portland on payment of the last semiannual payment - My husband had a written discharge, but it has been lost for many years before he removed from Gray - to Norway - he served three years and eight months - I do further on oath declare, that I have reason to believe, and do fully believe, that my said late husband, Jonas Stevens, was at the time of his said enlistment, an inhabitant of Gray in the State of Maine, then Massachusetts, and that I do know that he was at the time of his decease as aforesaid, an inhabitant of the State of Maine, residing in Norway aforesaid, where he had resided for 40 years before his decease. That I have reason to believe, and do fully believe, that neither my said late husband, nor any one claiming under him did receive, nor have I received since his decease, a grant of Land, or money in lieu thereof, from the Commonwealth of Massachusetts, for his said service, or any other service during the Revolutionary War; and that I am therefore justly entitled to the benefit of said Resolve.
