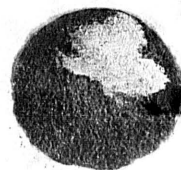

Caleb Lord.

I, Joanna Storer formerly the wife of Joseph Storer, late of Falmouth now Westbrook, in the county of Cumberland and State of Maine, deceased; and now an inhabitant of Portland in said county, aged ninety eight years, do upon oath declare, in order to obtain the benefit of a Resolve of the Legislature of Maine passed March 17, 1835, entitled a "Resolve in favor of certain Officers and soldiers of the Revolutionary war, and the widows of the deceased Officers & soldiers, that I am the widow of Joseph Storer abovenamed, who died of the small pox at Fiskhill in the State of New York in October 1777, about the time of the capture of Burgoyne, That I have reason to believe that my said husband did enlist in the revolutionary army, and Massachusetts line in the latter part of the year 1776, as a private, in the company commanded by Captain Nicholas Blauvelt in Colonel Wigglesworth's regiment for the term of three years, and that he performed his service until his decease in October 1777.

I do further on oath declare that I do believe that my said late husband Joseph Storer was at the time of his enlistment an inhabitant of said Falmouth, now Westbrook, in the State of Maine, and that I do know that he was at the time of his enlistment as aforesaid an inhabitant of said State, residing in said Falmouth where he had resided for many years, that I do know, that I have not since his decease, received a grant of land, or money in lieu thereof from the Commonwealth of Massachusetts for his said service, or any other service during the revolutionary war, and that I am therefore justly entitled to the full benefit of said Resolve.

I Stephen Riggs of Westbrook in the county of Cumberland and State of Maine aged seventy five years, on oath declare, that I am well acquainted with Mrs. Joanna Storer, now resident in Portland and formerly of that Part of Falmouth, now called Westbrook, in the said County, who has made application to the land Agent of the State of Maine for a grant of two hundred acres of land, as the widow of Joseph Storer a revolutionary ^{late} soldier of said Falmouth deceased, under the Resolve of the Legislature passed March 17, 1835, and have known her for more than sixty years last past, as the wife of the said Joseph Storer during his life time, and as his widow since his decease, which I understood took place in the autumn of 1777, and that I remember of his enlistment in the revolutionary ^{army} for three years in the latter part of the year 1776; and have been acquainted with their children; and have always understood, and have never heard it doubted or questioned by any one, but that the said Joanna was the lawful and faithful wife of the said Joseph Storer; and that she is now as his widow, justly entitled to the benefit of the Resolve aforesaid.

And my said Attorney is hereby authorized and empowered upon the receipt of said certificate, for me in my name, to execute such receipt or acknowledgment therefor, as I might, were I personally present.
