I *Happy Thompson* of *Bangor* in the County of *Penobscot* and State of Maine, aged *seventy six* years, do, upon oath, declare, in order to obtain the benefit of a Resolve of the Legislature of Maine, passed March 17, 1835, entitled a "Resolve in favor of certain Officers and Soldiers of the Revolutionary War, and the Widows of the deceased Officers and Soldiers," that I am the widow of *Joseph Thompson* late of *Lewiston* in the County of *Lincoln* and State of Maine, who died at *Lewiston* on the *twenty sixth* day of *May* A. D. *1827*. That I have reason to believe, and do fully believe, that my said late husband, *Joseph Thompson* did enlist as a soldier in the Revolutionary Army and actually served the full term of three years in said army that he enlisted as a private in the year 1777 for three years into Capt *Maybury's* Company & Col *Tupper's* Regiment of the Mass. Line & was discharged at West point in the year 1780. he received an honorable discharge and was a United States pensioner at the time of his decease.

I do further on oath declare that I have reason to believe, and do fully believe, that my said late husband, *Joseph Thompson* was at the time of his said enlistment, an inhabitant of *Falmouth in the State of Maine* and that I do know that he was at the time of his decease as aforesaid, an inhabitant of the said State of Maine, residing in *Lewiston* aforesaid, where he had resided for *forty three* years before his decease. That I have reason to believe, and do fully believe, that neither my said late husband, nor any one claiming under him did receive, (nor have I received since his decease,) a grant of Land, or money in lieu thereof, from the Commonwealth of Massachusetts, for his said service, or any other service during the Revolutionary War, and that I am therefore justly entitled to the full benefit of said Resolve.

I Joseph Thompson aged sixty three years, a citizen of the United States, born in Falmouth in the District of Maine but now resident in Lewistown in the said District, upon oath testify and declare, that on the twentieth day of December A D 1776, I enlisted as private soldier, in the war of the revolution, against the common enemy, upon the continental establishment, for the period of three years, in Capt. Mabury's company and Col. Francis's Regiment, afterwards Col. Tappan's regiment, of the Massachusetts line. This period I fully served out and took my final and honorable discharge from the army at West point in December 1779. My discharge is lost or mislaid and is not to my knowledge in existence. I was at the battle of Hubbardton, both the battles at the taking Burgoyne, and at the battle of Monmouth. I wintered one winter at Valley Forge. From my reduced circumstances, I am in need of assistance from my country for support. And I do hereby relinquish all my claim to every pension heretofore allowed me by the laws of the United States, if any; but I am not to my knowledge borne on any pension list whatever. I request that I may be placed upon the Pension list of the District of Maine.

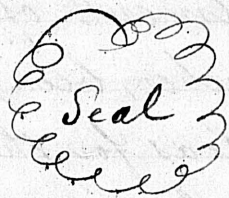

I the subscriber, being Chief Justice of the Circuit Court of Common Pleas for the second Eastern Circuit of Massachusetts, embracing the Counties of Lincoln Hennebise & Somerset, do hereby certify to your honor, that Joseph Thompson, a citizen of the United States now resident in Lewiston, in the said County of Lincoln, in the District of Maine, on the fourteenth ^{day} of April A.D 1818, made application to me to receive his declaration under oath, and such other evidence, as was in his power to produce; and to transmit the same, and the proceedings had thereon, to your honor; that he might be placed on the Pension list of the United States, agreeably to the provisions of an Act, entitled "an Act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed March

March 18. A.D. 1818, which declaration, and the other evidence produced by the said applicant, is herewith annexed. And I do further certify to your honor, that after a full examination of the said applicant, and a careful consideration of the evidence in the case, it appears to me that the said applicant did serve as a private soldier, in the war of the revolution, against the common enemy, upon the continental establishment for more than nine months, as stated in his declaration aforesaid, and that from his reduced circumstances, he needs the assistance of his country for support.
